## 18. Public Participation

Pam Tharp asked about the College Corner Union School day proposal. It was explained that a proposal to change the beginning and end times of the College Corner Union School day beginning with the 2015-2016 school year in order to eliminate the loss of instructional time and bus waiters had been developed and considered but abandoned because there would be too much potential for a negative impact on parents and students.

## 19. Superintendent's Comments

*Dr. Rozelle reported on how teachers utilize mCLASS data to adjust instruction.
*Dr. Rozelle commented on the March, 2015 cash flow reports. He noted that the current calendar year General Fund deficit projection is deceivingly low because we are receiving significantly more money from Ohio this year due to increased open enrollment. General Fund expenditures are projected to be well beyond ten million dollars and need to be below ten million annually.
*Dr. Rozelle reported that the School Board Ohio Apportionment Formula Review Committee met on Monday, March 9, 2015 and that all parties agree that the joint agreement and apportionment calculation continue to serve to the benefit of both entities.
*Dr. Rozelle reported that the School Board Transportation Committee had met and discussed a proposal to change the beginning and end times of the College Comer Union School day beginning with the 2015-2016 school year. The Committee determined the proposal had too much potential for a negative impact on parents and students and subsequently advised against moving ahead with it.
*Dr. Rozelle noted he would be scheduling a meeting of the School Board Technology Committee during the month of April or May.
*Dr. Rozelle reported that the District had received confirmation from the Indiana Department of Education that following a review by Department officials of the district certified personnel evaluation procedures the district's procedures are in compliance with Indiana statute.
*Dr. Rozelle reported that the district had received confirmation following an Indiana Department of Education review of Union County High Scnool safety procedures that the school is in compliance with Indiana statute and Department requirements.
*Dr. Rozelle reported that the high school Patriot Street dranage project is not yet Underway but scheduled to be done. He noted as well that al middle school drainage issue brought up at an earlier meeting had been resolved.
*Dr. Rozelle reminded Board members of the ISBA meeting on May 7 at Willie and Redd's in Hagerstown.
*Dr. Rozelle thanked the School Board Transportation Comnittee for their time spent on the CCUS issue.
