11. Public Participation

Pam Tharpe questioned the number of effective and highly effective teachers.

12. Superintendent's Comments

*Dr. Rozelle informed the Board that weather stripping had been replaced on the exterior doors he had been questioned about during the September 22, 2014 board meeting.

*Dr. Rozelle reported that the final ADM count had been submitted and was 1,397.5 (1,412.5 in February, 2014).

*In response to a question asked by a board member during the September 22, 2014 board meeting Dr. Rozelle distributed to board members a five-year history of assessed value noting that it has on occasion gone down.

*Dr. Rozelle informed the Board that the dimmer rack that controls lighting in the Union County High School auditorium had encountered a "meltdown" over the weekend and that the auditorium lighting is disabled as a result. An investigation into what happened is underway.

*Dr. Rozelle distributed a Whitewater Technical Career Center report that summarized the percentage of eligible students from each participating high school that sends students to the Career Center. Dr. Rozelle noted that Union County High School had the second highest percentage of eligible juniors and seniors participating (29%) among all of the high schools that send students to the Career Center.

*Dr. Rozelle reported that he had contacted attorney Mr. Walt Chidester regarding an agreement that would facilitate proceeding with a repair to the drainage issue on Patriot Boulevard and had been assured he would have a document by the end of the week.

*Dr. Rozelle reported that the District would be installing a paved path from the high school football / soccer facility bleachers to the newly added concession restrooms and that we would be paving the area adjacent to the restrooms. He also reported that we would be installing a walking path that would connect the middle school with Liberty Elementary School to make it possible for students to walk from one location to the other without getting in the street.

*President, Mike Murray reminded the board members that there will not be an executive meeting following the board meeting.

The board meeting was adjourned at 8:20 pm.
