ANNUAL MEETING and Board Elections - September 29 - 5:30 PM

Like many meetings, and public agendas, COVID-19 caused a delay in our own Annual Meeting, usually scheduled for April. Our Annual Meeting will now be held on September 29 - 5:30 PM.

Volunteering to serve on your Credit Union's Board of Directors can be an extremely rewarding experience, allowing you to share your knowledge, and expertise while representing your fellow Credit Union members.

The board of directors of a federal credit union is charged with the general direction, and control of the institution, as well as act on the needs and wants of fellow members, and the community at large. Credit unions receive deposits from the membership and, in turn, lend or invest these funds. The key measure of the credit union's success or failure is its financial statements. A director must understand these financial statements to participate in a meaningful manner in the direction and control of the institution.

Each year the Nominating Committee recommends candidates to fill volunteer vacancies on the Board of Directors. Nominations may be made by petition, containing signatures and account numbers of 90 members. The petition must be submitted to the Credit Union to the attention of Richard Mains, Secretary, by September 1, 2020.

With this in mind, the nominee must have a willingness to serve if elected. Written statements of qualification, and biographical information must accompany the nominee's petition.
