MINUTES FOR THE RIPLEY CO. RETIRED TEACHERS ASSOCIATION APRIL 28, 2015

On April 28, 2015, the Ripley County Retired Teachers Association met for its spring meeting at the Osgood Community Center. Retirees were welcomed by President Andrea Westerfeld.

Officers of the RCRTA were wearing their new RCRTA volunteer shirts. Members are encouraged to order a shirt from Janet's A Stitch in Time in Batesville. Cost is \$27.81. The idea is to wear the shirts while serving in the communities so people will see and value the work of the retired teachers.

Honored Guest: Westerfeld recognized Sherman Lemen for his ninety-ninth birthday by providing a birthday cake and balloons and having the group sing "Happy Birthday."

Lemen recalled that when he had started teaching only a two year license had been required. He eventually got his master's degree to become superintendent at Jac-Cen-Del.

Lemen had just returned from the World War II Honor Flight to Washington, D.C. A newspaper clipping showed two young women kissing him on each cheek. When teased about this, he quipped that he wasn't fast enough to get away. He concluded by reading a poem entitled "Drinking from the Saucer."

Thank You: Westerfeld next introduced Steve and Rita Gookins who served a delicious dinner of chicken marsala with ice cream and birthday cake for dessert. She thanked them for their service to the retired teachers.

President Westerfeld led the retired teachers in the "Pledge Allegiance to the American Flag."

New Attendees: Westerfeld introduced Nancy Durham and Jim Pierce as having returned to fulltime teaching, and welcoming other attendees, Arlene Gutapfel, Martha Kessens, Sharon Martin, Jim Powell, and Carol Volz.

IRTA Executive Director and President: Indiana Retired Teacher Carol Grieser spoke about her connections with Mary McElfresh, Dala Jones, and Janet O'Neill. As a first grade teacher, she had always wanted to teach Indiana history to fourth graders. She mentioned that she had learned of a Ripley, IN, not to be confused with Ripley County, and then she told stories about her mother's excitement over the 1954 Milan basketball team. She read reminiscings by Ripley County retired teachers Miriam Lamkin and Kathryn Turner which had been published in the IRTA Bicentennial publication. Lamkin had recorded that her salary was \$100/month with \$33/month set aside for her retirement. Besides her teaching responsibilities, she also had been the school janitor. She said she had worked a week without pay once when there were no funds to pay the teachers.

Grieser then introduced Tom Mellish who will begin his duties as the new IRTA Executive Director on May 1. Replacing retiring Nancy Tolson, Mellish has been the Principal at Crawfordsville and also the President of the Principal's Association. Grieser described Mellish as "servant-oriented."

Mellish talked about the difficulties of getting a COLA and thirteenth stipend. He thinks that the

thirteenth stipend is assured for at least this year. Mellish noted that 72,000 retired teachers are receiving less than \$650/month. Legislators Sheila Klinter and Jeff Thompson have worked tirelessly on behalf of the retired teachers, but Senator Kenley, Chairman of the Budget Committee, has refused to bring the bill to a vote to give the retirees a COLA. This is because \$850 million dollars of the budget has to go towards paying off the unfunded liability owed to the retired teachers.

Mellish indicated that a voluntary PAC might be needed in the future. He said that retired teachers need to know who is and who is not supportive of the retired teachers. Retired teachers have 23,000 members and have contributed over a million volunteer hours for the last ten years. Mellish commented that it has been seven years without a COLA with a loss of 13%-16% buying power for the. Mellish mentioned retirees the need for lobbyist Steve Bybee to help with legislation.

Mellish thinks that State Superintendent of Public Instruction's Glenda Ritz chairmanship issue of the governor's appointed education committee has been tabled until after Ritz completes her elected term.

Executive Director Mellish said that the Indiana Retired Teachers will be celebrating its sixty-fifth birthday at the Fiftieth Representative Assembly in June.

Mellish reminded retirees that the IRTA Foundation has a new Hands Up program to help teachers with financial needs. This would be a onetime dispersement of funds for teachers in need.

Mellish also reminded the retirees of the \$2000 scholarships available to college juniors or seniors who are majoring in education and have a family member who has worked as an educator. Deadline for the application is May 31. Westerfeld commented that Ripley County had not had a scholarship winner for several years. Anyone with a relative studying education should be encouraged to apply for the scholarship. The IRTA Foundation is also working to provide active teacher grants for classroom projects. A Silent Action will be held at the Representative Assembly June 17 to help fund the Foundation. Carlos Luken, husband of Area 10 Director Lois Luken, has made and donated a wooden floor lamp for the auction on behalf of RCRTA.

IRTA President Carol Grieser then led the group in singing "When Our Members Work Together" sung to the tune of "When the Saints Go Marching In." She commented that we were all like the Three Musketeers, "All for one and one for all." Three Musketeers candy was distributed to each member at the conclusion of the meeting.

Old Business: Minutes of the September 30, 2014 minutes have been presented in the newsletter "The Clipboard." They were approved as presented.

Newly-elected Treasurer Marcia Bultman reported a balance of \$1412.44. Fifty dollars has been donated to the retirement of Nancy Tolson. Fifty dollars has been donated for the school nurses. Seven members have renewed their memberships and one associate member had been added. Dues for the new year will be due at the September 29th meeting. Dennis Westerfeld made a motion, seconded by Lois Luken, to accept the report as given.

Community Service Report: Jean Deamron, Committee Chair, had reported 18,345 volunteer hours for Ripley County. Outstanding local volunteers will be honored at the June 17 Representative Assembly.

Volunteers are needed to help cut, sew, or decorate with the Dearborn County Retired Teachers' pillowcase dress project. The group meets each Thursday 10:00-2:00 at the Dearborn Community Center in Lawrenceburg. One does need to bring a lunch. Dennis Bourquein made a motion, seconded by Larry Sutherlin, that Ripley County donate up to \$300 to purchase flip flops to accompany the pillowcase dresses and shorts sent to Haiti, Africa, and Brazil. The motion carried. Kara Huff, Jac-Cen-Del school nurse, had sent a thank you note in appreciation of the \$50 given to the school nurses.

President Westerfeld noted that the vision screening done in conjunction with the Lions' Club needed more volunteers. Training will be held at a later date.

A jar was sent around to collect funds for the RCRTA food pantries.

Group Outing: Area 10 Director Lois Luken passed around a sign-up sheet for members to see "Church Basement Ladies' Last Pot Luck Supper" at La Comedia on July 28. Money needs to be turned in to Luken by July 28.

Legislative Committee Report: Chair Larry Sutherlin spoke of the need to contact legislators. He said that retired teachers have power in their organization. President Westerfeld said to always be polite and to thank the legislators for their work on behalf of the retired teachers.

Members Concerns: Nancy Cory has been hospitalized with COPD. Nancy Lever has had trouble walking. Ann Schmidt reports it is difficult for her to be in a group. Sarah Jane Wilson's chemo and radiation treatments have been completed. Patsy Holdsworth thanked the retired teachers for their cards and prayers during her recent heart surgery.

Necrology: Recent passings have included Bob Brokamp; Richard Chaffee; Abell Hooten; Don Myers; Linda Oelker; Sara Hughes' mother Anna Lois Richie, and Bill Schein. A short obituary, followed by comments from the audience, and a bell was rung in memorandum for each of the deceased.

Louella Voegele has been a dedicated volunteer for many years. Each Tuesday she volunteers at the Margaret Mary Hospital. Her duties consist of sorting and delivering mail to all departments of the hospital.

The church she attends has an Adoration Chapel which has volunteers continuously praying each hour of the day. Lou participates every Wednesday for an hour.

She works with the youth at a Reality Check program for eighth graders at six different schools. The students choose a career, learn ways to budget their money, and save for needs and wants, as well as saving for their retirement.

The Batesville Historical Society has a rummage sale and has made \$15,267.63 over a period of six years. Lou and other members set up the room, arrange the donated items, clean and repair some items to be sold, arrange

for larger items to be picked up. She also works during the two-day sale. The money from the rummage sale is used to maintain the Historical Society's house.

The Historical Society also sponsors a luncheon in December. Her contribution is attending four committee meetings, collecting silent auction gifts, selling tickets, and decorating the dining room for 140 people.

The Knights of St. John's ladies sponsor a "Sweetheart Breakfast." Lou does the shopping for the breakfast items and collects the donated items from the various businesses. She also helps prepare and serve the food the day of the breakfast.

In addition to the breakfast for the Knights, she prepares and serves food to the golfers who participate in the Knights' Jerry Becker Men's Golf tournament in the spring.

Lou participates in the ecumenical choir which has 15 rehearsals and two performances.

Each July, she continuously works for Relay for Life by working the day of the relay and once again collecting silent auction gifts. She attends many committee meetings throughout the months in preparation for this event. She is the chairperson for all corporate sponsors.

In October and November, she and her sorority sisters prepare for a Holiday Bazaar. She contacts all craft vendors, sells raffle tickets at three business places, and works the full day at the bazaar.

She supports "Think Pink" (breast cancer support group) by participating in the sponsorship of the big event. Her contributions consists of making numerous Christmas decorations during four committee meetings; collecting door prizes, and preparing food and collecting money for tickets sold at the door. She attends two support meetings per month for this organization.

She serves as a mentor to several cancer patients at the Hansen Center two times a week and visits them during their treatments. She also visits patients at St. Andrew's Health Campus two times a week. In addition to the visits, she remembers patients with prayer cards and a blessed medal to wear.

The Ripley County Retired Teachers Association believes Louella Voegele is an outstanding volunteer. (1060 hours).

Donna Harrelson contributed 994 volunteer hours. Donna works with first grade students for reading and other projects. She helps first grade teachers with tasks they need done. She also visits a local health care facility, visits with the residents and helps them with a craft or crocheting projects.

She volunteers for our state IRTA, Ripley and Dearborn Counties locals, the Dearborn County Retired Teachers Foundation, her church, the Council for Educational Travel USA (foreign exchange students), and the Think Smart/Stay Safe program which stresses ways to stay safe from danger to fourth and fifth grades students.

Patsy Holdsworth volunteered a total of 866 hours. Patsy spends numerous hours for her church, Tri Kappa, and Versailles Lions Club. She also spends many hours playing the piano for various school and community activities.
