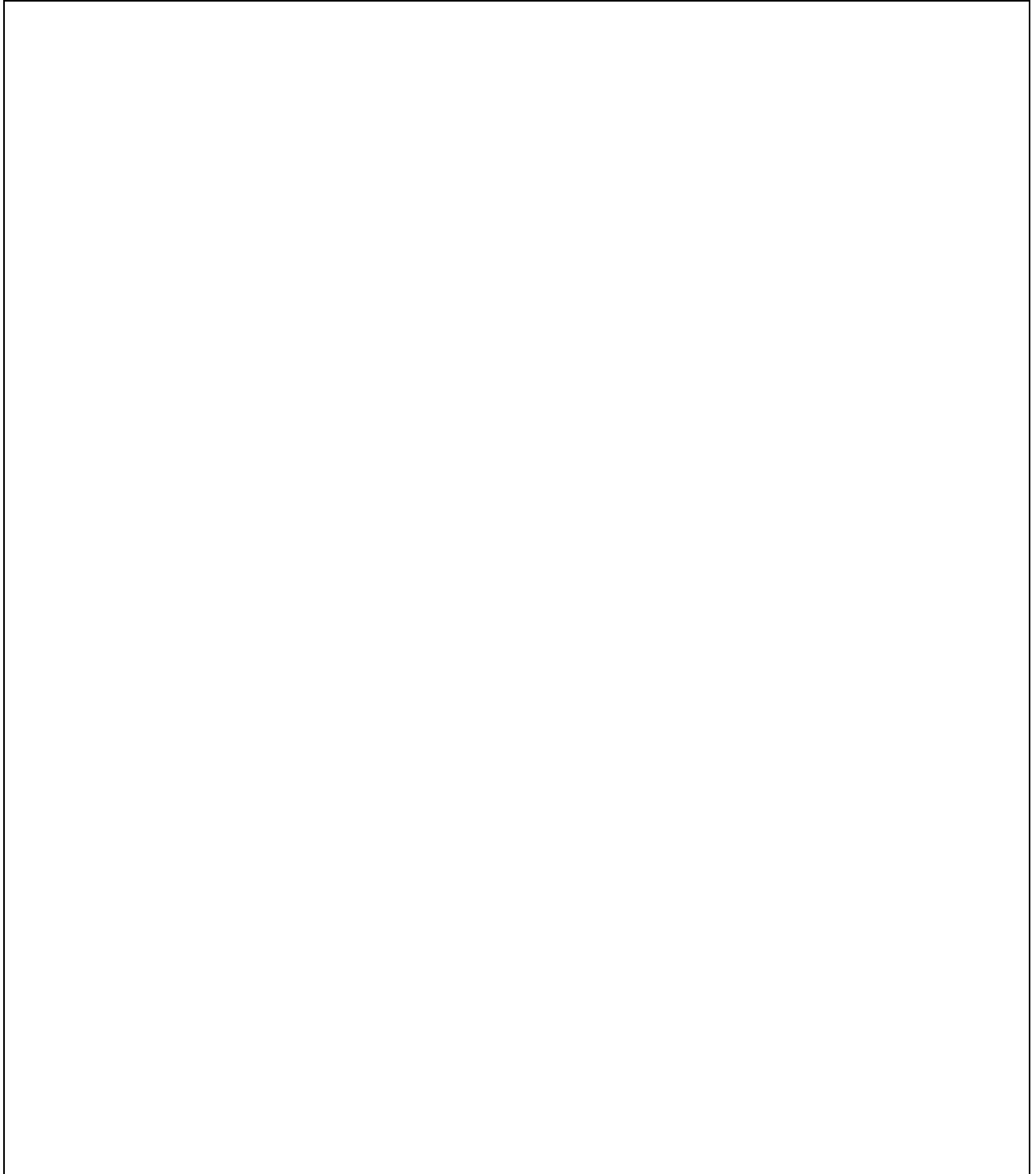

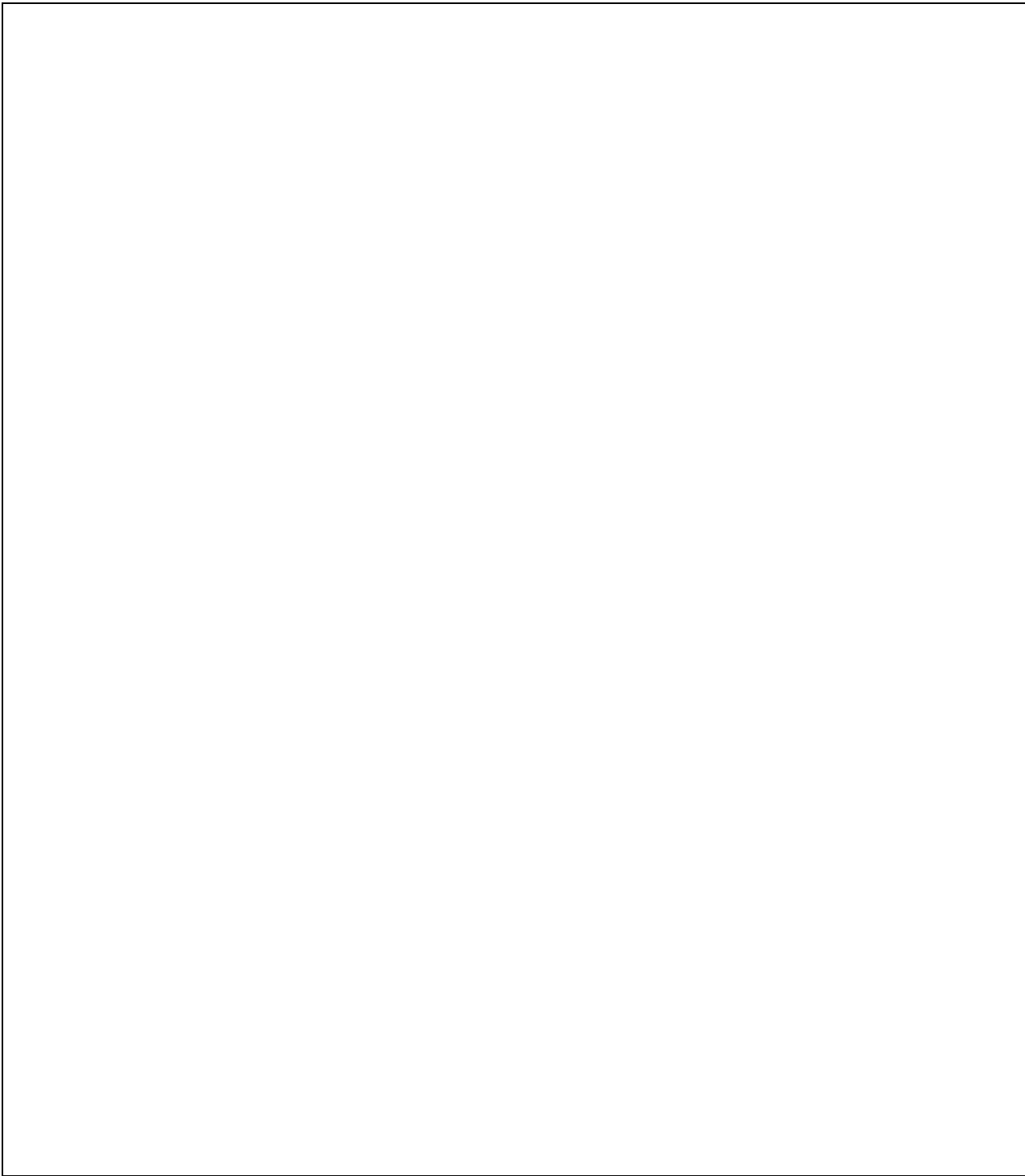
Item 1 Cover Page


Item 2 Material Changes
