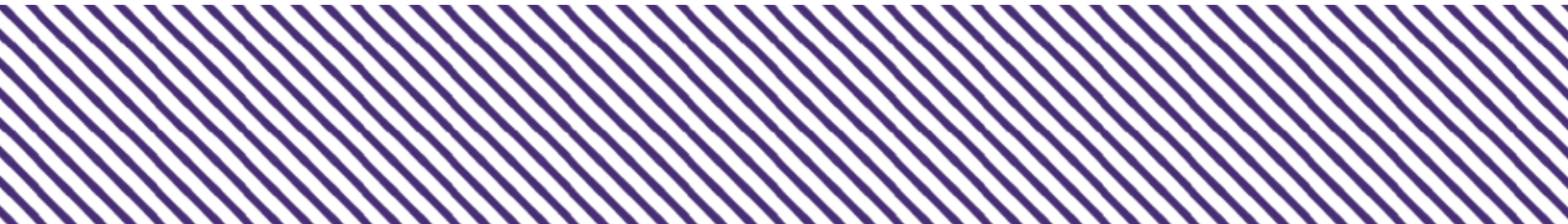


LANDON BAHL
