After the Assembly Health Committee arrived at an amendment to the massage licensing bill that made everyone comfortable, the full Assembly voted to pass AB588, as amended, on Thursday, February 25, 2010. Both votes were unanimous, indicating a very welcome bipartisan effort in these contentious times. In mid March AB588/SB388 went before the Senate Health Committee and will hopefully pass out of committee to the full Senate for a vote. The final step will be to go to the Governor's desk for his signature, all of which needs to happen yet this Spring or the bill will die. President's Report


Ahh Spring!

Ethical Dimensions

Q. I recently graduated from massage school and I am looking forward to establishing my own practice. Is it important to establish policies in my practice, and what type of client files do I need?

This is a great question. The answer to the first

part of this question is answered with a big <u>YES!!</u> Practice policies are one of the surest ways to establish clarity between you and your client. A policy statement is a useful vehicle for creating boundaries that foster trust, safety, and comfort. Policies clearly define the

expectations for both client and practi-

tioner. Policies often can circumvent potentially awkward situations, provide means for conflict resolution and demonstrate professionalism. Ultimately policies offer the practitioner a way to manage one's practice that holds clear intention for both client and massage therapist. I often offer the following illustration; what would happen if parents did not offer rules, guidelines, or boundaries within the family unit? The house-hold would probably feel chaotic, lots of misunderstandings, conflict, and ... now you know the rest of the story! Establishing practice policies must be a high priority item.

One of the first questions you can ask yourself is; what areas of the client / therapist relationship are important to you? It is also important to understand the laws of the land. The following are suggested areas your policies may be frame-worked around:

Cancellation & no-shows.

Fee structure.

Issues around sexual boundaries (dating, etc.)

Limits around confidentiality.

Grievance process.

Office etiquette (perfumes, cell phones, influence of alcohol or drugs, etc.)

Working with minors.

Dual-role relationships.

Illness (both client & therapist)

Time parameters for session.

Client records.

Draping.

Informed consent.

Client's rights & responsibilities.

Availability by phone or e-mail outside of session, if applicable.

*you may also include: educational credentials, scope of practice.

Policy statement can be designed in various formats: resembling a <u>letter</u>, a page with <u>bulleted or numbered</u> items, or a combination of the two.

Be mindful of the following:

How to communicate policies to your client. (1st appointment)

Are you willing to enforce your policies?

Think about the impact each policy has on the therapeutic relationship.

Establish client friendly policies.

It is important your clients read, understand, and sign your policies.

Periodically review your policies.

Client Files:

Welcome letter along with your professional bio.

Health history, documentation form.

Informed consent.

Information release (as needed.)

Practice policies.

Client feedback form.

Be mindful of the seeds you plant ~ and ~ have fun dancing with the tulips!

Class Review

Only Man In The Room by Ken-Adi Ring, WCMT

There are few newsletters I read more thoroughly than *Connecting Hands* because it lends itself so well to our AMTA community. In addition to discovery of what my associates in this industry are doing or talking about, it is in Connecting Hands, one can find out what CE class, course or conference one might chose to participate in next. I look forward to our Annual Chapter meeting and Conference which occurs every February. Here many take advantage of the very reasonable world-class trainings offered by the

AMTA Wisconsin chapter. No less this

year.

What surprised me is that, I changed my first choice to learn NMT from one of the industries best instructors, Doug Nelson, to considering taking Nurturing The Mother Pregnancy Massage with instructor, Claire Marie Miller. I have not had enough

experience in this area. I felt drawn to it. My wife, Sally and I used to be called in to deliver prenatal massage at a local Madison area hospital. Less than a week before the conference I had a conversation with Mya Rowe, our registration queen, and was encouraged to step into it, so I did. I was intrigued by the quote "healing fear around pregnancy and birth and embracing the sacredness and joy of welcoming a new life" in the winter newsletter training description. That hook got me, I am all about healing, sacredness and joy.

Upon arrival at the Marriott hotel, and after signing in, I stepped into the room where a circle of 30 fellow students, all women, was about to begin. Feeling at first like a fish out of water, the only man in the room, I was warmly welcomed. Comments I paraphrase, such as: your testosterone energy will help balance the group and someone to hold space for the father and the masculine; and I was thanked for 'being a brave one'. This helped to break the ice. I was invited to sit in an empty chair next to the instructor, and join the process of sharing the story our own birth. This was a stirring and somewhat emotional time of sharing.

Claire Marie Miller emphasized the importance of our story at various times throughout the weekend. In fact,

I heard it mentioned that more technique and practice and less story was what some wanted. However, I was very appreciative of the stories each woman told and found it of value. Yes, there was a good deal of sharing. I felt the instruction and practice in every detail of tremendous value, too, but being a man, I had a rare glimpse into the world of 30 women sharing from their heart. I sometimes felt a tear wanting to emerge, as feelings were deep. When it came to me, I was one of two admitted breech births in the circle. The other happened to be, coincidentally, a woman sitting right next to me.

Soon after this first session we were immersed into a PowerPoint enhanced guided demonstration and practice period that rounded out the remainder of the day. Since I was student number 31 we were 3 to a table, in a room full of pairs. Two women were welcoming enough to embrace me and work with me. One of them very skilled and experienced the other in her first semester as a new student. Me? I was one of the eldest in the class. We were a unique trio, though later in the weekend we changed partners. I appreciated working with different partners, and learned something from each.

Learning more about side lying massage techniques and proper pillow propping and positioning for comfort of the pregnant mom became very useful on day two when we were given the opportunity to work on real pregnant expectant moms in various stages of their pregnancy. WOW! What an honor this was for me and I guess for everyone in the room, students and moms alike, to be present to so much fertile life. I was happy and honored to be assisting in the process of making the moms and evolving babies as comfortable as possible. When massaging an expectant mom we were really massaging two, we were reminded.

In this three-day intensive we trained in pregnancy, labor, postpartum and newborn/infant massage techniques. We also learned about the appropriate points and areas to massage using the modalities of reflexology and barefoot shiatsu. Instructor, Claire Marie Miller says, "By nurturing the mothers we nurture the foundation that builds our future". We experienced a very bonding process.

There were many aspects of the training. One of our teaching aids was the video 'Giving Birth' which for me was so profound a piece that I purchased a copy to have and to share with members of my extended family and community, especially my nieces and daughter. Our instructor emphasized the importance and possibility that lies in natural childbirth, and that fathers are a very impor-

Massage Therapists Join Together to Create a New Business Model

I am gathering information and writing a paper about Massage Therapists who share space and or expenses. I offer a description of the situation that I work in below. Please contact me if you work in a shared environment and would like to

share information on how you are organized.

In Madison, there is a group of therapists that share office space and related office expenses. There is no CEO, and management decisions are made as a group. Everyone is self-employed. The name on the door is Alternative Therapy Center of Madison.

There are four treatment rooms, a waiting area, a storage room, and an office. Time is divided into half day "shares". A share is either 8 am to 2 pm or 2 pm to 8 pm for a specific room and a specific day of the week. An

example would be every Monday from 8 am to 2 pm The cost for one share in our office is approximately \$70 per month.

The lease is held in one person's name. It is a 3-month revolving lease. The landlord allows all of the share-holders to write checks directly to the landlord. One week prior to month end, an accounting is provided to all of the shareholders detailing the expenses for that month along with the upcoming month's rent. The number of "shares" divides it. Each person pays based on the number of shares they have. Shared expenses include bottled water, paper goods, and office supplies.

There are many components of running a business that we do not share. Each person does his or her own marketing, scheduling, and laundry. Each person sets their own rates and their own hours. We are working on a website.


There is no business organization that I know of for what we do. It is like a cooperative. We call it "sharing expenses" and it keeps our costs down. I look forward to further developing this concept into a model that can be shared. It may even lead to the creation of a legal organization that we can use. I look forward to hearing from you. 



Class Review

Ethics as Soul Work.....Kathy Ginn by Amy Appel, WCMT
2nd VP, Education Committee Chair

When making my final preparations for my trip to Madison for our educational conference, I began to think

about and anticipate the class that I

would be taking this time. "Ethics as Soul Work......hmm", I thought. For some reason the name of the class struck me like a lightening bolt from the sky. I was so struck that I found it necessary to contact Kathy and share my feelings with her. One of the things I discussed was

my prior aversion to the topic of ethics. I just could not understand what all the fuss about ethics was for. I just figured that ethical behavior was something so full of common sense that there couldn't possibly be a need to have a class about it or continuing education around it. Then I met Kathy. Then I took a class with Kathy. Then everything I thought about ethics changed. Of course I have enjoyed previous classes with Kathy and have never heard anything but positive feedback about her classes.

When I think of the ways in which I serve my world, and the various volunteer activities in which I participate, I am often filled with a feeling of gratitude for the chance and capability to give in many ways. When I think of the lives and bodies that I have changed on my table, I am often filled with a sense of, "How did I do that?" I am of the belief

that I was born to serve, but that wasn't always how I felt. When I began to think about massage as a career, I wanted to "help" people, make a bunch of money, and "fix" problems of my own. I did no volunteer work. For me however, it left a gigantic space in my soul that needed to be filled. Massage therapy was the beginning to filling that space. I began understanding that massage could be so much more than relief from minor muscle aches and becoming aware of ways to use massage therapy to "give" to the world. Then I began my long journey into the world of volunteering by becoming an Emergency Medical Responder. In the years since, I have found many ways to volunteer. Through this process, I have discovered what "Soul Work" really is. Until taking this class with Kathy, I never put a name on it.

Kathy has an energy about her that is so integrated, she is so thoughtful and intentional. She makes it very clear that she is listening. She is contemplative of everything that is shared with her. She provides the opportunity to be heard by her ears as she listens and gives the indicative "um hmm". But she also provides that sacred opportunity to be heard by providing us with thought provoking questions to our souls. And our souls were answering, even when nothing was heard with ears. Kathy shared with us and contemplated with us the differences between "fixing", "helping", and "serving". What amazing concepts, how nice to bring about such clarity. It was very nice to begin the process of defining my purpose.

I am really looking forward to my continuation of this exploration, and I know that many of the people who took Kathy's class feel the same.

AMTA-WI Board Meeting
July 26, 2009
Altoona, WI – Kay Peterson's House

Meeting called to order at 10:55am by Amy Remillard.

Board Members and Committee Chairs present: Amy Remillard (President), Kay Peterson (1st VP/Newsletter Editor/Education), AnnMarie Kolb (Secretary), Erin Witthun (3rd Vice President/Outreach). Ellen Wittwer (2nd Vice President/Awards) and Betsy Krizenesky (Immediate Past President/ Law & Legislation) joined us by phone.

Approval of Meeting Minutes. MOTION: Kay Peterson moved to approve minutes as corrected. Shane Granzow seconded. All approved.

Board/Committee Reports

President: Amy Remillard reported that as of June 30, 2009 there are 1830 AMTA-WI members.

1St Vice President/Newsletter Chair: Kay Peterson reported that for the first time in her history with our chapter newsletter, we have past due advertising. Newsletter went out on time. Kay reported that there are a couple of members that would like to sell equipment at the next chapter conference in the vendor area. After discussion, we need to write up a liability policy. 2nd Vice President/Awards: Ellen Wittwer reported on her CVOP experience. She did a lot of networking and learned a lot. Ellen ordered our new shirts to be worn at our Education Conferences.

3rd Vice President/Outreach: Erin Witthun reported that she did chair massage at the Wausau Relay for Life Event. Erin has not received any more offers to come to events. She is doing research on what other chapters do currently. Connecticut Chapter raises money at events to support an organization, like American Cancer Society. After some discussion, the board decided that we should ask the chapter for their opinion on who our Chapter should support this same way.

Treasurer/Sports Massage: Shane Granzow reported on the reports from National say that we have the following moneys in our accounts: \$32,422.88 in our Checking Account, \$125,593.15 in the Edward Jones Investment account, and \$98,865.22 in the Tri City CD. Our total assets are \$256,881.25 at the end of May.

Shane also reported that we are going to team up with Sports in Wisconsin. This will allow us an opportunity to work at the Summer and Winter Badger State Games in the next year. He has contacted the Special Olympics and Transplant Olympics and other organizations to get out into the community doing Sports Massage.

Shane is also working with Judy Wu to get our website updated with forms we can print off, including the Expense

Report form.

Secretary: AnnMarie Kolb handed out updated Policy Manuals. She asked that we look at them and get corrections to her before September.

Immediate Past President/Law & Legislation: Betsy Krizenesky reported that as of July 26, 2009 our bill has yet to be circulated by Representative Berceau's office to get assembly sponsors so that it can be formally introduced to the legislature. This is due mostly to the preoccupation by legislators with the budget but now that is done, we should be able to move forward. She has frequent communication with Rep Berceau's office helping them respond to constituent concerns and objections, also with our lobbyists. Tom Fonfara (colleague of Tony Driessen) has said he would very much like to get it introduced and through at least one committee by November. She cannot over emphasize the importance of constituent contacts for the success of this bill. Just as soon as we get the OK from Rep Berceau's office we will do a mass mailing to members with a sample letter. Education Committee Report: Erin Witthun reported for Amy Appel and Mya Rowe. They toured the LaCrosse Center. The Board of Director meeting will be on the Saturday night at 7pm. Amy is still waiting to get a contract back from Bryan Born. As of now there are small numbers registered. The committee has set a date of February 20-22, 2010 for the next Educational Conference and Chapter Meeting to be held in Madison, WI. Display Unit Chair: Amy Remillard reported that Lynn Kutz is working on getting numbers and new Display unit information and our Yahoo!/Facebook stuff.

Old and New Business

Delegate Policy: Amy Remillard reported that AMTA National has changed the Delegate terms for the next election year. Those who were elected in 2009 will serve in 2010 <u>AND</u> 2011. NEW POLICY: Whereas delegates/alternates are elected by the Professional Members to attend the Annual National Convention as representatives of the AMTA-WI Chapter they shall serve in that capacity, attending the convention following the year in which they were elected.

The AMTA-WI Chapter shall cover delegate expenses incurred by said attendance (maximum amount to be determined by the Chapter Board of Directors and approved by the membership at the Chapter Annual Meeting) provided the Delegate fulfills the duties described in the Chapter Policy Manual regarding Delegates.

Reimbursement shall occur after completion of all duties has been satisfied and proper documentation in the form of original receipts has been submitted to the Chapter Treasurer, with the exception of the registration fee, which will be paid prior to the convention.

Exceptions may be granted on a case-by-case basis after discussion and approval by a majority vote of the Board of Directors.

Alternate duties will be assumed at the time of acceptance of the position of Delegate to fulfill the remainder of the term.
