Henry C. Barry, MD, MS is a professor of Family Medicine and Senior Associate Dean for Faculty Affairs and Development in the College of Human Medicine at Michigan State University. After graduating from the University of Maryland, he completed his family medicine residency at St. Lawrence Hospital in Lansing, Michigan and completed a master's in Clinical Research Design and Statistical Analysis at the University of Michigan School of Public Health. For over 20 years, as one of the original "POETs," he and colleagues have generated nearly 6000 POEMs – Patient Oriented Evidence that Matters – short critical summaries of original research on topics relevant to primary care physicians.



Emily Hall, MD, is an assistant professor of Clinical Family Medicine, associate program director of the Family Medicine residency, co-director of Family Centered Maternity Care at the University of Illinois at Chicago. She attended medical school at Columbia University's College of Physicians & Surgeons and completed her family medicine residency training at the University of Illinois at Chicago. She is a full-spectrum family physician with clinical emphases on maternity and reproductive care, maternal-child health, and behavioral health. She is currently in the Masters in Health Professional Education program at UIC. Her medical-education research focuses on the teaching of procedural skills and remediation of learners in difficulty.



John Hickner, MD, MS, is Professor and Head of Family Medicine at the University of Illinois at Chicago and Editor-in-Chief of the Journal of Family Practice. After receiving his medical degree from Indiana University School of Medicine, Dr. Hickner completed his residency in family medicine at the Medical University of South Carolina and received a master's degree in Biostatistics and Research Design from the University of Michigan School of Public Health. His main research focus is patient safety, especially testing safety and medication safety in primary care practice.



Kate Rowland, MD, MS, FAAFP, is an Assistant Professor at Rush Medical College and faculty at the Rush Copley family medicine residency. She graduated from Rush Medical College, the Advocate Illinois Masonic family medicine residency, and the University of Chicago primary care clinical research fellowship. 7:45-8:45am	Breakfast CME <i>Suspecting Pulmonary Hypertension (PH) in the Dyspneic Patient: Who, When and How - Tim Lahm, MD</i> Pulmonary hypertension (elevated right ventricular systolic pressure) is common, often caused by left heart disease but also associated with various lung diseases or idiopathic in origin. A less common but deadly form, PAH is usually undiagnosed or misdiagnosed until it has progressed to an advanced stage. This case-based lecture, designed for primary care clinicians, identifies clinical clues for the presence of PH in dyspneic patients; presents keys to differentiating PAH from other more common forms of PH; and offers a practical paradigm for collaborative diagnosis and optimal long-term management of PAH.

Axial Spondyloarthritis: A Case-Based Approach to Addressing Diagnostic Challenges and Missed Opportunities in the Primary Care Setting

Learning Objectives:

1. Identify axial spondyloarthritis (axSpA) in patients with inflammatory back pain via assessment of medical history, musculoskeletal symptoms and findings, and extraarticular manifestations and comorbidities
2. Apply classification criteria and diagnostic tests into clinical practice to support early detection of axSpA
3. Assess efficacy and safety data related to novel biologic options for axSpA, recognizing the potential clinical impact on the management of patients who do not respond well to traditional pharmacologic therapies
4. Employ a collaborative, multidisciplinary approach to ensure optimal treatment and long-term overall management of individual patients with axSpA

CME Topics Will Include:

- *Atopic Dermatitis Management: Practical Guidance for the Family Physician*

The overall goal of this educational initiative is to improve family physicians' ability to accurately diagnose and manage mild to moderate atopic dermatitis (AD). AD diagnosis and long-term patient management is a crucial clinical care gap among PCPs that has broad implications for patient outcomes. Accurate assessment of disease severity, the ability to understand the pathogenesis of AD, and individualization of management regimens are linchpins to developing an effective treatment plan that has the highest likelihood of achieving treatment response, disease remission and improvement in quality of life factors such as itching and sleep.

Learning Objectives:

Upon completion of this activity, learners will be better able to:

- RECOGNIZE the clinical features and characteristic age distribution patterns of AD
- DESCRIBE the role of skin barrier dysfunction, immune dysregulation, and environmental factors in the pathogenesis of AD
- INDIVIDUALIZE AD management regimens according to age, location, disease severity, response to treatment, and QOL concerns

- IMPLEMENT educational strategies to communicate the safe and appropriate use of skin-directed therapies to individuals with mild to moderate AD
- ***Canary in the Coal Mine - Will Cooke, MD***
 Saturday's program will include a presentation by Will Cooke, MD, the AAFP's current Family Physician of the Year. Cooke had always planned to practice in a rural, underserved area of his home state, but by February 2015, the tiny rural town of Austin, IN, found itself in the crosshairs of two deadly epidemics. The worsening opioid crisis led Austin to become what the CDC confirmed was the epicenter of the country's most serious drug-related HIV outbreak. Cooke's unrelenting commitment to his patients, as well as his many successes, earned him national recognition as the AAFP's 2019 Family Physician of the Year. Dr. Cooke will present Canary in a Coal Mine during Saturday's CME program, discussing lessons learned in his fight to help his patients.
