STAFF PROVIDE ADVOCACY, SUPPORT, AND ASSISTANCE TO HELP SURVIVORS MOVE PAST THEIR INITIAL CRISIS AND TOWARD A STABLE FUTURE. SERVICES INCLUDE FOOD, CLOTHING, TRANSPORTATION, PERSONAL CARE ITEMS, SAFETY PLANNING, ADVOCACY, CRISIS RESPONSE, INDIVIDUALIZED CASE MANAGEMENT, AND REFERRALS. ALTERNATIVES INCORPORATED'S SERVICE AREA INCLUDES HAMILTON, HANCOCK, HENRY, MADISON, MARION, AND TIPTON COUNTIES. IN FISCAL YEAR 2023, EMERGENCY HOUSING WAS PROVIDED FOR 72 ADULTS AND 92 CHILDREN FOR A TOTAL OF 5,832 BED DAYS.
