ELEMENTARY TEACHERS: IREAD-3 GOOD CAUSE EXEMPTIONS

If you are an elementary special education teacher or administrator serving students in grade 3, please review this document: <u>Process and Considerations for Issuing A Good Cause Exemption</u>

It is not required, but it is highly recommended that schools allow students with IEPs the same opportunities for remediation and retake of the test as their general education peers.

The retake testing window is from May 22- June 30. If the student does not pass the I-READ 3 test during the summer retest opportunity, a case conference will need to be held during the summer or at the start of the next school year to discuss whether or not the student qualifies for a Good Cause Exemption. A Good Cause Exemption may only be granted after a case conference is held.

Schools must now report all students who were granted a GCE from the IREAD-3 Spring 2022 and Summer 2022 administrations using the <u>Good Cause Exemption (GCE) Intervention Plan</u> form by March 6, 2023. IREAD-3 Spring 2023 and Summer 2023 GCEs should be submitted by September 1, 2023. Please talk with your administrator to find out who is filling out these forms for your school.

Grade two students who do not receive a passing score on the I-READ 3 test must retest in grade three and are not eligible to receive a GCE until after the grade three administration.

ASSET: APPLICATIONS NOW BEING ACCEPTED FOR 23-24

Add a mild and/or intense intervention license FOR FREE! Yes, FREE! We have several folks participating in this program this year. They attended a week long "boot camp" in the summer, then attend one virtual training day per month throughout the school year. There are tasks assigned each month that accumulate to the development of a portfolio at the end of the one year program. Once the year is over, they are eligible to take the PRAXIS exam for licensure. Let me know if you would like to talk with one of these folks more about their experience!

More info: ASSET is an approved alternative licensure Transition to Teaching program through IDOE and the Indiana State Board of Education. ASSET is offered through the Indiana Council of Administrators of Special Education (ICASE) for currently-licensed Indiana educators to add a special education teaching credential. Successful completion of the ASSET program coupled with passing the appropriate licensing exams enables educators to add either the Mild or/and Intense Interventions endorsement to their existing license. SECONDARY TEACHERS: AGE OF MAJORITY INFO

At a case conference committee (CCC) meeting not later than one year before a student becomes 18 years of age, the public agency must inform the parent and student that the parent's rights under Article 7 will transfer to the student when the student reaches age 18, unless a guardian has been appointed under IC 29-3 or an educational representative has been appointed pursuant to the procedures in 511 IAC 7-43-6. After the rights transfer to the student, the public agency must provide any notice required under Article 7 to both the parent and the student.

A student may request in writing that an educational representative be appointed. The student's parent must be appointed as the educational representative unless the parent is not available. If the parent is not available, the public agency must appoint an educational surrogate parent to serve as the educational representative.

If the student does not have a guardian or an educational representative and the public agency does not believe the student is capable of providing informed consent, an educational representative may be appointed if two appropriately licensed individuals (at least one of whom may not be an employee of the public agency) provide written certification, based on personal examination or interview, regarding the student's ability to understand, make rational decisions concerning proposed educational programs, and communicate understanding.
