I. <u>PURPOSE</u>

It is the policy of ClinicalConnect HIE (CCHIE) for its Participants to comply with the Health Insurance Portability and Accountability Act (HIPAA) rule pertaining to the notice requirements of its uses and disclosures of protected health information, specifically 45 C.F.R. § 164.520, and any applicable related state laws that are not preempted by HIPAA. The HIPAA Privacy Regulations can be located at 45 C.F.R. Parts 160 & 164.

II. <u>SCOPE</u>

CCHIE employees and its Participants.

III. <u>DEFINITIONS</u>

"Participant" is an organization (including physician practice) that has signed a Data Exchange Agreement with the CCHIE.

"Patient" includes a person authorized to consent on behalf of a patient who is a minor or lacks decision making capacity.

IV. <u>POLICY</u>

- A. Participants shall ensure that their Notice of Privacy Practices (NOPP) authorizes disclosures to CCHIE and be provided to patients before any patient health information is sent to CCHIE. Participants shall also ensure that their treatment consent forms authorize such disclosure. If assistance is necessary regarding updating the NOPP or treatment consent confirm, the Participant shall timely contact CCHIE.
- B. The patient has a right to control their participation in the CCHIE by either "opting-in" and allowing their health information to be shared with Participants or "opting-out" and preventing their health information from being shared.
- C. Each patient's participation decision shall be obtained by each ConnectChart Participant through the registration process when the patient is physically present and transmitted from their registration system to be managed by the CCHIE. Each ConnectChart Participant is responsible for communicating the patient's participation decision to the CCHIE.

- D. The Opt-Out Election form shall be used to record the patient's signature when optingout and filed for future reference. The Participant shall provide patients with a copy of the Opt-Out Election Form when providing its NOPP and treatment consent form and when a patient verbally elects to opt-out of CCHIE. If the patient refuses to sign the Opt-Out Election form, the Participant shall document the patient's unwillingness on the Opt-Out Election form before filing the form within the patient's medical record.
- E. Patients who do not express a decision to opt-in or opt-out of CCHIE will be assumed to have decided to participate and the patient's health information will be viewable by Participants provided that the patient had not opted-out at another Participant's facility.
- F. Each patient's declaration to opt-out of the CCHIE remains in effect until the patient explicitly makes the decision to opt-in and participate. For clarification, a "no preference" declaration does not change the prior "opt-out" declaration."
- G. CCHIE shall not share a patient's health information with Participants until the Participant has confirmed that its NOPP authorizes such and is available to the patient prior to sending the patient's health information to CCHIE.

Heritage Valley registration system sends "no preference" decision to ClinicalConnect HIE. Since patient had not previously opted-out, their health information in the HIE becomes viewable by the PCP and other HIE Participants.	Yes	No Pref	Yes
01/31/2012, 9:00 AM. Patient referred to UPMC for procedure and registers as an outpatient. Patient receives Addendum to the NOPP and verbally tells registration staff they want to opt-out of the HIE. Patient is given the Opt-Out Election form to complete and sign. UPMC registration system sends "opt-out" decision to ClinicalConnect HIE and the patient's health information in the HIE is no longer viewable by HIE Participants.	Yes	Opt-Out	No
01/28/2013, 10:00 AM. PCP visit within Heritage Valley Health System and patient registers as outpatient. Third visit at PCP so patient does not receive Addendum to the NOPP. Since patient's most recent participation decision was "opt-out", their health information remains protected and not viewable by HIE Participants.	No	No Pref	No
