Special Education Program Evaluation Info

Staff from the Center on Education and Lifelong Learning from IU will be visiting schools and talking with staff this year to complete an evaluation of each participating corporation's special education services as well as of the cooperative. Focus group meetings will be held in each corporation for principals, special education teachers, elementary teachers, and secondary teachers. Observations will be completed in both general education and special education classrooms. This is going to be a wonderful opportunity to get feedback on what we're doing well in addition to suggestions on areas in need of improvement. Be on the lookout for more information about when these focus group meetings and observations will be held in your district.

East Central Indiana Special Services - Info Corner

One thing that has come to light in planning for the special education program evaluation is that many corporation level special education staff and administrators do not fully understand the operations of the cooperative. In an effort to address this, a section is being added to the newsletter with information about the cooperative so that all are informed and aware prior to the program evaluation. Let's start with some basic info about the cooperative:

- The cooperative was created by and follows the terms outlined in a joint services agreement signed by the school board presidents of each of the participating corporations.
- The last revision to this joint agreement was in 2013. At that time, all teachers employed by the cooperative were made local hires. From 2013 to the present, all special education teachers are

- 2. We don't provide that (special education service) at this school...
- 1. We can't pay for that.....
