Answered mostly A: **Short-Term/As Needed Projects Volunteer**

Short-term and as-needed projects usually have a firm end date. Volunteers can serve the Fraternity in a variety of ways depending on the project. Typical short-term projects include: Writing content for Fraternity publications; reconnecting Sisters with and through the Fraternity; opportunities to provide educational training and facilitation at different Fraternity events; event planning and event production.

Answered mostly B's: **National Directors Network**

This is a network of national volunteers with expertise in the following areas: Academics, C.A.R.E., Extension, Finance, Lifetime Engagement, Member Development, Philanthropy, Ritual, Recruitment. The National Directors Network helps Territory Directors and Specialists find answers to questions for the chapters or associations.

Answered mostly C's: **National Council Designee**

National Council Designees serve as the liaison between their assigned chapter(s), advisory board(s), and the National Fraternity. They provide consistent leadership, mentorship, and support to the chapter(s) and advisor(s) they serve. During their appointment, they provide strategic planning, problem solving and adaptability in decision making. Part of their role is to interpret, and when necessary, grant exception to policy. They also appoint, train and lead Chapter Advisors.

Answered mostly D's: **Chapter Advisory Board**

These volunteers provide on-the-ground guidance, assistance and positive direction to their assigned chapter(s). Chapter Advisors and advisory boards build positive relationships and deliver consistent communication to serve the chapter. Chapter Advisors are appointed and trained by their National Council Designee. They work closely together with the chapter to set goals and action steps. The Chapter Advisor also appoints an advisory board. A full advisory board can include, but is not limited to (depending on the needs of the chapter): Chapter Life Advisor, Membership Advisor, New Member Orientation Advisor, Member Development Advisor, Philanthropy Advisor, Finance and Operations Advisor, and Communications Advisor. These advisors closely work with their assigned collegiate officer and/or team to provide guidance on their goals.
