**Speaker Biographies:**

**John Hammond, JD | Partner, Ice Miller, Indianapolis**

John R. Hammond III is co-chair of Ice Miller's Public Affairs Group. As a veteran of Indiana state government, he has helped shape a wide variety of public policy, from tax policy to environmental management, education to tort reform, transportation to insurance and economic development.



John served as a key aide to former Indiana Governor Robert D. Orr during his time as lieutenant governor, as well as serving as a deputy campaign manager for Orr's gubernatorial run in 1979 and heading up his transition team in 1980. He was senior executive assistant for Legislative Affairs and Education Policy in the Orr administration, serving as chief legislative liaison for six general sessions and three special sessions of the Indiana Legislature during the 1980s. Since leaving state government in 1988, he has led the governmental and public affairs programs for several major Indiana firms.

He is a frequent public affairs panelist and lecturer, and is the co-author of the article "Campaigns and Candidates: Lawyers and Their Obligations," prepared for the Legislative Services Agency for Continuing Legal Education's seminar titled, "The Lawyer-Lobbyist." He also serves as a Republican commentator and analyst on Indiana Week in Review, a state wide public affairs news program of WFYI focusing on Indiana government and politics.

He has served as an advisor to several statewide campaigns. John was awarded his Bachelor of Arts from DePauw University in 1976, and a juris doctorate from the Indiana University School of Law in 1991. He is admitted to practice law in the state of Indiana. John joined Ice Miller in February 2001.

**Anne Doran | Director of Public Affairs, Ice Miller, Indianapolis**

Anne Doran is a seasoned legislative advocate with a wealth of experience representing corporate, municipal and trade association clients before the Indiana General Assembly and state and local regulatory agencies.

Anne has previously held government positions at the federal, state and local levels. She began her public service career in Washington, D. C., working for the general counsel of the Federal Election Commission and the administrator of the Small Business Administration. Anne joined the staff of the mayor of Fort Wayne, Ind. as deputy staff director responsible for oversight of external affairs for the city, including public information, citizens action service center and the management of local and state legislative matters. She was active with the U. S. Conference.

At the end of the mayor's term in office, Anne joined the Lincoln National Corporation as director of Indiana government relations, representing both the corporation and the domestic life and health trade association, the Association of Indiana Life Insurance Companies, before the Indiana General Assembly and state regulatory agencies. She served as corporate representative to numerous associations, including the Health Insurance Association of America, the American Council of Life Insurance, Indiana Chamber of Commerce, the Indiana Manufacturers' Association and the National Association of Insurance Commissioners. Prior to joining Ice Miller in January 2001, Anne was director of public affairs for the law firm of Johnson Smith, LLP.

A member of a politically active Indiana family, Anne has been extensively involved in state and local politics. She has served as campaign manager or volunteer on dozens of mayoral or city council races throughout the state, and has worked on the campaigns of several current and former congressional members as well as state office holders. She has been a delegate to both state and national conventions and has been a local precinct committeewoman.

She holds a Bachelor of Science in public affairs from Indiana University.

### ***The Role of Primary Care in Indiana's Infant Mortality***

Nancy Swigonski, MD, MPH | IU School of Medicine, Indianapolis

#### **Learning Objectives:**

#### **Speaker Biography:**

Dr. Swigonski is a professor at the IUPUI Children's Health Services Research department at IUPUI in Indianapolis. Her special interests include primary care; medical home; quality of life; improvement science; quality improvement; improvement partnerships; and children with special health care needs.

Dr. Swigonski received her MD from the University of Kentucky. She completed an internship and residency in Pediatrics at the Indiana University School of Medicine. She then moved to Cleveland where she was in private practice. She returned to Indiana University to complete a health services research fellowship at the Regenstrief Institute for Health Services Research and completed her Masters in Public Health.

Dr. Swigonski is a professor of General and Community Pediatrics, in the Indiana University School of Medicine, a professor in the Fairbanks School of Public Health, and is an affiliate scientist of the Regenstrief Institute. She has served on many national and state boards including the AAP's Medical Home Initiative Project Advisory Committee. She receives funding from NIH, AHRQ and MCHB. Her research interests include underserved populations, access to health care, quality of health care, improvement science, and systems development.

### ***HIV: Updates in Prevention and Management***

#### **Learning Objectives:**

1. Recognize risk factors that contribute to the continued spread of HIV, especially in high-risk populations
2. Incorporate into the family physician's daily practice various practical methods to educate, counsel, and/or refer patients exposed to HIV with a goal to promote safe and responsible health and reduce risk of new infections
3. Discuss and apply findings and ongoing research on the use of vaccines, pre-exposure prophylaxis, post-exposure prophylaxis, and other prevention strategies in various populations
4. Develop and implement an up to date evidence-based treatment regimen in individuals who have been infected with HIV, and improve patient adherence among those who are receiving treatment
5. Describe strategies that link patients with HIV to the appropriate care upon diagnosis when referral is required

#### **Speaker Biography:**

Dr. Beeler was born and raised in Indianapolis and developed a passion for Infectious Diseases before Medical School when shadowing a local physician over a summer. He went to school in Bloomington for College and his first two years of medical school after which he returned to Indianapolis for his clinical years. He did his Internal Medicine Residency with IU and served as

Chief Resident at Eskenazi Hospital. He completed his Infectious Diseases Fellowship and joined IU faculty in July of 2017. He currently serves as the Director of Infection Control at University Hospital. His interests lie in HIV, hand hygiene, central line associated bacteremias, Clostridium difficile, and Antimicrobial Stewardship. Dr. Beeler lives with his wife and children in Carmel. In my spare time he enjoys playing bass, running, reading, and staying active at his church.
