AMTA Wisconsin has been busy this past month. I am delighted to be able to share with you some of the highlights:

Veterans Massage Training with Nicole Miller took place March 18-22 in Madison. It was a intense 40 hours of training (see Alisha's article below). Ten Wisconsin therapists completed the



training. Congratulations to those who have achieved the NCBTMB Speciality Certification! We will be working with the VA hospitals and veteran's organizations to find ways to serve our veterans through massage therapy.

Senate Bill 133/Assembly Bill 143 is moving through the legislature. This bill will allow local municipalities (cities, towns, and villages) to pass ordinances against massage being practiced without a state license. The municipalities will then be able to issue citations to persons and business owners were unlicensed massage takes place. We worked with the bill authors (Sen. Kooyenga and Rep. Sanfelippo) to make sure that these ordinances will not place any burdens on professional, ethical, licensed massage therapists. We will continue to follow this bill.

Our <u>State Convention</u> is quickly approaching! We have an exciting lineup of education including a student and graduate day. Our chapter meeting will be held on May 4 during the convention. Please join us for the latest chapter updates.

Our elections are underway. Thank you to those who are running for leadership positions. We appreciate your willingness to serve the chapter! We will install our new board members at the chapter meeting.

AMTA-WI had the pleasure of hosting Nicole Miller from Crouse Health in New York who has developed a specialty training for massage therapists to reach our Veterans with massage services that many need and desire. The course was five days filled with information that ranged from effects of combat gear on bodies, physical as well as invisible wounds and



specific techniques to adapt to Veteran's needs. The therapists who participated were from a diverse background of clientele all with a passion for serving our Veterans of all ages.

While it's difficult to put into words the effect that the week had on participants; let me share a few of the highlights with you. We had the pleasure of learning more about the services of the Veterans Suicide crisis department and how they are able to triage calls and assist many veterans in urgent need. The spokesperson for the department did a wonderful job conveying the effects and outreach that continues to grow to help Veterans from crisis. We had the honor of visiting inside the veteran's hospital where we were able to talk with the therapy department and also provide a donation from the class. During the week many course participants were generous with their thoughts in writing hand written cards to Veterans and donations of items that went directly to the Veterans in the hospital. I want to thank those that provided the donations and well wishes; I'm sure many are already impacting the needs of the Veterans. We also had the privilege to hear from a guest Veteran speaker about a documentary that he and a fellow Veteran created regarding their struggles on many levels upon returning to civilian life. If you have a chance please look into The Documentary: "Almost Sunrise" which follows Anthony Anderson and Tom Voss.

This specialty training will hopefully be a platform to for many of the class participants to take the specialty certification. I am confident that each therapist that took the course walked with increased knowledge, respect for the Veteran's culture and thankful for the opportunity to grow as therapists.

Recently Jeffrey Montoya, AMTA-WI Chapter President and I have been working to protect the interests on AMTA – WI Chapter in regard to Senate Bill 133 (and its companion bill, Assembly Bill 143)

The goal of the Senate Bill 133 is to provide local law enforcement the tools they need to address illegal activities by unlicensed employees in massage establishments. Jeffrey and I met with the author of the bills, State Representative Sanfelippo as well as Bill Cosh, Policy Advisor to State Senator Kooyenga to discuss the legislation. After a positive exchange and clarification regarding the language of the bill, the AMTA-Wisconsin determined that we could support

The Senate Committee On Public Benefits, Licensing, & State-Federal Relations, held a hearing on Senate Bill 133 on Tuesday, April 16, 2019. The AMTA-WI

Chapter registered in favor of the bill and Wisconsin President Jeffrey Montoya testified in support of the bill. President Montoya's testimony showcased who AMTA-WI Chapter is, who are our members, and provided an opportunity to educate the Senate Committee members on the current requirements to obtain a state license, the importance of licensing for massage therapists, and the potential harm that can be done by those who do massage without a license.
