**Welcome to Pike Place** - a community collaboration culminating in a beautiful place for our community to gather. This new green space in downtown Crawfordsville is located on the corner of Pike and Washington streets. A devastating fire in 2008 that destroyed buildings left this corner desolate for several years. The City of Crawfordsville was awarded the Stellar Community Designation in 2015 and one of the targeted projects was turning this vacant space into a pocket park. In 2016, the Montgomery County Community Foundation awarded \$100,000 toward this project as part of our 25th anniversary celebration. It was a long process from concept to completion, but in the Spring of 2019, a dedication ceremony was held to celebrate the official opening of the new park. The name itself, Pike Place, was the result of a community contest, and now it is a place for many community gatherings, including the seasonal Farmers' Market.





#### For any child to experience the pain and discomfort of consistent hunger is heartbreaking. To compound that

with the frightening prospect of not knowing when, or even how, the next meal will come is an even greater tragedy. But hunger and food insecurity are the reality for nearly 20 percent of children in our community. It is a complex problem as multiple, overlapping issues like affordable housing, social isolation, health problems, medical costs, and low wages increase a family's risk of food insecurity. There is no single face of food insecurity, and could be as close as our next door neighbor.

The negative impact of hunger on children goes way beyond a growling stomach. Children who are food insecure are more likely to repeat a grade in elementary school; can have difficulty concentrating in school; can experience social and behavioral problems, as well as chronic health issues; and are more likely to suffer depression and anxiety. These are the sad and sobering facts that the Nourish Backpack Program, administered by the Youth Service Bureau, is working to address.

The Nourish Backpack Program provides backpacks of food to children in need who are identified through our schools and pre-schools. These backpacks are sent home every Friday to help ensure that the children will not go hungry over the weekend. Since 2014, over 44,000 bags of food have been provided through this program, and in 2019 around 225 bags per week were sent home with students. Families participating in the program say it makes a positive difference, and they are encouraged knowing their community and school care about them. Students look forward to getting their bags each Friday knowing that at least for that weekend, they will not go hungry.

Financial support is made possible through strong community partnerships, such as local churches and businesses, as well as individual donors. The Nourish Endowment Fund was established at the Montgomery County Community Foundation to help provide sustained funding for this program well into the future. Distributions from this fund go directly to support the Nourish Backpack Program.

In October 2018, we began a matching gift campaign for the Nourish Endowment Fund and donor gifts were matched two dollars for every dollar given. When the campaign ended in December 2019, over \$50,000 was raised through donor gifts. These matched gifts, added to the endowment, will generate approximately \$8,000 per year to the Nourish Backpack program. Thank you to all our generous donors who are helping us ensure a healthier tomorrow for children in need right here in our community!

### Minding our Manners Matters

Middle school is a critical time of development, and social influences and personal experiences can have a profound effect on students' lives. As they begin the transition to young adulthood, fundamental skills are needed as they prepare for their future. And in today's environment, it is evident that many of the social manners of the past are not being taught, or caught.

Through the generosity of a private funder, we hosted three etiquette workshops for local middle school students. The Etiquette Luncheon and Workshop was led by Christie Pate Herron, a professional etiquette consultant, and was held at the Crawfordsville Country Club. The program covered important topics such as table manners, the art of conversation, eye contact, cell phone and social media etiquette, among other important life skills. It was a fun, lively, and engaging atmosphere. The feedback was overwhelmingly positive and below are just a few of the many comments from students that we received.

#### Describe one thing you learned through this experience:

"Always use proper manners and don't talk with your mouth full."

"You cannot pick up a fork after it has been dropped in a public place."

"I've been eating bread wrong my whole life."

"How to be polite and nice during a meal."

"The part about self-love really stood out to me because I've had issues with self-love myself. I have definitely learned a lot."

### **Holocaust Education**

The Montgomery County Community Foundation was honored to bring Holocaust survivor Eva Mozes Kor to Crawfordsville in April 2019 for a community presentation. With a standing-room only crowd, her message, "From Auschwitz to Forgiveness" was sobering and powerful.

During her internment at Auschwitz concentration camp when she was just 10 years old, Eva and her twin sister, Miriam, were subjected to genetic experimentation by Nazi doctor Josef Mengele. On the 50th anniversary of the liberation of Auschwitz, she received international attention when she publicly forgave the Nazis for what had been done to her.

In 1984, Eva founded CANDLES Holocaust Museum in Terre Haute. She worked tirelessly through the museum and her lectures to educate the public about eugenics, the Holocaust, and the power of forgiveness. Eva emerged from a trauma-filled childhood as a brilliant and inspiring example of the human spirit's power to overcome, and the ability to forgive those who committed unspeakable atrocities.

2. Prevent prejudice by judging people only on their actions and the content of their character.

#### **TYPES OF FUNDS**

#### **UNRESTRICTED FUND**

An Unrestricted fund enables the Board of Directors to choose the most worthy and needy recipients of your fund's distribution over time according to the current needs of the community. The flexibility of the fund makes it particularly valuable to the community. Fund minimum is \$5,000.

#### **DESIGNATED FUND**

A Designated fund allows you to choose specifically the charity, or charities, that you wish to support. Fund minimum is \$5,000.

#### DONOR ADVISED FUND

A Donor Advised fund allows you to make non-binding recommendations to the Board of Directors, thus allowing you more interaction with your fund. Fund minimum is \$5,000.

#### **FIELD OF INTEREST FUND**

A field of Interest fund allows you to choose a particular area of charitable interest that you would like to support. The Board of Directors then identifies the most qualified local charities which work to support your area of interest. Fund minimum is \$5,000.

#### **SCHOLARSHIP FUND**

A scholarship fund provides assistance to Montgomery County students. Scholarship criteria may be broadly or narrowly defined, as you choose. Please note that for administrative reasons, scholarship funds require a minimum contribution of \$25,000.

#### PATHWAY PLAN

A Pathway Plan is a planned giving agreement that allows you to build a named fund over five years. You may establish the fund immediately with a minimum of \$1,000 and add to it over five years until it reaches \$5,000 and becomes an endowed fund. Holly Shaver, 2019 Southmont graduate, was honored to be the first recipient of the Cole Petty Scholarship. She is attending Purdue University and is currently pursuing a degree in Ag Sales and Marketing. Holly grew up on a farm and was a member of FFA throughout her middle and high school years. This, combined with her interest in marketing and graphic design, steered her towards this degree.

Holly comes from a small, close-knit community, and she wanted to find a way to re-create that within her large community of peers at Purdue. She says this important task has really been the best thing about college so far – the joy of meeting new people and bonding with her "family" of ag students. And

like most freshmen, the hardest adjustment has been time management and staying on top of a much heavier course load than high school.

Holly is grateful for the financial help through this scholarship, but there is an emotional attachment as well. Holly knew Cole as he and her brother were good friends in high school and even attended Purdue University together. Cole was also instrumental in helping her feel welcome when she first joined FFA, and Holly will always remember his kindness.

Cole Petty had a passion for the outdoors and loved hunting and fishing. He soaked up everything nature had to offer and held a deep affection for all wildlife - even if it slithered. Cole had a wonderful, contagious sense of humor. He was also a dedicated student who received his BS degree from Purdue in Animal Science, Posthumous. Cole fought a hidden battle with depression which clouded his vision and cast a murky shadow over the value of his life. He lost that battle at the age of 22.

The Cole Petty Scholarship Fund was established by his parents, Bret and Lisa Petty. His parents have courageously chosen to be open about the manner of Cole's death, hoping it will lead to conversations about suicide awareness and prevention where possible. This scholarship honors Cole's love for Southmont, as well as his beautiful, tender spirit.

We are honored to continue to help turn the generosity of our donors into results. Every grant, every scholarship, is because you gave, you trusted, and you believed. We are deeply grateful for what you do, and what you allow us to do, for Montgomery County through your generosity.





We conducted five informal and conversational meetings with various citizens in our community. These meetings, called Community Chats, were part of our ongoing efforts to make our community a better place to live, work, and raise a family. These sessions were engaging, valuable and very enlightening! The five conversations were with neighbors and friends from the Waynetown community, the recovery community, the Hispanic community, downtown residents/business owners, and the Montgomery County Leadership Academy. All together, we had 72 participants and we were so grateful for their input. We heard many positives about our community, and we gained a clearer perspective on areas that need improvement. The following is a summary of what we learned.

## WHAT WE HEARD

### SUBSTANCE ABUSE, ADDICTION & DRUG PREVENTION



- The opioid problem is multifaceted it affects poverty, employment, parenting, etc.
- Despite progress, there still is a stigma associated with addiction.
- There is a lack of MAT (Medication Assisted Treatment) physicians/ clinics.
- More mental health and trauma services are needed in the county.
- There is a need for more of a prevention focus, such as a mentoring program.

### **WORKFORCE & JOB READINESS**

- There are some barriers that make it challenging to find employees to work, such as, the inability to pass drug tests, and a lack of commitment, work ethic, and skills.
- More education is needed on life skills, such as writing checks, doing taxes, interview skills, etc.
- The community is not aware of career resources such as Next Level IN.
- While there are many jobs available, many are looking for jobs with better wages and benefits such as health insurance.
- Once some are employed, they lose assistance and are worse off than before.



### POVERTY



- We have wonderful resources and services that address poverty in our community. However, there is a need to strengthen services to address the root causes of poverty and help individuals learn the necessary skills to become self-sufficient.
- Some questions were raised about the possibility that our abundance of resources attracts people relying on resources.
- Some families with real needs are slipping through the cracks, such as poor working families that are not eligible for free and reduced lunch.

### **DOWNTOWN CRAWFORDSVILLE**

- Visitors might find our one-way streets challenging.
- There are many great events happening downtown, but it is challenging to learn what they are.
- Not enough new development to attract youth.
- Parking is difficult to locate, and fills quickly.







Panelists for Community Insights: Getting Schooled

In April 2019, together with the League of Women Voters, we hosted a three-part series of meetings called Community Insights: The Workforce. The community was invited to listen and participate in any or all of these gatherings, with facilitated discussions following the presentations. The primary goal was to learn as much as we could about our local workforce and to illuminate areas of challenge and opportunity. A shared concern that rose to the top among all three groups was child care. Below is a brief summary of the series.

#### Part 1 - The Big Picture

Representatives from the Montgomery County Economic Development and the Montgomery County Chamber of Commerce gave an overview of the workforce from their perspectives. They shared the types of work available locally, workforce statistics, and changes and trends. Here's what we learned:

- We have a strong workforce overall, but there are gaps.
- While our unemployment rate remains under 5%, latest estimates show we have 300 unfilled positions due to a lack of qualified workers.
- In addition, employers are lowering their standards because of a less stringent work ethic among potential employees.
- The top concern was a lack quality child care, which is needed to attract new employees and keep current ones.

#### Part 2 - The Human [Resources] Perspective

Local employers shared the strengths and weaknesses of the local workforce. Here's what we learned:

- Generally, their core workforce is dedicated and hardworking, but it is a challenge to recruit and retain new employees into the culture.
- Addictions and lack of work ethic make it challenging to find new employees.
- Other top issues were developing a workforce, and the need for affordable, diverse housing.
- Especially challenging was the lack of quality child care, especially for children under age three, and for those working early shifts.

#### Part 3 - Getting Schooled

Local school superintendents, school career coaches, and a representative from Ivy Tech shared their collaborative efforts to help prepare our students for the workforce. Here's what we learned:

- The schools are working with local industries and businesses to develop programs that will create skilled workers.
- There is a stigma about entering the workforce upon graduation, so more education is needed for parents and students to look beyond a fouryear degree.
- Opportunities exist for students to earn certificates while in high school.
- While child care was not a top concern in this session, it was noted that research shows an investment in the first five years of education will have huge payoff for a student's future success.





**Workforce Signing event:** Twenty-three students from Crawfordsville, North Montgomery, and Southmont high schools signed commitments with their employers before a crowd of 140 people gathered at Stone Creek Lodge last May. Thanks to the great class offerings in Advanced Manufacturing, students are entry-level ready for many opportunities upon graduation and well on their way to various associate degree options. We were happy to make a Love Note grant of \$1,000 to support this event.

This inaugural event was the result of the Mayor's Workforce Roundtable (which brings local employers, and local school and government officials together, sharing and networking) and the career coaches from the three county school districts.



### **Nonprofit Listening Sessions**

Throughout the summer we held listening sessions with our local nonprofits, gathered by these areas of interest: Health, Human Services, Youth, Education, History, Arts & Culture, and Community Development. In multiple sessions, we shared and heard many positive aspects about our community. These pages focus on the areas where improvement is needed. Child care is an underlying factor in each, with availability and affordability being high concerns.



### COMMUNITY DEVELOPMENT

### We Heard...

- Many expressed concerns about the lack of diversity in housing in Montgomery County.
- · Accessibility is an issue in many areas from being unable to walk to places such as work to a lack of wheelchair accessibility.
- A lack of communication about events and opportunities in our town can sometimes create problems.


### **EDUCATION**

### We Heard...

- Access to mental health assistance is a growing concern in our community.
- Many children are experiencing ACEs (Adverse Childhood Experiences), which include: parent divorce, parent incarceration, parent with mental illness, parent substance abuse, victim or witness of abuse, or being a victim of poverty.
- There is a noticeable gap in pre-K education in our county. Lack of consistency in early childhood education curriculum can cause delays in educational and behavioral goals.
- Some students are unaware of all the options available to them for education after high school.


### Data Says...

### We Heard...

- Mental health is a rising concern among youth and adults in our county.
- More mental health services are needed in our county.
- There are many children who do not have health insurance or a medical home.
- The Free Clinic is a valuable resource but not widely known.



**27.2%** of Montgomery County adults reported having a high level of stress (8+ on a scale of 1-10).



**65.1%** of Montgomery County adults get their health information from family and friends, **64%** get health information from the internet, but only **19.1%** get their health information from a health professional.

### HISTORY, ARTS & CULTURE

### We Heard...

- Concerns were expressed about the ease of access to information about events and resources in our community.
- There is a lack of a brand for our community, which creates gaps in our marketing as a whole.
- Wayfinding also plays a role, as it can allow a brand to develop, and allow visitors and residents alike to know where places are, where to park, and how to walk to certain areas/buildings.

### Data Says...

In a city that has incorporated wayfinding, **33.1%** of residents said the signs encouraged them to walk or bicycle more in their community, and **82.6%** said wayfinding was beneficial to their community.

### HUMAN SERVICES

### Data Says...

### We Heard...


- More emphasis is needed on preventing criminal activity and drug abuse.
- Prevention needs to start in young children, because the later prevention efforts begin, the less effective they are.
- Our county is lacking adequate transitional housing.
- There are some recovery programs available, but they quickly reach capacity.
- Lack of resources is a cause of higher recidivism rates.



The Montgomery County recidivism rate is **26.2%** overall. For controlled substance offenders, the recidivism rate is **23.4%**.

### Before JCAP\*, Dearborn County's recidivism rate was **43%**. The rate after JCAP is **18%**.

\*JCAP, which stands for Jail Chemical Addiction Programs, is a 90-day voluntary program for incarcerated individuals struggling with drug addiction. Montgomery County started their own JCAP program in spring of 2019. Participants are placed in a separate jail pod from the general population throughout the duration of the program. JCAP helps teach participants to stay away from drugs and other criminal activity after their release. The Montgomery County JCAP currently has a capacity of 13 male inmates.




### YOUTH

### We Heard...

- Emotional and behavioral issues have become more common among youth, which often stems from the disintegration of the family.
- Social media is playing a large role in youth mental health - children tend to believe what they see online, which can lower their self-esteem.
- Montgomery County is considered a child care desert. A child care desert is defined as a neighborhood or town where there is no more than one child care seat for every three children.
- Child care is a need that reaches beyond youth and affects the workforce and the entire community.
- Lack of transportation is a barrier for many as they consider child care and preschool options.

### **2020 VISION - LOOKING TO THE FUTURE**

From the conversations we had during our Community Chats, Community Insights, and Nonprofit Listening Sessions, the need for high quality early learning and child care seats emerged as a high priority. Many of the other issues mentioned in our sessions can also be potentially impacted by this in the future. Before we lay out our vision and our strategy to address this issue, we will show you the steps we took to get here:



GIFT VII Planning Grant – As part of Lilly Endowment's community foundation leadership efforts, they launched the seventh Giving Indiana Funds for Tomorrow (GIFT) late in 2018. Under the first phase of the Community Leadership portion of GIFT VII, we had an opportunity to apply for a \$50,000 Planning Grant. We were excited about the leadership opportunities in our community and the potential impact through this grant. This planning grant allowed us the opportunity to do a more in-depth exploration of needs in our community and help us focus on a key area or areas of greatest need. Our application was successful and we were so grateful for the award which enabled us to conduct the listening sessions, hire a consultant, and increase our internal capacity through training and software upgrades.

As child care emerged as a common concern across all listening sessions, we joined with the Mayor's Workforce Development Round Table to form a group known as the Montgomery County Child Care Task Force. This 18-member group includes employers, nonprofits, government, educators, parents and child care providers. Once formed, the Task Force hired Transform Consulting to complete a county-wide needs assessment and help develop a strategic action plan to address early learning in our community.



In total, more than 1,490 people contributed to this child care needs assessment for Montgomery County. Employers, employees, and parents took surveys or participated in focus groups or interviews to discuss the child care needs of Montgomery County. Sixteen partners including industry, city and county government, and all three public school districts recruited employees and parents to participate. The results confirmed what we heard in our listening sessions.

From the assessment we learned that:

- 81% of employers see child care as an important factor in their employee's decision to work in the county.
- 81% of employers believe that employees have difficulty focusing at work, are late, or miss work due to issues related to child care.
- 40% of employees see child care as an important factor in their decision to *live* here.
- 53% of employees see child care as an important factor in their decision to *work* here.
- Available hours was the number one priority parents cited when looking for child care, with 74% saying it was a problem.
- According to providers, the cost to parents for one child enrolled in a full day program ranged from \$60 to \$110/week for children ages three or older who are potty trained. Children under two had costs that ranged from \$80 to \$191/week.




