# **Transition Guidance for Secondary Teachers**

• PLEASE- Focus on Authentic Assessments, student career/college/technical school research experiences, etc. Examples can be found here:

- BURN (carefully so as not to cause a nearby forest fire) any left behind contrived 'assessment' such as What's in my Bag, Personal Professional Goals Worksheet, What's Difficult for Me, etc. These were originally posted on the Transition Matrix. These assessments WILL NO LONGER meet criteria for a compliant Indicator 13 audit.
- ANNUALLY assess Education, Training, AND Independent Living areas of transition. An Independent Living Skills Checklist, that can grow with the student, can be used. This is also posted on the Transition Padlet.

#### What is the Alternate Assessment?

All students with disabilities must participate in either the general assessment for the grade in which the student is enrolled or the alternate assessment. Our alternate assessment is called Indiana's Alternate Measure or I AM. Case conference committees must determine whether or not a student meets specific criteria (see below) to participate in the alternate assessment. This assessment is designed for students with the most significant cognitive disabilities. # What is the Criteria for Student Participation in the Alternate Assessment?

If a case conference is considering moving a student to the alternate assessment, please request a reevaluation so that new cognitive and achievement information is available to assist the case conference committee in making this decision.

Once the evaluation has been completed and reviewed by the case conference committee, then you may use these forms to determine whether or not a student meets the criteria to participate in the alternate assessment.

#### Course Description:

Language Acquisition Through Motor Planning (LAMP) is an augmentative alternative communication (AAC) approach designed to give individuals who are non-verbal or have limited verbal abilities a method of independently and spontaneously expressing themselves through the use of a voice output communication device. LAMP was initially developed to give non-verbal individuals with autism a means of communication but can be adapted to benefit individuals with a variety of disabilities. The components of LAMP address the features and vocabulary available on the device as well as the method of teaching communication while taking into account the individual's sensory needs.
