1. Call to Order

Ms. Chavis made a motion to provide a stipend to East Central teachers in the amounts provided from the Teacher Appreciation Grant to Union County teachers out of the IDEA grant funds.. Motion seconded by Mr. Edge. Motion carried 3-0.

C. Special Education Administrative Assistant


Ms. Bates will gather information regarding the compensation provided to special education administrative assistants in other comparable districts.
