ABOUT JCPL

History

- **1911** Local women's clubs raised \$1,850 and opened Franklin's first public library
- **1966** Bookmobile service introduced to expand services outside Franklin
- **1977** Franklin-Johnson County Public Library established to meet demand
- **1987** Franklin (19,400 sq ft) and White River (23,500 sq ft) branches open
- **2007** Trafalgar Branch (22,000 sq ft) opens
- **2008** JCPL Services Center, our administrative building, is added
- **2022** Clark Pleasant Branch (17,200 sq ft) relocates to new building
- **2023** JCPL on Wheels bookmobile launched to reach underserved areas



FACILITIES PLANNING

2018 Completed Building Analysis Plan

2020–2023

- Major mechanical and lighting deficiencies at the Trafalgar Branch addressed
- Relocated and opened a new Clark Pleasant Branch in Whiteland: larger, more accessible and better equipped to serve the community
- Added a Play and Learn space at the Trafalgar Branch, to support early literacy and kindergarten readiness
- Continued evaluating long-term facility needs at White River and Franklin branches

2024 Feasibility study determined renovating White River Branch is the fiscally responsible option

Late 2024 Preconstruction planning with HBM Architects to refine project scope and cost estimates

2025 Project was paused while JCPL assessed the impact of new state legislation

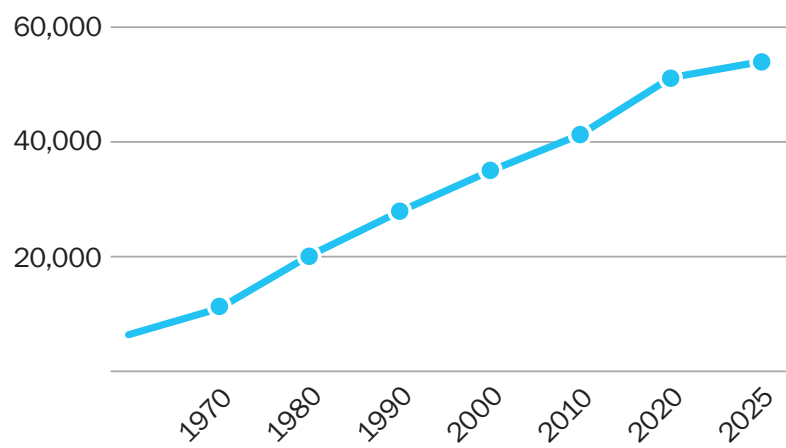
MEETING THE NEEDS OF A GROWING COMMUNITY

Why Now?

The White River Branch has served the community for nearly four decades. In that time the Township’s population has doubled, from 28,232 residents in 1990 to an estimated 57,600 in 2025. Center Grove Schools will grow from about 9,700 students to an estimated 14,000 by 2050. Now is the time to prepare for the continuing growth.

In 2023, a detailed facility assessment revealed aging infrastructure, accessibility issues and limited space, which hinder the Library’s ability to meet current and future community needs. The proposed plan aims to increase usable space by about 37%, safeguarding our 40-year investment and ensuring the building can adequately serve the community for many years.

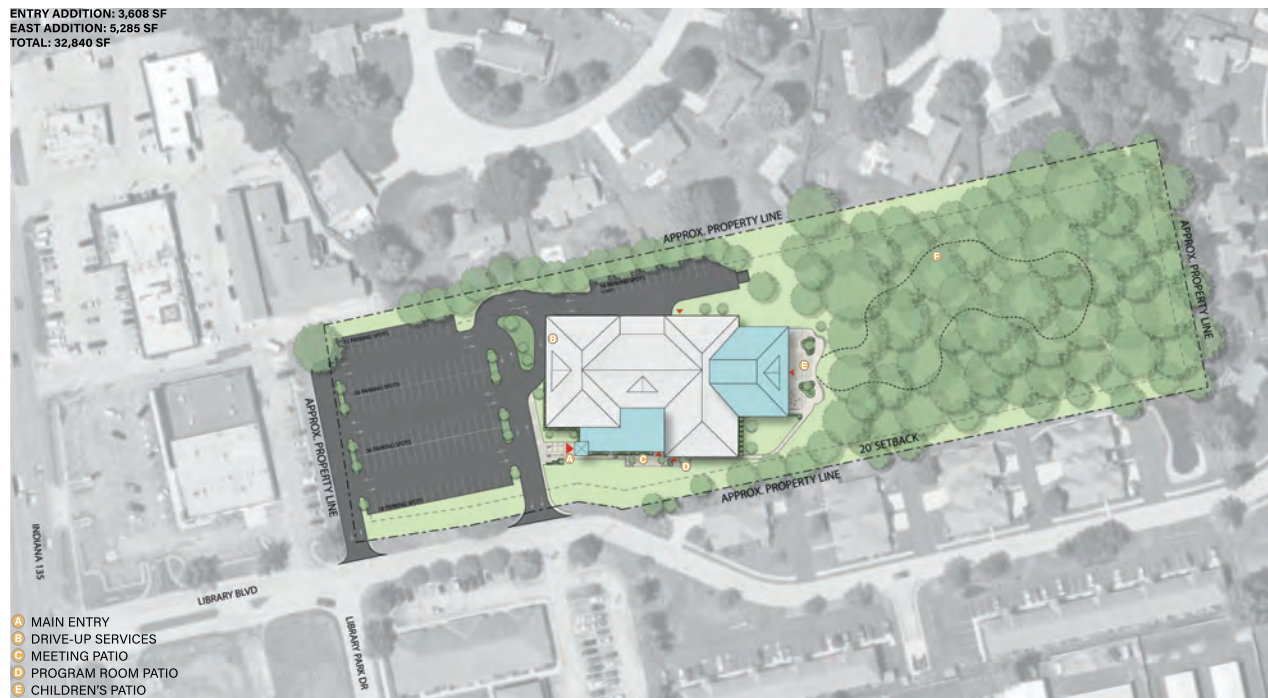

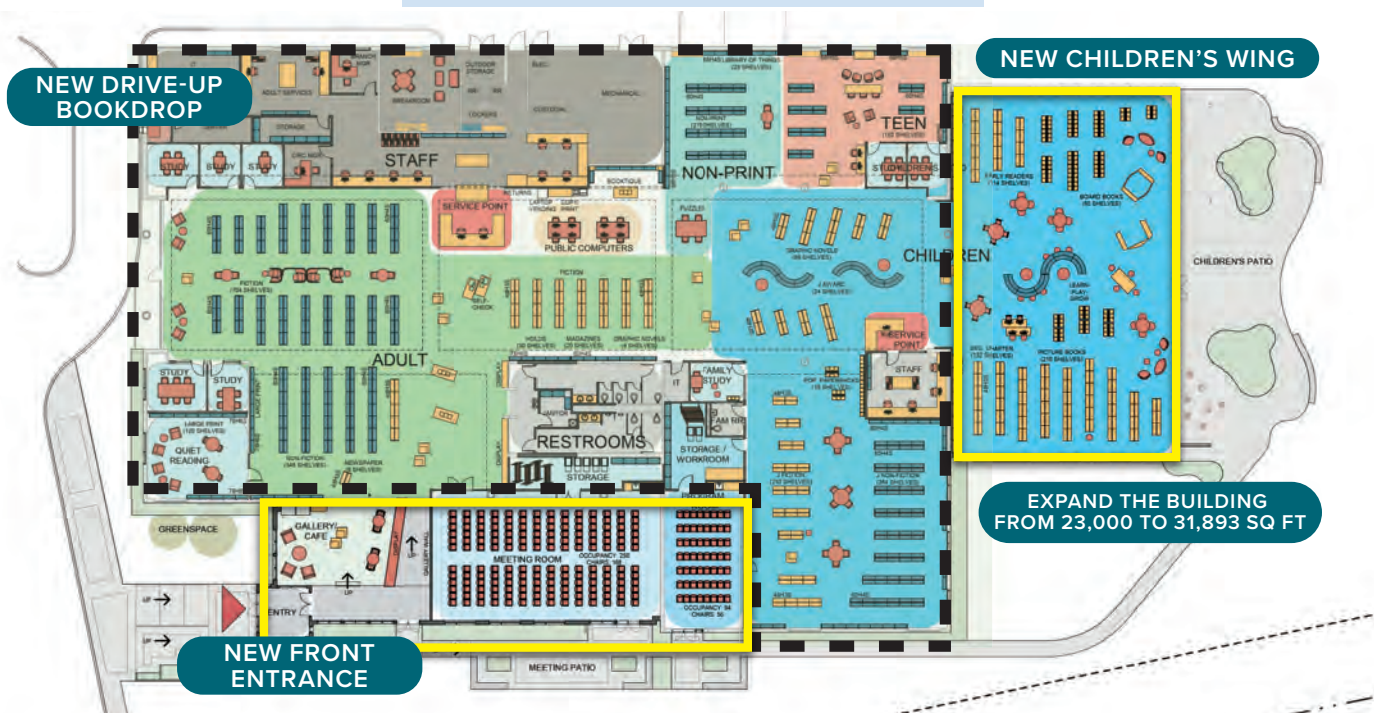

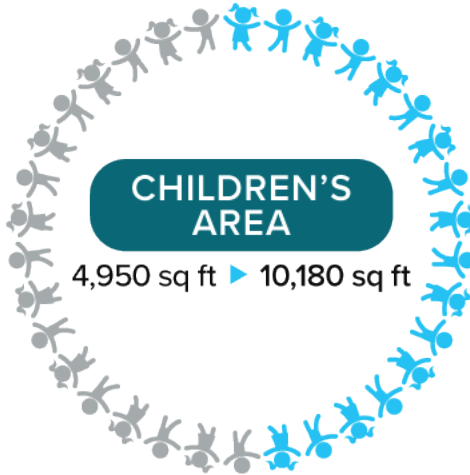

JCPL considered the option of purchasing land and relocating. It was deemed too costly at an estimated \$31,250,000 for a 30,000 sq ft new building.

The renovation and expansion will preserve a 40-year investment and create a library designed to serve the White River Township community for the next 40 years.

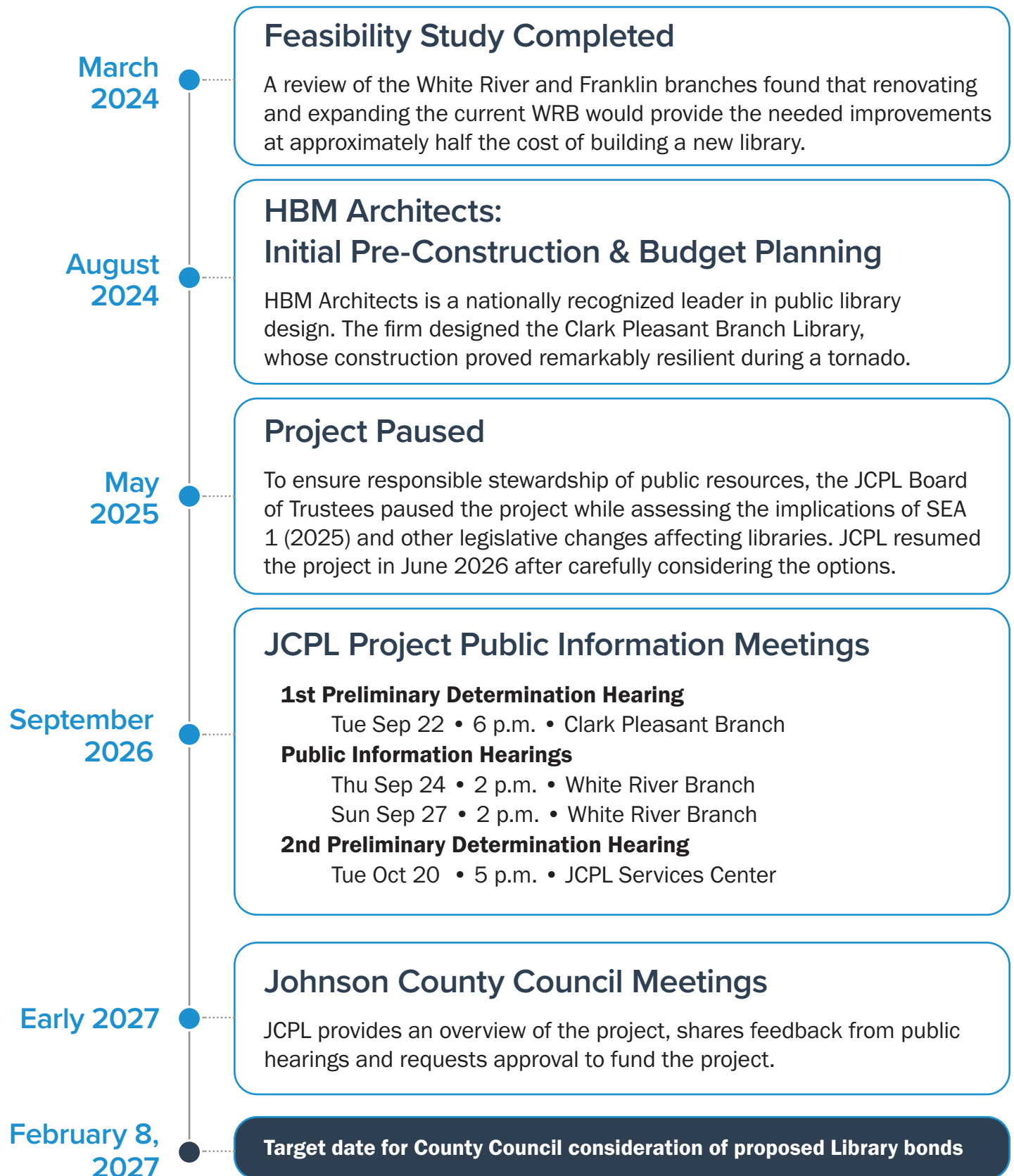

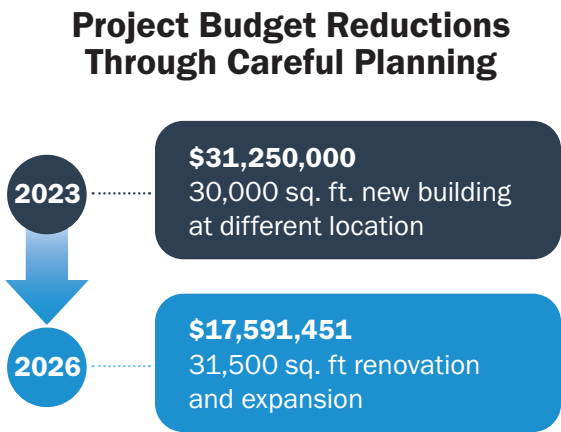

Balancing Community Needs with Responsible Spending

White River Branch Renovation & Expansion Project Costs (assumes a fall 2026 start)	
Renovation, expansion and other related costs	\$17,591,451
Minus JCPL's savings toward the project	-\$6,000,000
Total financing required (General Obligation Library Bond)	\$11,591,451



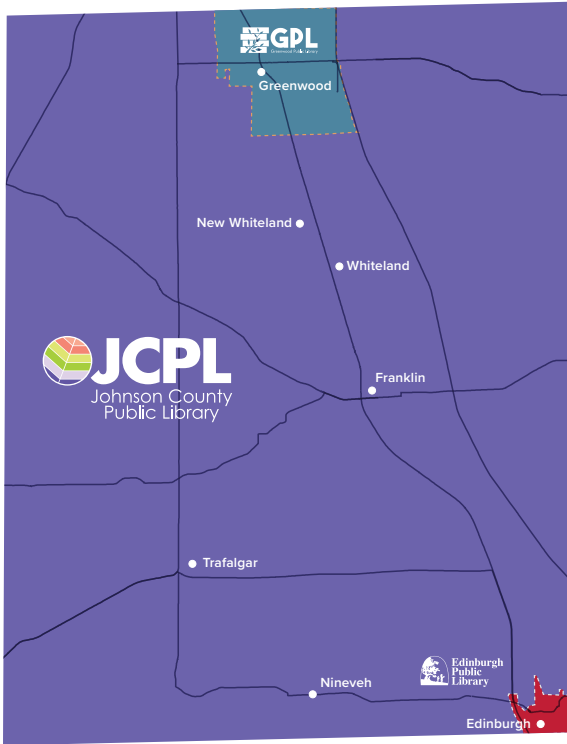
Through careful stewardship of taxpayer funds, JCPL has \$6 million in savings to commit to the project, reducing the library bond need to \$11,591,451.

HOW CAN THE LIBRARY FUND THIS PROJECT WITHOUT INCREASING TAXES?

If approved by the Johnson County Council in early 2027, the Library would replace its current bond (a type of loan) with a new one as the existing debt for the Clark Pleasant Branch is paid off. This allows the project to move forward within the Library’s current budgeting.

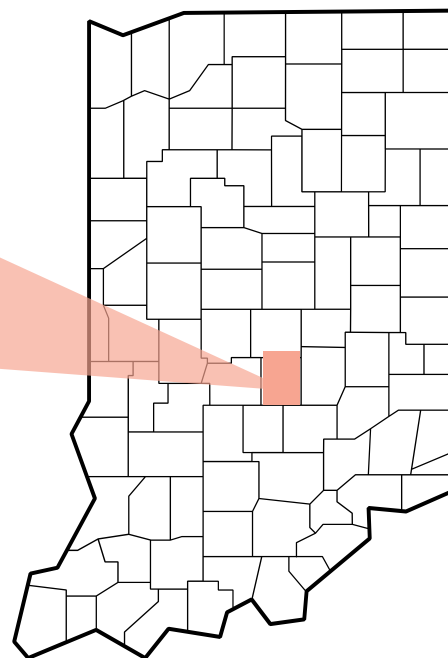


OUR STRENGTHS
