

2014 Legislative Update

The Indiana General Assembly adjourned *sine die* on March 14, 2014, with members of the General Assembly returning home to their legislative districts — many of them preparing for re-election in November. This session was a "short," non-budget session, meaning legislators did have to deal with state financing. While issues such as preschool vouchers, business tax cuts, mass transit and day care were at the forefront of discussion, several health-related matters will become law. All of the items on IAFP's legislative agenda became law, and the IAFP was also able to encourage the tabling of issues that could negatively impact family medicine.

Regulating Prescribing

Notably, efforts to make tramadol a Schedule III drug were **tabled** this legislative session. During legislative hearings, IAFP expressed concern with moving too aggressively on regulating pain management. IAFP indicated general support of efforts to curb prescription drug abuse but noted that scheduling tramadol may have unintended consequences and lead to the undertreatment of pain. IAFP's message resonated with members, and this language was shelved for the rest of the session.

Several legislative attempts to schedule or make ephedrine/pseudoephedrine legend drugs were unsuccessful. IAFP testified against these efforts. But it should be noted, this issue may be a hot topic during the 2015 session.

Public Health

Two bills backed by IAFP's Commission on Legislation will become law. Senate Enrolled Act (SEA) 50 will prohibit a person less than 16 years old from using a tanning device at a tanning facility. SEA 245 will allow health care providers with prescriptive authority to prescribe auto-injectable epinephrine to a school or school district and allow certain individuals employed by the school to fill, store and administer the drug. The bill also provides civil immunity to the school employees and health care providers.

As introduced and backed by the attorney general's office, SEA 408 would have set an inadequate clinical definition of neonatal abstinence syndrome (NAS) in Indiana law and would have mandated that hospitals screen and report instances of NAS without any mechanism for payment or reimbursement. During legislative discussions, providers educated legislators on the complexity of the NAS issue, and the legislation was scaled back to allow stakeholders the opportunity to review several important issues related to NAS and report to the General Assembly by November of this year. The workgroup will develop a standard clinical definition for NAS and a process for identifying NAS; identify the time and resources needed for hospitals to develop and implement NAS protocol; review existing and new data-reporting mechanisms; and identify whether payment methodologies exist, or are needed, for identifying and reporting NAS. Dr. Andy Shull is participating on the NAS workgroup on behalf of IAFP. We can expect legislation to result from the findings of this workgroup.

INSPECT Expansion

House Enrolled Act 1218 initially required all legend drugs to be reported into INSPECT by July 1, 2015. The legislation was modified and now requires the Professional Licensing Agency to study and report by October 1, 2014, on various issues relating to an INSPECT expansion. Among others, the issues include: the impact of including all legend drugs in INSPECT; an analysis of security concerns related to patient and provider privacy; and regulatory impact analysis and a fiscal impact analysis.

Health Care Delivery Reform

House Enrolled Act 1258 will require the Medical Licensing Board to establish a pilot program before August 1, 2014, for physicians to provide telehealth services to patients without an in-person patient/physician relationship. The MLB will set standards and procedures for physicians to follow when treating patients in the pilot program. IAFP has submitted an official request to the MLB seeking the opportunity to participate as a stakeholder in the discussions.

Scope of Practice

Senate Enrolled Act 233 will provide for the licensure of a new provider type — an anesthesiologist assistant (AA). In addition, this bill will provide licensure of diabetes educators and recognize certified registered nurse anesthetists (CRNAs) as advanced practice nurses. The MLB has solicited input from IAFP on the AA and diabetes educator regulations.

Tips from Our Medicare Payment Consultant



Confused About Medicare Preventive Visits? So Are Your Patients!

Congress legislated coverage for two preventive visits for Medicare beneficiaries:

- Initial Preventive Physical Examination (IPPE), also referred to as the Welcome to Medicare Visit
- Annual Wellness Visit
 - Initial
 - Subsequent

Even though these services have been covered for several years, physicians continue to have questions about who is eligible for a Medicare-covered visit, what services are included in the visit, who can perform the visit, etc. Given all the questions surrounding these visits, we were asked to provide information about each visit.

Medicare Part B Eligibility

While Medicare Part A is typically premium-free to anyone eligible for Social Security or railroad retirement benefits or anyone who would be eligible for such benefits if the worker's quarters of coverage (QC) from government employment were regular Social Security QCs, Medicare Part B is voluntary, and a beneficiary may refuse enrollment because the beneficiary is required to pay a premium for the coverage.

Depending on the beneficiary's circumstances, e.g., continues active employment and is covered under the employer's group health insurance, a beneficiary may choose to delay enrollment in Medicare.

The effective dates for Parts A and B are noted on the beneficiary's Medicare card. This information is also included on CMS Secure Net Access Portal (C-SNAP), the Wisconsin Physician Services (WPS) eligibility, patient information and claims data.

Coverage for the IPPE and AWV

All new Medicare beneficiaries who are within the first 12 months of their first Medicare Part B coverage period may get an IPPE. Thus, if a beneficiary enrolled in Medicare in June 2013, the Welcome Visit must be performed no later than May 31, 2014. This is a one-time benefit.

Medicare covers an AWV for beneficiaries who

- Are not in the first 12 months of their first Part B coverage period
- · Have not received an IPPE or AWV within the past 12 months

At least 11 months have passed following the month in which the IPPE or the last AWV was performed and billed to Medicare.

Medicare pays for only one initial AWV per beneficiary per lifetime and pays for one subsequent AWV per year thereafter.

Members can access C-SNAP to confirm the date when the patient is eligible for their next AWV.

The IPPE is meant to be an introduction to Medicare and covered benefits. The intent of the both visits is to help Medicare beneficiaries stay well. Physicians should focus on health promotion and disease prevention and detection.

Joy's first recommendation is to always use the term "visit." Never refer to these preventive visits as an "examination."

Deductible and Coinsurance/Copayment

Medicare waives both the co-insurance/co-payment and the Medicare Part B deductible for the IPPE and AWV. Thus, the patient has no out-of-pocket expense for these services

Who May Perform the Preventive Visit? *IPPE*

Either a physician (a doctor of medicine or osteopathy) or a qualified nonphysician practitioner (a physician assistant, a nurse practitioner or a certified clinical nurse specialist) must furnish the IPPE.

The provider performing the IPPE must be shown as the billing provider on the claim (Item 24j or its electronic equivalent). Services performed by a qualified nonphysician practitioner cannot be billed by the supervising/collaborative physician because "Incident to" rules are not applicable.

AWV

A health professional can perform the IPPE. For purposes of the AWV, this term includes:

- A physician (a doctor of medicine or osteopathy)
- A qualified nonphysician practitioner (a physician assistant, a nurse practitioner or a certified clinical nurse specialist)
- A medical professional (including a health educator, a registered dietitian, a nutrition professional or another licensed practitioner), or a team of such medical professionals who are working under the direct supervision of a physician (physician must be physically present in the office, but is not required to have a face-to-face encounter unless the physician is practicing in a Rural Health Clinic)
