Mark H. Ebell MD, MS is a Professor in the College of Public Health at The University of Georgia. Dr. Ebell is Deputy Editor of American Family Physician and Editor-in-Chief of Essential Evidence. He is a graduate of the University of Michigan School of Medicine, a former RWJ Generalist Physician Faculty Scholar, and is former editor of the Journal of Family Practice. Dr. Ebell is author of 9 books and over 500 peer reviewed articles. From 2012 to 2016 he was a member of the USPSTF, and in 2019 he was a Fulbright Scholar at the Royal College of Surgeons in Ireland.



**Gary Ferenchick, MD, MS** is Professor of Medicine at Michigan State University College of Human Medicine, where he practices general internal medicine and is deeply involved in MSU-CHM major curriculum renovation. He earned his master's degree in human nutrition and medical degree from Michigan State University and completed his residency training in internal medicine at Michigan State University College of Human Medicine, where he has been a faculty member for over 25 year. Dr. Ferenchick is a Past-President of the Clerkship Directors in Internal Medicine. His research interest is the interface between medical education and information technology.



**Kate Rowland, MD, MS, FAAFP,** is an Assistant Professor at Rush Medical College and faculty at the Rush Copley family medicine residency. # Town Hall Meeting: The State Of Health In Indiana - Lindsay Weaver, MD, FACEP

Hear the latest developments on the many pressing issues that the IDOH is focusing on.



As chief medical officer for the Indiana Department of Health (IDOH), Dr. Weaver provides clinical input and support to all agency divisions. She joined IDOH as chief medical officer Feb. 3, 2020. She immediately jumped into the role, helping to lead the state's pandemic response by spearheading the development of the statewide lab testing network to expand COVID-19 testing capacity in Indiana. Dr. Weaver also led the statewide distribution of COVID-19 vaccines and therapeutics.

Dr. Weaver is also an assistant professor of clinical emergency medicine at the Indiana University School of Medicine and continues to practice emergency medicine at Methodist Hospital in Indianapolis. She is board certified in both emergency medicine and hospice and palliative care medicine.

She earned her undergraduate degree in biology at the University of Kentucky and graduated from the University of Louisville School of Medicine. She received residency training in emergency medicine and fellowship training in hospice and palliative medicine at Indiana University School of Medicine, and she completed a fellowship in ethics at the Charles Warren Fairbanks Center for Medical Ethics at Indiana University Health.

She also chairs the Indiana Commission for Women.

Innovative Approaches to Address Agitation in Alzheimer's Disease - Thomas W. Heinrich, MD

#### **Learning Objectives:**

• Summarize the impact of agitation on individuals with Alzheimer's disease, their caregivers, clinicians and the healthcare system.

Thomas Heinrich, MD, Professor of Psychiatry and Family Medicine at the Medical College of Wisconsin (MCW), completed a combined residency in psychiatry and family medicine. He is board-certified in family medicine and general adult psychiatry and holds subspecialty certification in consultation-liaison psychiatry and neuropsychiatry. In these roles, he has collaborated with multiple stakeholders to develop and implement several innovative cross-disciplinary and inter-institutional clinical programs.

**Dr. Anna Chodos** is an Associate Professor of Medicine in the Division of General Internal Medicine at Zuckerberg San Francisco General and the Division of Geriatrics, both within the Department of Medicine at UCSF. Her clinical work is in outpatient specialty care in geriatrics and dementia care. Her academic work is focused on understanding the unmet needs of older adults who are seen in primary care in the safety net, especially those who are living with dementia. She is the Executive Director of Dementia Care Aware, a state-wide program to improve detection of dementia in older adults who have Medi-Cal benefits. She is also Co-Principal Investigator of the Geriatrics Workforce Enhancement Program, which is training health care providers and social service providers in geriatrics principles. Clinically, she is director of two clinics: the outpatient Geriatrics Consult Service and the Geriatrics-Neurology Cognitive Clinic at Zuckerberg San Francisco General Hospital.

After his USN commission, Dr. King became ABFM certified in Family Medicine after his residency at Navy Hospital Pensacola. He has received multiple awards including Chief Resident and Resident Instructor of the Year and has served as an active-duty family medicine doctor as the Senior Medical Officer in Diego Garcia, as well as an instructor at the Interservice Physician Assistant Program. Following the Navy, Dr. King continued his family medicine career while serving as a consultant and speaker for multiple pharmaceutical companies focused on the diabetes space. He has also published several peer reviewed original research articles, literature review articles and real-world clinical research articles.

Dr. Gary LeRoy serves ABFM as the Senior Vice President of Diplomate Experience.

Previously, Dr. LeRoy was an associate professor of Family Medicine at Wright State University Boonshoft School of Medicine in Dayton, Ohio. He served as East Dayton Health Center's Medical Director from 1992 to 2007 before joining the faculty of Wright State University Boonshoft School of Medicine where he served as Associate Dean of Student Affairs and Admissions for 14 years (2008-2022). He also served on the Miami Valley Hospital Board of Directors from 1997 to 2006.

Dr. LeRoy has shown love and loyalty to the city of Dayton in many ways since his career began. Beginning in 2008, he continued his clinical practice by serving patients at the East Dayton Community Health Center, a federally qualified health center. Dr. LeRoy is a past board chair of The Dayton Foundation, Public Health Dayton/Montgomery County, and Hospice of Dayton. Additionally, he has served as the Chief Medical Consultant for Dayton Public Schools since 1997.

Dr. LeRoy has had significant national leadership experience as the President-Elect, President and Board Chair of the American Academy of Family Physicians from 2018 to 2021. He is an active member of the Alpha Omega Alpha Honor Medical Society, the Ohio State Medical Association, the American Medical Association, the Ohio Academy of Family Physicians (Past President), and the Phi Rho Sigma Medical Society (Vice President).

Over the last 30 years, Dr. LeRoy has been recognized for his work through numerous awards at the state and national levels. These include the Wright State University Outstanding Alumni Achievement Award, a Certificate of Recognition by the Ohio House of Representatives and Ohio Senate, the American Association of Medical Colleges Humanism in Medicine Award, the National Council of Community and Justice Humanism Award, the American Medical Student Association Golden Apple Teaching Excellence Award, and both the Educator of the Year and Philanthropist of the Year awards from the Ohio Academy of Family Physicians. He is also an award-winning book author – Quotes From The Edge of Nowhere (2020).

Dr. LeRoy completed his medical degree at Wright State University before moving on to Dayton's Miami Valley Hospital for residency and then a fellowship at Michigan State University in 1992.

Matthew DuPre, MD, is an associate director at Memorial Family Medicine Residency Program in South Bend. Dr. DuPre is also an Adjunct Clinical Assistant Professor of Family Medicine at Indiana University School of Medicine. After graduating from medical school at Indiana University School of Medicine, he completed his residency at Memorial Family Medicine Residency. After graduation from residency, he worked in a busy rural Indiana full-spectrum practice. During this time, he had many medical students and family medicine residents train with him, further expanding his passion for medical education. Dr. DuPre joined the Memorial faculty in 2019. He is currently working as Memorial's nursing home medical director and coordinator for their geriatric curriculum.
