EMPLOYER IMPACT

A study conducted by the IU Public Policy Institute and Early Learning Indiana calculated the effects of inadequate child care options resulting in work disruptions such as employee absences and turnover. These disruptions impact the bottom line of businesses, the local economy, and tax revenue. The lack of access to child care costs Montgomery County businesses \$7.9 million annually.



Two out of 3 employers and over half employees rated child care as a top three issue.


"I would like to see more accredited childcare. I think we're missing opportunities for professionals to live in the community, because we don't have the quality of child care that they expect for their children." - Employer


AFFORDABILITY

"Licensing doesn't matter as much as trust which can be hard when you don't know anyone."




A single parent living in poverty would have to dedicate almost half (47%) of their income in order to access highquality child care for just one child.

Single-parent families whose income is twice the poverty level would still have to set aside **almost a quarter (23%)** of their income for child care.

Both of these scenarios show that Montgomery County parents are paying more than the nationally recommended 7% of their income on child care.

PRIORITIES & BARRIERS

Access to early childhood education for all children is dependent on a large enough workforce to meet the demand. In 10 years, the early childhood education workforce is projected to grow slightly to 85.

However, with an estimated 30% turnover rate, the projected need of the workforce in Montgomery County will be 111.
