About Dave Westol

The award is named in honor of David L. Westol, Beta Zeta / Michigan State 1973, who has devoted a good deal of his volunteer and professional career to the health, safety, and protection of fraternity and sorority members. After graduating from Michigan State in 1973, Dave worked for his alma mater as Assistant Director of Student Activities and Advisor to Fraternities. He was admitted to the Michigan Bar in November 1979 and became an assistant prosecutor for the Office of the Prosecuting Attorney in Kalamazoo County, Michigan.

From 1975-1980, Dave served as a Regional Counselor for Theta Chi before being elected to the Grand Chapter and as National Vice President in 1980. He remained in that role for the maximum two terms in 1988. In December of that year, he was named the Fraternity's Executive Director and held that position for 18 years. Today, he is the founder, owner, and CEO of Limberlost Consulting.

Westol's interfraternal career is equally impressive. He was elected to the board of directors of the Fraternal Information and Programming Group (FIPG) in 1993 and has served continuously on the board since that time. He has also served FIPG in the roles of Director of Policy Interpretation and more recently as administrator. In July 1998, he was elected to the Fraternity Executives Association (FEA) board of directors and served as president from 2002-2003. He has also served on the board of directors for HazingPrevention.org and Gamma Sigma Alpha and on the Association of Fraternal Leadership and Values (AFLV).

Dave has become a ubiquitous figure at fraternity and sorority leadership development events. He has performed his signature anti-hazing presentation "Hazing on Trial" over 1,800 times since 1981 and has spoken on more than 460 campuses and at over 300 Greek leadership events. Dave has served as a faculty member for AFLV Central and West, the Northeast Greek Leadership Association, the Southeast Interfraternity Conference and the Fraternal Risk Management Trust, (FRMT) Inc. From its first session in the early 1990s through 2010, he was a faculty member for "Risk Management on the Road," an annual workshop for women's national fraternity and sorority consultants.

In 2012, Dave was named a recipient of the North American Interfraternity Conference's Gold Medal, the most prestigious honor in the interfraternal world. Brother Westol is one of only four Theta Chi members to have received the Gold Medal. In addition, he has received the Distinguished Service Award from Theta Chi which is the most significant honor in the Fraternity. Dave has also received three Alumni Awards from the Fraternity.

About the David L. Westol Sacred Purpose Award

Presented annually, this award goes to the chapter that most exemplifies the spirit of Sacred Purpose. A first runner-up may be considered based on merit.

Launched in the fall of 2013, Sacred Purpose is our modern expression of our motto— the Assisting Hand. Sacred Purpose offers programmatic support at the chapter and international levels that concentrates specifically on seven different health and safety topics that affect today's collegiate men: Drug Use and Abuse, Fire Health and Safety, Hazing Prevention, Recognizing Signs of Depression, Responsible Alcohol Use, Sexual Misconduct Prevention, and Suicide Prevention and Intervention.

All active chapters and colonies are eligible to apply for the David L. Westol Sacred Purpose Award on a form specified by the Chief Executive Officer.

Essential items for consideration:

- List of health and safety related guest speakers and program topics
- List and description of campus-wide events/programs, including outcomes
- List of local health and safety partners
- Testimonials from students and partners
- Letters of recommendation from campus health and safety professionals
- Letter of recommendation from Health and Safety Adviser
- Photos and/or video

Applicants for the award are nominated by the International Headquarters staff. Final approval of the award winner(s) will be confirmed by the Sacred Purpose Committee or the Grand Chapter.

The award(s) will be presented at a time and manner determined by the Grand Chapter. Whenever possible, the award shall be presented in the presence of the International President, Chief Executive Officer, appropriate staff members involved with Sacred Purpose, and/or David L. Westol.

Application Procedures

David L. Westol Sacred Purpose Award applications must contain accurate and up-to-date information regarding the chapter's/colony's performance during the 2020/2021 academic year. Inaccurate information will serve as a basis for disqualification.

1. All applications must:
 - Be submitted in either .doc or .pdf format; paper applications will not be accepted
 - Use standard 8 ½" by 11" paper size with one-half inch margins and 12-point Times New Roman font
 - Include a title page with the chapter/colony designation, the name of the college or university, and "David L. Westol Sacred Purpose Award Application 2020/2021"

 - Provide a letter of recommendation from your Health & Safety Adviser. Letters of recommendation for your chapter can be emailed to awards@thetachi.org or mailed to the International Headquarters.

- Submit photos or videos that demonstrate the scope of Sacred Purpose and its helpfulness to your chapter/colony and your campus community. Photos should be included in the application and properly labeled/identified. Videos should be hosted on YouTube with specific links provided in the application and properly labeled/identified.
3. Please email the completed application as one attachment to awards@thetachi.org. Do not mail a hard copy.
 4. While there is no specific word or page limit, the selection committee asks that you be as concise as possible when addressing each individual section. Should the committee need more information, it will be requested from you.
 5. To qualify for the David L. Westol Sacred Purpose Award, all sections must be completed. Leaving one or more sections incomplete will render the chapter ineligible for consideration.

Applications must be received by Saturday, April 10, 2021.
