

ERIC RIEKE

When DeKalb Memorial Hospital opened its doors on January 2, 1964, it was the culmination of tremendous efforts by many individuals throughout the community. In 1955, the Auburn Lions Club began considering whether DeKalb County could support a new, more modern hospital. Interest grew and, as a result, a petition was circulated asking for more information. Judge Harold J. Stump formed an eight person board charged with discovering details on building and operating a medical establishment.

A key role was played by Glenn Rieke of Rieke Corporation, who led the board that oversaw the planning, fundraising and construction of the project. "Despite its enormity, the task suited him well," recalls his son, Eric Rieke. "He had wide experience of expanding Rieke operations throughout North America and around the world, so he understood how to manage both professional and volunteer entities to accomplish the goal."

### CONSTRUCTION TIMETABLE IS ON SCHEDULE AT THE DEKALB MEMORIAL HOSPITAL SITE



The construction timetable for the DeKalb Memorial Hospital at the east edge of Atlanta is on schedule.

The aerial photograph of the site shows progress on construction of the big facility that will be ready for occupancy in the fall of 1960.

Hospital Administrator Robert O. King and the president of the hospital board of directors, Glenn T. Hicks, reported today that completion of the roof slab is scheduled by the end of October.

**Hospital Timetable**

The timetable calls for installation of windows and brick walls by December 1. By that date, the outside work on the hospital building will be completed sufficiently to permit work on the inside to progress through the winter months.

Mr. King said the big boilers for heating the facility are on the building site and will be installed to provide temporary heating during the winter construction period.

The boilers, along with the air-conditioning units, are scheduled for installation next week.

Hospital officials also reported today that the follow-up advertising campaign is in progress. It is being handled, principally through payroll deductions in its course.

At the Sept. 21 meeting of the board of directors, the following resolution was adopted:

"It is resolved by the Board of Directors of the DeKalb Memorial Hospital, Inc., in a meeting assembled this 21st day of September, 1960, that recognition be given Carter L. Roper for the time and effort spent in reviewing the pledge cards for the hospital follow-up campaign.

"Mr. Roper graciously accepted this responsibility and went many hours at the tedious task. The board's appreciation is hereby recorded in the permanent records of this corporation."

**Financial Report Given**

Mr. King reported today that receipts from pledges in the public subscription campaign through Sept. 30 amounted to \$1,879,427.76.

A big slice of the receipts to date came from the pledge of the late William H. Wilkerson of Atlanta. Collections from the Wilkerson pledge to date amount to \$115,000. Sale of remaining shares of Lincoln National Life Insurance stock is expected to approximate \$90,000.

Mr. Wilkerson's original pledge of 1,000 shares of Lincoln National Life Insurance stock was valued at the time the gift was made at \$220,000. A 2% for one stock split increased the number of the shares to 2,000.

The hospital will receive an estimated \$100,000 increase in the value of the original gift.

**\$254,850 to Contractors**

The financial report shows that approximately \$254,850 has been paid to date in contracts.

A total of \$598,000 has been transferred to the DeKalb County Community Memorial Hospital Foundation, Inc.

Beginning pledges amounted to \$1,505,745.32. New pledges total \$396,549.39 for a total in pledges of \$1,902,294.71.

Resolutions to be collected in pledges is \$715,425.34.

The foundation reported receipts on Sept. 30 of \$712,200.49. In addition to the \$396,000 transferred by the hospital to the foundation, amount of \$14,300.49 was reflected. Of the receipts, \$120,000 is in U.S. Treasury bills and \$196,110.49 in cash on deposit.

Glenn was proud of the fact the project proceeded as a not-for-profit operation. When the board presented its recommendations, they were against having a hospital that was county funded and operated, as during their due diligence they observed that government operated hospitals were vulnerable to political infighting. Of course, this meant that the fate of the project rested on whether sufficient financial support could be generated.

As it turned out, the community rallied around the hospital's fundraising efforts. Volunteers from around the county packed the McIntosh High School gymnasium, and there was huge momentum as they worked to gather donations of all sizes.

"It was remarkable how the community assumed ownership of the project from the very beginning," said Eric. "It was called the 'Miracle of Indiana,' the true miracle being how united and determined our community was in making the dream come true."


Today, 50 years later, we can still marvel at the accomplishment that DeKalb Health represents. "There's an enormous legacy here," concluded Eric. "People still take great pride in having a hospital right here in our community that was built just for us."

## JAYNE MCCLELLAN

Jayne McClellan was on the nursing staff from the very first day of the hospital's opening, having completed her training at the Lutheran Hospital School of Nursing in Fort Wayne.

For more than 30 years, she was on the front lines as an Obstetrics and ER nurse, and she experienced countless changes as the hospital modernized and expanded.


"When I started out, we wore traditional starched-white uniforms and caps, and we always stood up whenever a doctor came into the room," said Jayne. "The nursing staff was much smaller than it is today, and we all worked in a variety of places throughout the hospital – helping out wherever it was needed." Jayne spent many evenings in the emergency room at a time when there was no EMS service in DeKalb County. "We often had no advance warning when patients would arrive, and we were relied on to stabilize them while a physician or surgeon was quickly summoned. Even with our limited staff in the evenings, I know there were many lives saved with our early intervention."

While many things evolved over the years at DeKalb Health, for Jayne, one thing remained constant. "Being in a smaller community made it more personal. We knew many of the families who came in for emergency care or to have a baby, and it truly felt like we were taking care of our neighbors." Indeed, nurses like Jayne have helped forge a strong bond between the hospital and the community over the years, for which we are grateful. "Every day certainly had its challenges," said Jayne, "but I loved it."


## BETTY CARBAUGH

When the hospital opened, it became known as the 'Miracle of Indiana' due in part to the fact that so many people in the community supported the effort, making donations of all sizes that totaled nearly \$2.5 million.

To this day, individuals and businesses across the area are generous in their support of DeKalb Health through participation in a wide range of events.

In 1985, the hospital launched the first annual DeKalb Memorial Hospital golf tournament fundraiser. Betty Carbaugh, who with her husband owned Carbaugh Jewelers in downtown Auburn, was the overall winner for the women. "It was an outstanding event," said Betty, "and most importantly, it raised more than \$5,000 to help support the hospital." For 29 years, the Charity Golf Outing has continued to grow, and this year, proceeds provided scholarship assistance to 19 local students who are pursuing a degree in the healthcare field.

"It is a big asset to DeKalb County and the surrounding area to have a hospital," said Betty. "It's wonderful to have it so close, especially in times of emergency. And just as the community has participated in raising funds to support the hospital, DeKalb Health has in turn done its share in giving back to the community."



### J. ROBERT EDWARDS, MD

Throughout the hospital's many changes over the past 50 years, a constant has been the quality and dedication of its physicians. Dr. John Robert Edwards came to DeKalb Health in 1967 following service as a surgeon in Vietnam and after completing his residency in San Francisco. "My wife and I came here to help out temporarily with my father-in-law's family practice, and we ended up putting down roots," explained Dr. Edwards.

"In the early days, we had limited surgical facilities, but I was fortunate to have a great team, and we performed a wide range of procedures. We had a strong commitment to taking care of our patients and simply doing what needed to be done," said Dr. Edwards. "In fact, the people were always what made this hospital great," he continued. "We attracted outstanding doctors who were willing to get up in the middle of the night, if needed, to take care of their patients."

Throughout his career, Dr. Edwards played a role in much of the progress in medical care that has taken place at the hospital, having served as Chief Surgeon, Chief of Staff and on the Board of Directors. "As I look around, I'm proud of the level of sophistication we have here today," he said. "This is a very valuable healthcare resource for our community."

Dr. Edwards retired from DeKalb Health in 1997, but he never slowed down. He worked at Parkview Hospital, earned an MBA degree and resumed a part-time surgical practice at DeKalb Health with Jeffrey Justice, MD. Although he retired again in 2006, he continues to take care of patients at St. Martin's Healthcare. At age 80, Dr. Edwards is still doing what needs to be done.

## JEFFREY TURNER

Long-time DeKalb Health Foundation board member and community leader Jeff Turner has helped guide the Foundation as its role has evolved over the years. "The Foundation was started with the funds that remained after the hospital was completed," explained Jeff, "and for the first 20 years, it served primarily in a caretaker role in receiving bequests and modest donations."

In the 1980s, the Foundation expanded its ability to provide meaningful support to DeKalb Health when it received a \$1.5 million gift, and from that time, funds from the Foundation have been used to expand or equip the hospital. "More recently," said Jeff, "a new generation of Foundation board members have asked the question of where do we go in the next 50 years." This led to the decision two years ago that the hospital and Foundation would jointly fund the position of Foundation Director, and it paved the way for a wide range of fundraising opportunities to support the hospital as it makes capital improvements and expands healthcare services.

"Today, the DeKalb Health Foundation has a broader mission that is designed to help the hospital remain an independent, world-class healthcare provider," said Jeff. "It's about carrying on the commitment of so many in our community who came before us, and it's about ensuring the quality of life in our area for generations to come. After all, this is our hospital. We built it, and it's up to us to help it thrive."

**Message from the Auxiliary Guild President**

The DeKalb Health Auxiliary Guild experienced another exciting year. I would like to begin by thanking our tireless volunteers for all their service on behalf of the hospital. In 2013, we had 75 active volunteers who provided 18,355 volunteer hours.

Auxiliary volunteers play an important role in ensuring a quality experience for both patients and visitors to DeKalb Health. They provide an invaluable service in way-finding, staffing patient and family hospitality needs at the reception and information

desks, through their assistance in the Surgery waiting area and the Family BirthPlace, and as clerks in the Serendipity Gift Shop. The Auxiliary volunteer organization owns and operates the Curiosity Shop thrift store in downtown Auburn as their major fund-raising effort. I would like to give a special recognition to Nita Webb, Volunteer Coordinator, for her outstanding service as staff liaison to DeKalb Health.

This past year, the Auxiliary donated \$23,000 to the hospital for the remodeling of the outpatient clinic, including new furniture, carpeting and paint. We also made a donation of nearly \$8,000 for the purchase of new televisions in the Family BirthPlace. In addition, we were pleased to be able to fund three scholarships of \$1,000 each to college students

who are residents of DeKalb County and are pursuing studies in a healthcare field. The Auxiliary also spent \$1,200 to provide a small gift for each newborn in the Family BirthPlace.

As we celebrate the hospital's 50th anniversary it's a great opportunity to look back. The Curiosity Shop opened its doors in 1966 and has been in continuous operation. Most importantly, the Auxiliary Guild has provided DeKalb Health with nearly \$500,000 in donations over the past five decades.

In October, I handed the reins to incoming president Pat Lumpkins. It has been a privilege to lead the Auxiliary Guild for the past two years, and I know it will be in good hands as we set off toward the next 50 years.


