



would have a much tougher retirement future. The emails, calls, contacts and letters from members make the difference in the legislature. Legislators know educators vote, especially retired ones. Members of the House of Representatives continue to champion our stipend, or "13th check". This upcoming year we hope they will support and push through a Cost Of Living Adjustment into the budget. We will be going onto our ninth year without a COLA. Our pensions are not keeping up with inflation or the rise in prices for food, utilities, medicine, health care and other life necessities as all of you know. As we wait on the election in November, many of the same legislators will be in place making it a very tough battle to push through a COLA this next year. Your advocacy with your local legislators will be critical.

Our budget finished in the black for the third consecutive year and eight months into this year's budget we are trending in the black and expect this trend to continue. This year's upcoming budget that we hope you approve is about the level as the 2011-12 budget. We have streamlined cost on our insurance, auditing, printing services, while adding value and benefits to our members. This upcoming year we will be renegotiating two big items. One being our office lease and the other being our contract with AMBA.

Our members once again volunteered and served over a million volunteer hours in their communities. This makes it 11 years in a row of over a million hours of volunteer work and service given back to the state! Our volunteer hour's value is greater than the "13th check" by over a couple million dollars. Please feel free to let your local legislators know that fact. Those hours are only the recorded hours, I believe we could double that amount if everyone recorded and turned in their hours.

The IRTF's Active Teacher Grant program this past fall was a huge success. They had 128 grant applications and were able to award 29 grants across the state. The Future Educator Scholarship awarded 10 scholarships this past year to college juniors and seniors pursuing an education degree. The Hand UP grants are available to our members in need. The Foundation is aggressively seeking grants and has a grant writer searching and writing for grants that will enhance their mission. All IRTF programs have applications posted on our website under the Foundation tab. The applications can be downloaded or filled out online.

Our Strategic Planning Committee has been meeting regularly and are looking at many ideas to help drive our association forward into the future. They will be investigating potential changes to the Representative Assembly to make it more of a conference style. Some of our committee structure may change with new or added responsibilities. Our board has an ad-hoc committee that will be charged with reviewing our by-laws, policies, and guidelines. This committee will bring recommendations to the board so they can update each area making them more responsive to association needs. Next year you will be voting on the updated by-laws.

We are continually looking for ways to serve you and enhance the benefits that we have available. We will have a new membership incentive program for our members to reach out to potential new members. If you sign up 5 new members you will receive a \$25 gift card. The member who signs up the most by next April will receive a \$100 gift card. IRTA is the best kept secret in the state, let's change that this year and make this the year of the "Retired Teacher" as we celebrate Indiana's Bicentennial.
