Your Wisconsin Regulatory Board Needs You!

Have you thought about putting your massage therapy/bodywork therapy experience and expertise to use in a unique way?

The State of Wisconsin Massage Therapy and Bodywork Therapy Affiliated Credentialing Board is a 7-member regulatory board that is appointed by the Governor and confirmed by the Legislature to serve 4-year terms. Members serve primarily to consider complaints against those who are licensed by the State. They work with the legal staff of the Department of Safety and Professional Services to determine appropriate disciplinary actions to be taken but ultimately the Board's professional judgment is the final word. Periodically the Board takes on updating administrative rules, which is also done with the

- Access to computer, phone & internet
- Able to commit for the entire term of office
- Willing and able to commit the time required
- Able to travel for volunteer activities if required

Time commitment is pretty minimal: quarterly attendance either in person or by phone at board meetings that range from 1-4 hours; brief, monthly screening panel teleconferences to consider whether complaints warrant investigation and consideration by the full board; case advising for the legal department and of course some preparatory reading ("homework") for the above. It is amazing how professional experience prepares you for successful board service.

To qualify you only need to have been a licensed massage therapist or bodywork therapist for two years and fill out an application either by mail or online:
