## **QUESTION 1:**

Do you think your main street / downtown is healthy and successful? What would you do to support continued success or help create the change you want to see?

Downtown Greenwood has seen some successful development in the last 4 years and more of the population are taking advantage of those services. Is that enough? Additional services which are not currently available in nearby shopping districts would certainly be welcome but the biggest complaint I continue to hear is regarding access. This includes parking and traffic congestion at various times. We need to explore alternatives that would alleviate some of these concerns.

Any requests for a future development should have some concrete analysis regarding a return on investment. Tax dollars need to be safeguarded to prevent inefficient pet projects or those not serving the community in general. Whether looking at a project either by individually or prioritizing it against several proposals, consideration from a cost standpoint needs to be followed by determining a return to be obtained. Sometimes it appears those who scream the loudest get their project pushed forward regardless of any analysis and that needs to be stopped. Cost vs return needs to drive decisions.

## **QUESTION 4:**

## As you evaluate future development projects, what do you think are the most important considerations in granting economic development incentives, and what types of incentives are you most supportive of?

It has been reported that 95% of all new businesses received some sort of incentive to locate in a particular area. When considering the economic incentives, there are several critical factors to review. Those include the number of jobs to be created/time frames for those jobs, the cost of the incentive per job, the impact on local infrastructure and impact on local area housing and protection services. If it is determined that a business should be incentivized, the type of needs to be tailored to that specific entity. Whether it be an income tax credit, grants, TIF or tax credits, it must be designed to satisfy each entity.

#### **QUESTION 4:**
