1. WHAT INFORMATION DO WE COLLECT?

Personal Information You Provide

We collect personal information that you voluntarily provide, including when you:

This information may include:

- Name
- Email address
- Phone number (if provided)
- Billing address
- Payment information (processed securely by third-party providers)
- Communication preferences

We ask that you **do not submit sensitive personal information** through the Site.

Information Collected Automatically

When you visit the Site, we may automatically collect:

- IP address
- Browser type and device information
- Pages visited and time spent on the Site
- Referral source
- Cookie and tracking data

2. HOW DO WE USE YOUR INFORMATION?

We use your information to:

- Provide and deliver our Services

- Process transactions and deliver digital products
- Send newsletters and marketing communications (with your consent)
- Respond to inquiries and provide support
- Improve the functionality and performance of the Site
- Analyze usage trends

3. LEGAL BASIS FOR PROCESSING (GDPR)

If you are located in the European Economic Area (EEA), United Kingdom, or Switzerland, we process your personal information based on:

- **Consent** (e.g., marketing emails, cookies)
- **Contractual necessity** (e.g., purchases)
- **Legal obligations**
- **Legitimate interests** (e.g., improving our services)

You may withdraw your consent at any time.

4. WHEN AND WITH WHOM DO WE SHARE YOUR INFORMATION?

We may share your personal information with trusted service providers, including:

- Email marketing platforms
- Payment processors
- Website hosting providers
- Analytics providers
- Embedded content providers (e.g., video or podcast platforms)
- CRM, form, or scheduling tools

These providers may only use your information as necessary to perform services on our behalf.

We may also share information:

- In connection with a business transfer
- To comply with legal obligations
- To protect our rights or prevent fraud

We do **not sell your personal information**.



5. COOKIES AND TRACKING TECHNOLOGIES

We use cookies and similar technologies to:

- Ensure the Site functions properly
- Improve user experience
- Analyze traffic and usage
- Support marketing efforts (if applicable)

6. INTERNATIONAL DATA TRANSFERS
