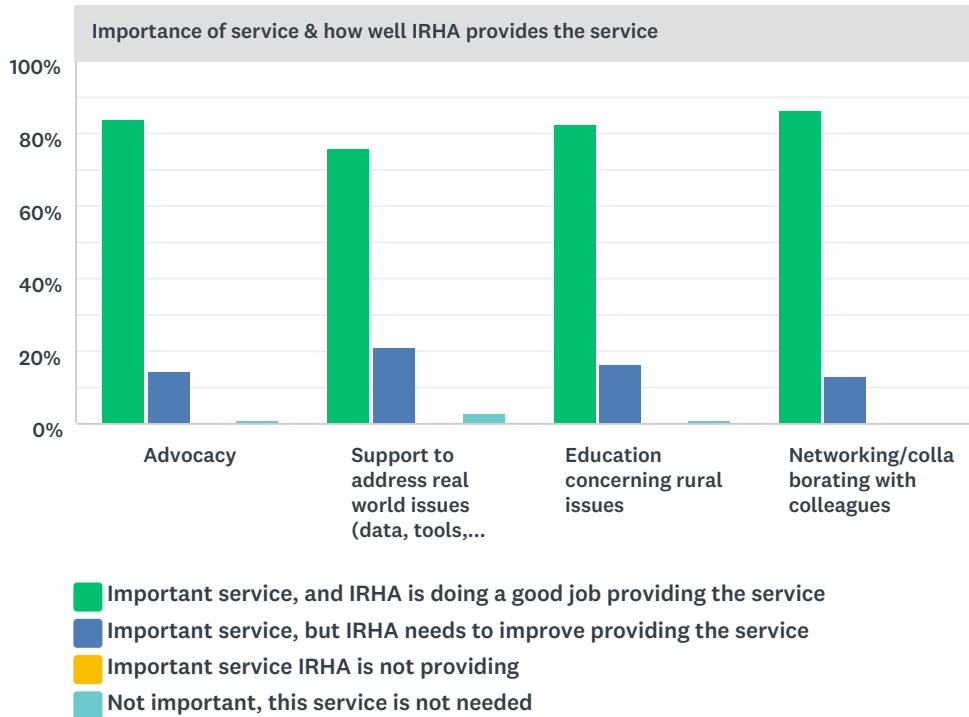

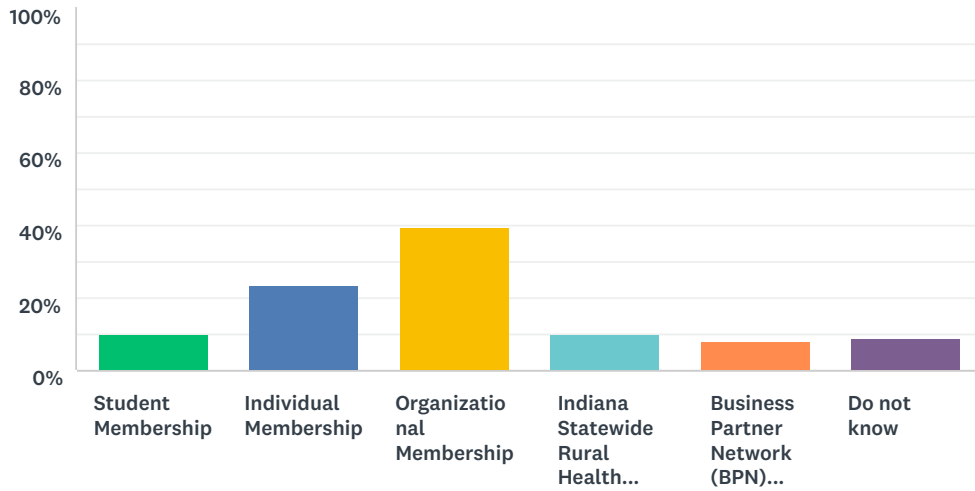

Q10 Please indicate the type of IRHA membership you are receiving member benefits through.

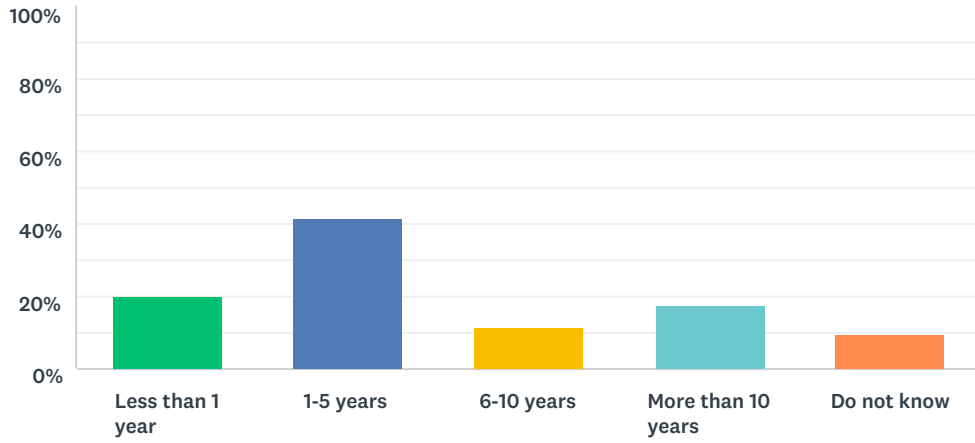

Q11 Approximately how many years have you been a member of IRHA?

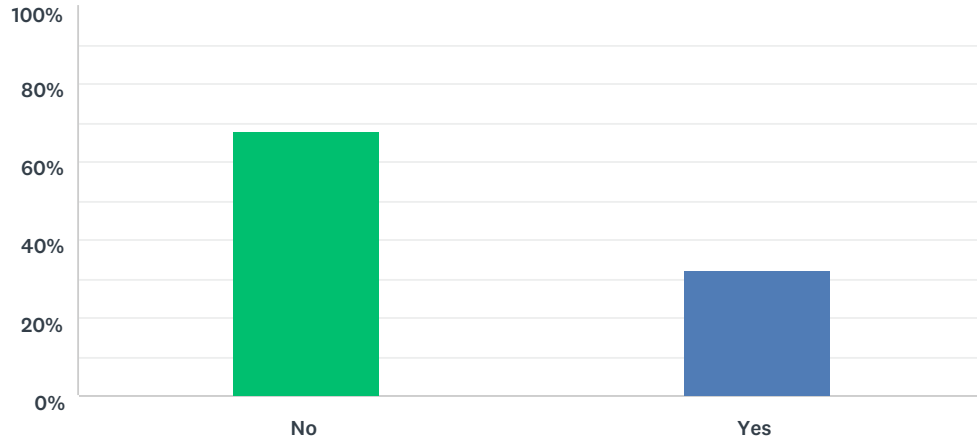

Q12 Have you exhibited at an IRHA educational event in the past 12 months?

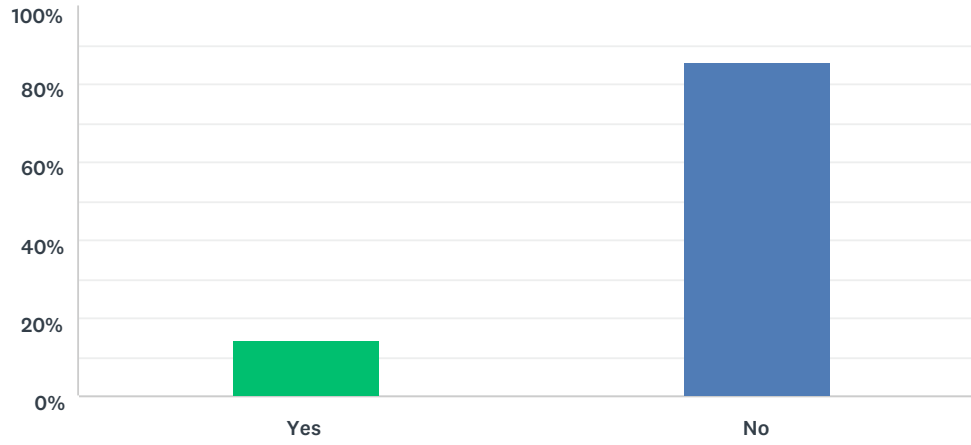

Q13 Are you a full-time student?

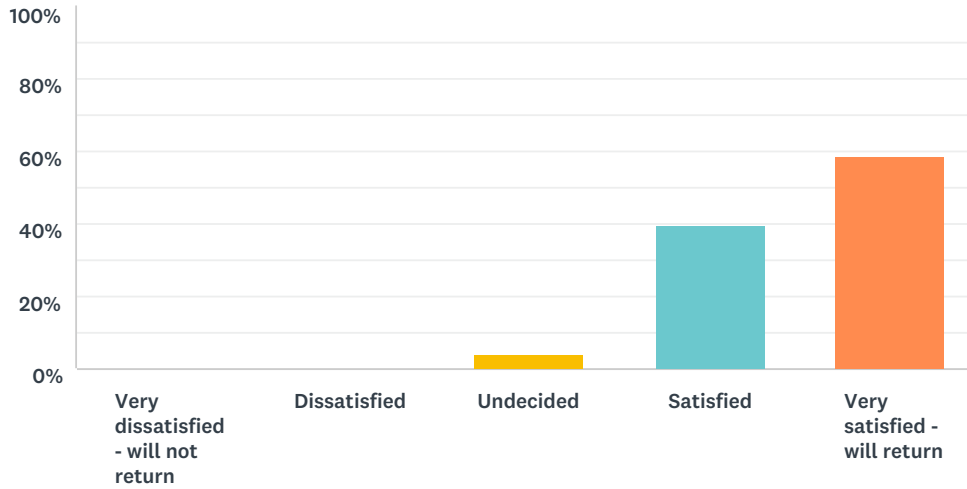

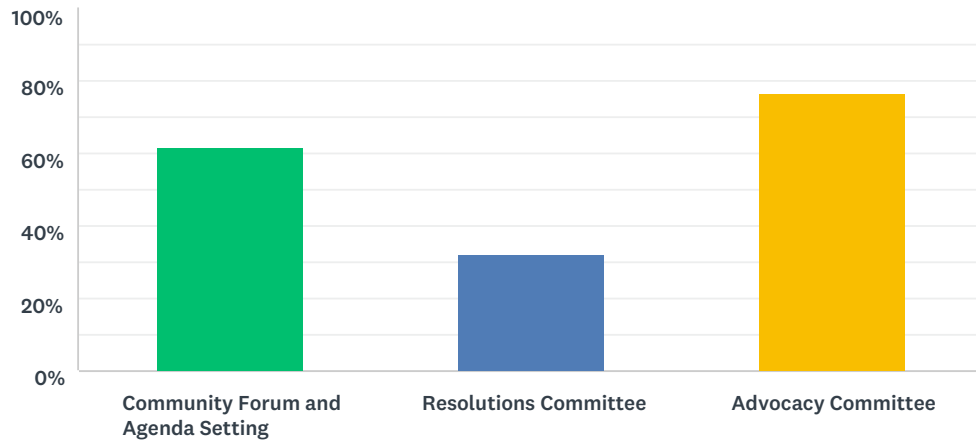

Q23 Which advocacy activities are you most interested?

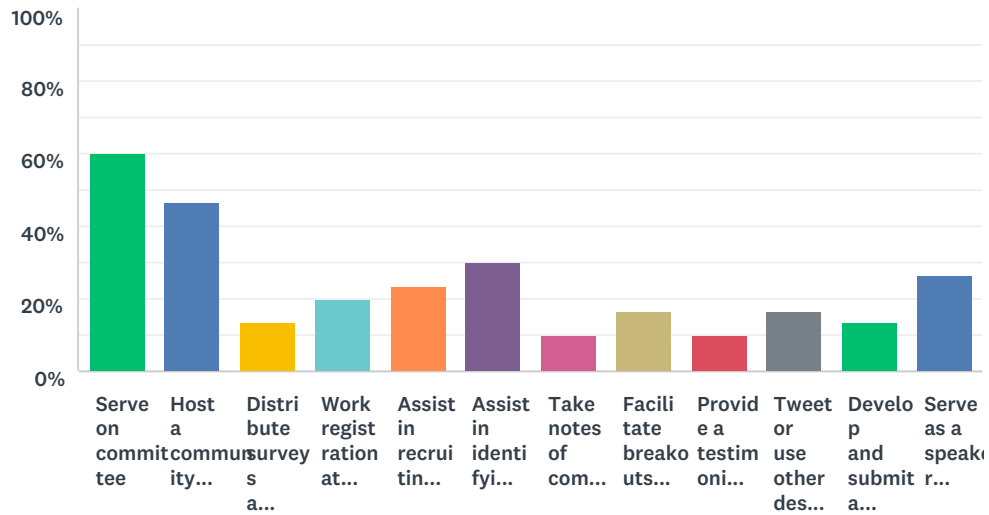

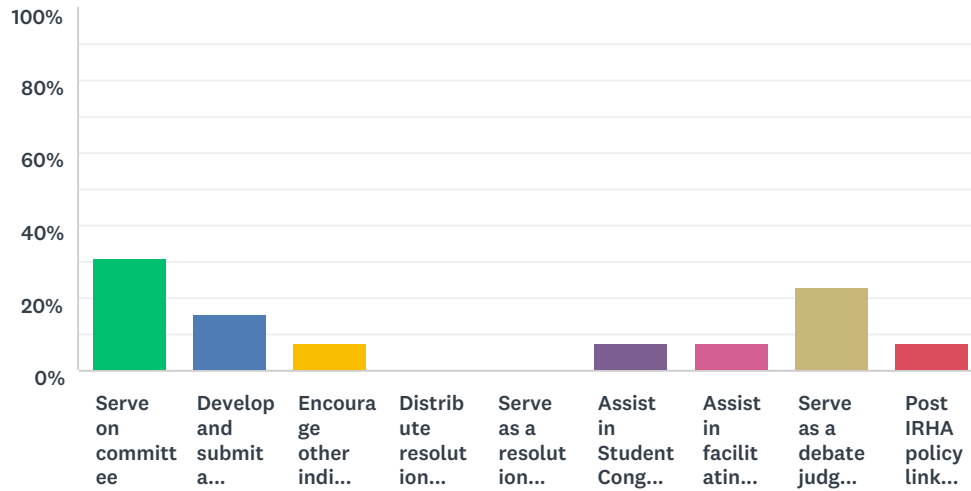

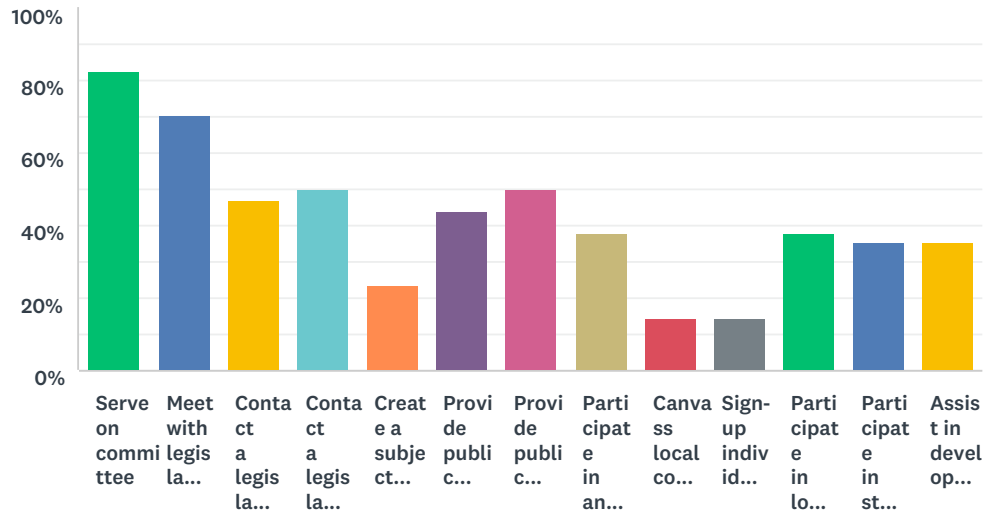
