
COMMUNITY FEEDBACK

JOHNSON COUNTY PUBLIC SCHOOL GUIDING PRINCIPLES

Everyone should understand and anticipate that schools may have to deal with positive Covide-19 cases, and they cannot be completely prevented. Johnson County Public Schools have coordinated their efforts in the following areas:

- Schools will start on time and keep their presently approved school calendars for 2020 2021.
- Use water fountains only to fill water bottles and/or cups.
- Require students and staff to be fever free for 72 hours (without the use of fever reducing medications) prior to returning to school.
- Discontinue perfect attendance and other attendance incentives for students.
- A strict limitation of visitors will be permitted in the school buildings throughout the instructional day.
- Masks are strongly encouraged to be used by students and staff, particularly in areas where social
 distancing norms are difficult. In some situations, masks may be required, such as food service workers
 and bus drivers.
- Staff and students will be provided frequent opportunities to wash and/or sanitize their hands during the school day.

TRANSPORTATION

TRANSPORTATION PLAN COMPONENTS WILL INCLUDE:

- BUS DRIVERS MUST WEAR MASKS WHEN SOCIALLY DISTANCING ON THE SCHOOL BUS IS NOT FEASIBLE.
- COACHES AND SPONSORS DRIVING MINIBUSES MUST WEAR MASKS WHEN SOCIALLY DISTANCING IS NOT FEASIBLE.
- STUDENTS WILL BE ASSIGNED SEATS FOR EACH ROUTE. SEATING CHARTS WILL BE KEPT IN ORDER TO PROVIDE A RECORD IN THE EVENT THAT CONTACT TRACING IS REQUIRED BY THE HEALTH DEPARTMENT.
- WHILE ON THE SCHOOL BUS, STUDENTS ARE STRONGLY ENCOURAGED TO WEAR THEIR OWN MASK. THIS HELPS TO PROTECT BOTH STUDENTS AND BUS DRIVERS.
- OUR TRANSPORTATION DEPARTMENT WILL STRIVE TO PLACE TWO STUDENTS PER SEAT ON A SCHOOL BUS.
- CONSISTENCY IN DAILY RIDING OF THE SAME BUS IS REQUIRED FOR SAFETY REASONS, FOR NOT OVERCROWDING BUSES, AND TO ENSURE THE POSSIBLE NEED FOR CONTACT TRACING. FOR EXAMPLE, STUDENTS NEED TO CONSISTENTLY RIDE THE SAME BUS FOR THEIR MORNING AND AFTERNOON ROUTES.
- THERE WILL BE NO SWITCHING/MOVING TO OTHER BUSES. THERE WILL BE NO GUEST/FRIEND RIDERS ALLOWED TO RIDE BUSES HOME.

TRANSPORTATION PLAN COMPONENTS WILL INCLUDE:

- PARENTS WHO ARE UNCOMFORTABLE WITH BUSING PROCEDURES ARE ENCOURAGED TO DRIVE/PICK UP THEIR STUDENTS ON A CONSISTENT BASIS.
- EXTRA CLEANING OF BUSES WILL OCCUR BEFORE AND AFTER EVERY ROUTE.
- STUDENTS SHOULD KEEP THEIR HANDS TO THEMSELVES WHILE ON THE SCHOOL BUS.
- 5TH GRADE STUDENT-ATHLETES WILL BE ESCORTED BY AN ADULT TO THE MIDDLE SCHOOL FOR ATHLETIC PURPOSES.
- CHILDREN OF STAFF MEMBERS WILL BE ESCORTED BY AN ADULT TO AND FROM BUILDINGS.
- IF BUS CAPACITY SIZE NEEDS REDUCED, THE TRANSPORTATION DEPARTMENT WILL CONTACT OUT OF DISTRICT FAMILIES AND REQUEST THAT THEY PROVIDE THEIR OWN TRANSPORTATION.
- IF AFTER SCHOOL CARE IS NEEDED, PLEASE CONTACT OUR CONTRACTED PROVIDER--COUNTRY KIDS' DAYCARE AND AFTER SCHOOL PROGRAM. CLICK ON THE FOLLOWING LINK FOR ASSISTANCE: COUNTRY KIDS

STUDENT INSTRUCTION (IN-PERSON AND REMOTE LEARNING OPPORTUNITIES)

STUDENT INSTRUCTION PLAN COMPONENTS WILL INCLUDE:

- TRADITIONAL IN-PERSON INSTRUCTION WILL OCCUR FIVE DAYS PER WEEK.
- USING OUTSIDE AREAS FOR CLASSROOM INSTRUCTION WILL BE PERMISSIBLE (WEATHER PERMITTING).
- ALL STUDENTS (K 12) WILL POSSESS AND TAKE HOME THEIR OWN SCHOOL-ISSUED DEVICE ON A DAILY BASIS.
- CONSIDERATION WILL BE GIVEN TO USING INSIDE, LARGE AREAS FOR CLASSROOM INSTRUCTION TO HELP MAINTAIN SOCIAL DISTANCING. EXAMPLES INCLUDE: POOL LOBBY, LGI, COMMONS AREA, CAFETERIAS, AND AUDITORIUM SPACE.
- TEACHERS WILL CLEAN OUT ALL CLASSROOMS FOR MAXIMUM SPACE USAGE AND REMOVE NONESSENTIAL MATERIALS PRIOR TO THE START OF THE 2020 2021 SCHOOL YEAR.
- CLASSROOMS WILL BE REORGANIZED TO ALLOW FOR PROPER SPACING OF DESKS TO ENSURE SOCIAL DISTANCING. FOR EXAMPLE, DESKS WILL BE REARRANGED TO INCREASE SPACE BETWEEN ALL STUDENTS. DESKS WILL FACE IN THE SAME DIRECTION WHEN POSSIBLE.
- THERE WILL BE ASSIGNED SEATING IN ALL CLASSROOMS ACROSS ALL SCHOOL BUILDINGS.
- THERE WILL BE NO FIELD TRIPS AND/OR SCHOOL-WIDE ASSEMBLIES OR CONVOCATIONS FOR THE 2020 2021 SCHOOL YEAR.

STUDENT INSTRUCTION PLAN COMPONENTS WILL INCLUDE:

- PERFORMANCE EXPECTATIONS FOR IN-PERSON/TRADITIONAL AND REMOTE LEARNING WILL BE THE SAME FOR STUDENTS REGARDLESS OF THEIR LEARNING ENVIRONMENT.
- THE DISTRICT WILL DEVELOP A STRONG COMMUNICATION PLAN (THAT WILL BE IN THE BUILDING-LEVEL SPECIFIC PLANS) WITH FAMILIES TO DISCUSS THE DELIVERY METHOD OF INSTRUCTION FOR STUDENTS WITH DISABILITIES AND ENSURE THAT THEIR NEEDS ARE ADEQUATELY MET.
- ATTENDANCE AWARDS AND/OR PERFECT ATTENDANCE INCENTIVES FOR STUDENTS WILL BE SUSPENDED FOR THE UPCOMING SCHOOL YEAR.
- PARENTS OF STUDENTS WITH PRE-EXISTING HEALTH CONDITIONS OR OTHER SERIOUS HEALTH CONSIDERATIONS SHOULD CONTACT THEIR BUILDING LEVEL ADMINISTRATOR TO DISCUSS REMOTE LEARNING OPPORTUNITIES.
- EXPANDED, REMOTE LEARNING OPPORTUNITIES WILL BE AVAILABLE ON AN INDIVIDUAL BASIS. REACH OUT TO YOUR BUILDING ADMINISTRATOR FOR ADDITIONAL INFORMATION.
- IF A STUDENT CONTINUES WITH REMOTE LEARNING THEN HE/SHE WILL NOT BE ABLE TO PARTICIPATE IN EXTRA-CURRICULAR ACTIVITIES.



SCHOOL DAY PROCEDURES & OPERATIONS

SCHOOL DAY PROCEDURES AND OPERATIONS PLAN COMPONENTS WILL INCLUDE:

- STAFF AND STUDENTS ARE STRONGLY ENCOURAGED TO WEAR MASKS IF PROPER SOCIAL DISTANCING CANNOT BE MAINTAINED.
- NO GUESTS OR VISITORS WILL BE ALLOWED DURING THE SCHOOL DAY.
- ONLINE REGISTRATION THROUGH INFINITE CAMPUS WILL BEGIN IN EARLY JULY.
- NO OUTSIDE LUNCHES/FOOD ITEMS WILL BE DELIVERED TO SCHOOL OFFICES.
- NO ACCEPTANCE OF FOREIGN EXCHANGE STUDENTS WILL OCCUR AFTER AUGUST 4TH.
- NO SCHOOL SUPPLIES ARE ALLOWED TO BE SHARED BETWEEN STUDENTS (TOYS, ELECTRONIC GAMES, ETC.).
- WATER FOUNTAINS WILL BE CONVERTED TO WATER DISPENSING STATIONS.
- LIBRARY MATERIALS WILL OPERATE ON A THREE DAY CHECK-IN/CHECK-OUT SYSTEM. IN OTHER WORDS, WHEN BOOKS ARE RETURNED THEY WILL NOT BE SHELVED FOR THREE DAYS.

SCHOOL DAY PROCEDURES AND OPERATIONS PLAN COMPONENTS WILL INCLUDE:

- ICES STUDENTS WILL TAKE THEIR SCHOOL ISSUED DEVICES HOME DAILY LIKE STUDENTS IN ALL OTHER BUILDINGS.
- LUNCHROOM SCHEDULES
 *EXPANSION OF DINING AND SITTING AREAS FOR SOCIALLY DISTANCING STUDENTS DURING THIS TIME WILL OCCUR.
- STAGGERED PASSING PERIODS WILL BE UTILIZED TO MINIMIZE CONTACT BETWEEN STUDENTS.
- STUDENTS WILL REPORT IMMEDIATELY TO CLASSROOMS UPON ARRIVAL AT SCHOOL.
 *STUDENTS PURCHASING BREAKFAST SHOULD DO SO, AND REPORT TO THEIR CLASSROOM.
- A COVID-19 SELF CHECK-LIST FOR SYMPTOM REMINDERS WILL BE SENT OUT TO FAMILIES DAILY.
- WE WILL PROVIDE MORE FREQUENT OPPORTUNITIES TO WASH AND/OR SANITIZE HANDS THROUGHOUT THE DAY.
- RECESS TIMES (K 5) WILL BE STAGGERED AND MODIFIED IN ORDER TO SOCIALLY DISTANCE AND TO MINIMIZE THE NUMBER OF STUDENTS ON THE PLAYGROUND AT THE SAME TIME.
- STUDENTS WILL BE ALLOWED/ENCOURAGED TO BRING THEIR OWN WATER BOTTLE FOR USE.
- THERE WILL BE NO CHANGE OF CLOTHES DURING PE CLASSES UNTIL AFTER AUGUST 16.
- THERE WILL BE NO DELIVERY OF SWIMMING CURRICULUM DURING PHYSICAL EDUCATION CLASSES FOR THE FIRST SEMESTER.

SCHOOL HEALTH & WELLNESS CARE

SCHOOL HEALTH AND WELLNESS CARE PLAN COMPONENTS WILL INCLUDE:

- STUDENTS AND STAFF WILL STAY HOME IF THEY HAVE A FEVER OF 100 °F OR HIGHER.

*PARENTS SHALL MONITOR ON A DAILY BASIS CHILDREN AND SIGNS OF POSSIBLE INFECTION. STAFF WILL MONITOR THEMSELVES FOR POSSIBLE INFECTION AS WELL. THESE INCLUDE THE FOLLOWING SYMPTOMS:

- *FEVER OR CHILLS
- *COUGH
- *SHORTNESS OF BREATH OR DIFFICULTY BREATHING
- *FATIGUE
- *MUSCLE OR BODY ACHES
- *HEADACHE
- *NEW LOSS OF TASTE OR SMELL
- *SORE THROAT
- *CONGESTION OR RUNNY NOSE
- *NAUSEA OR VOMITING
- *DIARRHEA
- ANY STUDENT OR EMPLOYEE WITH A FEVER WILL STAY HOME UNTIL THEY HAVE NOT HAD A FEVER FOR AT LEAST 72 HOURS (THAT IS THREE FULL DAYS OF NO FEVER WITHOUT THE USE OF MEDICINE THAT REDUCES FEVER); OTHER SYMPTOMS HAVE IMPROVED; AND AT LEAST 10 CALENDAR DAYS HAVE PASSED SINCE SYMPTOMS FIRST APPEARED.

SCHOOL HEALTH AND WELLNESS CARE PLAN COMPONENTS WILL INCLUDE:

- AN ISOLATION AREA WILL BE ESTABLISHED FOR STUDENTS EXHIBITING SYMPTOMS IN ORDER TO PROVIDE A SAFE AREA FOR INDIVIDUALS TO BE QUARANTINED WHILE AWAITING PARENT PICK UP.

- MEDICAL INQUIRIES

- *FEDERAL LAW TYPICALLY LIMITS THE TYPE OF MEDICAL INQUIRIES THAT CAN BE MADE, BUT GIVEN THE NATURE OF THE PANDEMIC MORE LEEWAY HAS BEEN GIVEN TO SCHOOLS IN THIS CIRCUMSTANCE TO MAKE ADDITIONAL MEDICAL INQUIRIES OF STAFF AND STUDENTS THAN WOULD OTHERWISE BE ALLOWED.
 - * IF THE PARENT TELLS THE SCHOOL THAT THE STUDENT IS ILL, THE SCHOOL MAY ASK THE PARENT WHETHER THE STUDENT IS EXHIBITING ANY SYMPTOMS OF COVID-19.
 - * IF AN EMPLOYEE CALLS IN SICK OR APPEARS ILL, THE SCHOOL CAN INQUIRE AS TO WHETHER THE EMPLOYEE IS EXPERIENCING ANY COVID-19 SYMPTOMS.
 - * IF A PERSON IS OBVIOUSLY ILL, THE SCHOOL MAY MAKE ADDITIONAL INQUIRIES AND MAY EXCLUDE THE PERSON FROM SCHOOL PROPERTY.

SCHOOL HEALTH AND WELLNESS CARE PLAN COMPONENTS WILL INCLUDE:

- SELF-ASSESSING QUESTIONNAIRES WILL BE SENT DAILY TO FAMILIES FOR THE SAFETY OF OUR ENTIRE CAMPUS, IT IS IMPERATIVE THAT THESE QUESTIONNAIRES ARE COMPLETED DAILY.
- IMMUNIZATION REQUIREMENTS HAVE NOT CHANGED. ALL IMMUNIZATIONS WILL BE BASED ON THE REQUIRED STATE GUIDELINES. IMMUNIZATION REQUIREMENTS MAY BE VIEWED AT THE FOLLOWING LINK: <u>IMMUNIZATION 2020 -2021</u>
- YOU WILL NOTE THAT IN THE EVENT OF A DOCUMENTED POSITIVE CASE, SHORT-TERM CLOSURE MAY BE APPROPRIATE. SCHOOLS AND LOCAL HEALTH DEPARTMENTS ARE ENCOURAGED TO KEEP SCHOOLS OPEN AND OPERATING AS MUCH AS POSSIBLE. THE CDC DECISION TREE HAS THE SCHOOL CLOSING FOR POTENTIALLY TWO FIVE DAYS SO THE LOCAL HEALTH DEPARTMENT OR THE INDIANA STATE DEPARTMENT OF HEALTH CAN ENGAGE WITH YOUR TEAM TO RECOMMEND FURTHER TESTING, CLEANING, ETC.; HOWEVER, THIS HEALTH/MEDICAL REVIEW MAY BE DONE ON THE SAME DAY AS A POSITIVE CASE TO REDUCE SCHOOL CLOSURE TIME.
- THE INDIANA STATE DEPARTMENT OF HEALTH (ISDH) WILL COORDINATE AND CONDUCT ALL CONTACT TRACING IN THE EVENT IT IS NECESSARY.



FOOD SERVICES

FOOD SERVICE MODEL PLAN COMPONENTS WILL INCLUDE:

- STAFF WILL WEAR MASKS AND GLOVES DURING FOOD PREPARATION AND SERVING.
- MEALS WILL BE SERVED TO STUDENTS, OR STUDENTS MAY PICK UP PRE-PACKAGED MEALS THEMSELVES.
- PRE-PACKAGED FLATWARE WILL BE PROVIDED.
- THERE WILL BE NO SHARING OF FOOD BETWEEN STUDENTS.
- STUDENT MICROWAVE OVEN USAGE IS SUSPENDED UNTIL FURTHER NOTICE.
- SNEEZE GUARDS/PROTECTIVE BARRIERS WILL BE INSTALLED AT CASHIER STANDS AND SERVING AREAS AS NECESSARY AND APPROPRIATE.
- FAMILIES ARE ENCOURAGED TO USE THEIR ONLINE PAYMENT PORTAL THROUGH *INFINITE CAMPUS* TO DEPOSIT MONEY. THE USE OF CASH AND CHECKS IS STRONGLY DISCOURAGED. CASH TRANSACTIONS THAT ARE BROUGHT TO SCHOOL SHOULD BE PLACED IN THE CAFETERIA DROP BOXES LOCATED IN EACH SCHOOL'S MAIN OFFICE.
