Wabash County Hospital

As part of our Wabash County Hospital Patient Safety Initiatives for 2011, we reviewed what we were doing for fall risk assessment and prevention. We found our policy needed updating, our practice could stand a "refresher," we wanted to define "near falls," [patient is lowered to the floor without landing forcefully], and consistently review all occurrences post-fall in a standard manner. Previously, we had coordinated our fall prevention efforts with the North East Indiana Patient Safety Coalition and conformed to the color "yellow" for use throughout our region as an indicator of fall risk. However, we felt a small yellow dot on their ID bracelet and a dot on the doorway to their room wasn't effective. researching some additional fall risk alerts, we found we could identify our fall risks with yellow hospital "footies" and lap robe of inexpensive yellow fleece. This way, if our patients are in bed, the lap robe is placed on the foot of the bed to identify them as a fall risk. If a person gets out of their room [goes to radiology, for example] they are quickly identified as an individual who may need additional assistance and not be left alone. Even if our housekeepers see a little old lady ambulating down the hall by herself wearing the yellow slippers, they know she probably shouldn't be out walking by herself and can stroll along beside her until they can let the nurse know the patient is walking by themselves! The slippers and lap robes are very inexpensive and we feel it has really helped identify our patients with fall risks uniformly. We decreased from 11 inpatient falls during first 6 months of 2010 to 2 inpatient falls during first 6 We were doing Annual Inmonths of 2011. servicing with all hospital staff when we instituted the slippers and lap robes so ALL employees were educated about the meaning and what to do to help prevent falls. We now also cover it in new employee orientation monthly so new hires are educated.

Wabash County was recently recognized on a national *Partnership for Patients* conference call on July 8, 2011 by HHS Secretary Kathleen Sebelius.

St. Vincent Dunn Hospital

St. Vincent Dunn Hospital is proud to be the only Accredited Chest Pain Center in Lawrence County, in Bedford, Indiana. Accreditation from the Society of Chest Pain Centers means that we have met certain standards in the of Acute Coronary care Syndrome (ACS) patients and clearly displays our commitment to excellence in this area. St. Vincent Dunn Hospital is also unique because it is very rare for a Critical Access Hospital to have Interventional Cardiology, and the broad range of Cardiovascular Services that we offer.

Within the Cardiovascular Lab. we perform both diagnostic and interventional cardiac procedures, including balloon angioplasty and stent placement. In addition to those procedures, we also implant Pacemakers and ICD's (Internal Cardiac Defibrillators), perform diagnostic and interventional peripheral vascular procedures. and carotid angiography. Beginning in July of 2011, we will also be performing Trans-Radial heart catheterizations. This means that instead of performing these procedures through the femoral artery in the groin, we will start using the radial artery in the wrist for some of these cases. Trans-Radial cath patients do not have to lay flat for an extended period of time after their procedure, should recover more quickly, and have a lower risk of bleeding complications.

The Cardiovascular Lab actively participates in separate registries (one for Cath-PCI, and the other for ICD's) through the ACC-NCDR (American College Cardiology National Cardiovascular Data Registry). Participation in these registries helps us to measure ourselves, and the care we provide to these patients, against other hospitals across the nation so that we can readily identify areas improvement and ensure that we stay current with the standards of According care. to the Institutional Outcomes Report generated by the NCDR for 2010 we are in the top 10% of participating hospitals for median time to PCI for STEMI patients. STElevation STEMI. Myocardial Infarction patients, are those patients that are actively having a heart attack and losing heart muscle as time passes. The "gold standard" that has been established nationally for care of these patients' states that STEMI patients should be in the lab, and have intervention on the blocked artery that is causing their heart attack, within 90 minutes of their arrival to the hospital. This time period is referred to as "Door to

Balloon" time. In 2010, our average "Door to Balloon" time was 57.8 minutes, and we achieved our 90 minute goal on 96% of STEMI patients. Since "time equals heart muscle" for these patients, acting quickly is essential for improving patient outcomes.

Additionally, we offer a fully Accredited Cardiac Rehab program at St. Vincent Dunn for care of our patients after their cardiac event. Our Cardiology department provides a full range of Stress Testing, along with Holter and Event Monitors. Our Vascular Ultrasound department is accredited with ICAVL, and also have a full-time Echocardiography program. Our goal is to pursue Accreditation for Echo our department with ICAEL.

At Community Hospital of Bremen, we have implemented Electronic Medication Administration Records (eMAR), bedside barcode scanning for medication verification against the electronic medication record, and Telepharmacy for pharmacist review of medication orders when the pharmacy is closed.

We would like to share a few brief things about the Community Hospital of Bremen related to workforce and quality and patient safety and quality. We tend to develop the professional capabilities of our existing staff to meet hospital patient care needs. This has included reimbursing tuition assistance for three LPNs to advance to RN status over the last 24 months. Three members of our senior leadership team have pursued additional training with hospital tuition support. Two senior leaders completed Masters of Public Administration degrees and one completed a bachelors degree in Organizational Management. We are also assisting one RN pursuing a BSN credential. In addition to the skill and training development of our employees we are also concerned about the health of our employees. Due to our successful implementation of a variety employee health initiatives we have been designated as a Fit Friendly Company by the American Heart Association.

We take patient safety and quality very seriously as part of our healing mission. Our hospital was granted Joint Commission accreditation in January We are quite proud of this of this year. accomplishment. Our hospital laboratory is dual certified by the American College of Pathology and by the Clinical Laboratory Improvement Act. The American Heart Association recently gave us a Get the Guidelines Stroke award for our implementation of stroke protocols that follow evidence based medicine. Our digital

mammography program is credentialed by the Mammography Quality Standard Act. We have implemented a picture archiving and retrievalsystem (PACS) in our Imaging Department to share, retrieve, and store all images digitally rather than on plain film. This allows us to instantly send images to other hospitals and physician offices. Other steps that we have taken to improve quality and safety include an electronic nurse order entry program and a bedside medication verification program. We also partnered with other Indiana State Rural Health Network hospitals to participate in a telepharmacy All medication orders are remotely program. reviewed before administration during times when our in house pharmacists are not on duty. We have also joined a regional health information exchange to share patient care information between providers.

This is only a partial list of things that we are doing to improve our Community Hospital of Bremen.
