THEN

FUNDS: The first fund was created in 1992 by Dr. Mark and Barbara Caress. This fund continues to benefit the Montgomery County Educational Foundation.

GRANTS: The first three grants were awarded in 1992 and totaled \$2,091.

SCHOLARSHIPS: The first scholarships were awarded in 1994, for a total of \$9,775.

ASSETS: In April 1992, our assets totaled \$64,934.

NOW

FUNDS: We now have 230 endowed funds benefitting nearly every area of our community.

GRANTS: 334 grants were awarded in 2020 and totaled \$1.4 million.

SCHOLARSHIPS: 264 scholarships were awarded in 2020, for a total of \$503,075.

ASSETS: In December 2020, our assets totaled \$59.5 million

The Montgomery County Community Foundation (MCCF) and Hoosier Heartland State Bank (HHSB) are pleased to offer the Bridge Builder Nonprofit Loan Program to Montgomery County nonprofit organizations.

Our nonprofit community is facing many challenges and limited fundraising opportunities. MCCF and HHSB regularly support local nonprofits with grants and donations but know that grant funding may not address all of the needs of organizations. This program offers low-interest loans to recognized 501(c)(3) organizations serving Montgomery County residents and is intended to act as an additional option to help meet unfulfilled operating and program needs.

Types of Qualifying Loans

Loans for operating needs, projects, and programs will be considered for the Bridge Builder Nonprofit Loan Program.

Requesting Amounts:

The minimum loan amount that can be requested is \$10,000. Maximum amounts vary and will be determined on a case-by-case basis.

Terms:

Loan terms will vary with a maximum of five years.

Interest Rate:

Low to 0% interest

Note: HHSB will determine if collateral is required on a case-by-case basis.

Group wants to form community foundation

Last fall Lilly Endowment invited groups to establish community foundations. It committed \$47 million through the year 2005 to help Indiana communities in creating community foundations or strengthening existing ones.

The invitation caught the attention of Nancy Doemel, director of corporate and foundation relations at Wabash College, and Mayor Philip Michal.

"They (Lilly) dangled the carrot which stretches to the year 2005, and we thought maybe this would work for our community," Doemel said. She and Michal attended some "how-to" sessions to learn more about the Lilly project.

They were impressed and even more excited about the prospect

of having a local community foundation. "Lilly's goal is to help Indiana communities establish a legacy reselfreliance in addressing cal problems," Doemel said. "We can't think of a community with a stronger sense of self-reliance than this one."

The two decided to go a step further. Thursday night they met with a small group of community leaders and resource people for an exchange of ideas.

"We wanted to know if there is an interest here in establishing a munity foundation," Doemel se____ "If there is, should we move forward and how?"

Lilly Endowment defines a community foundation as "a publicly-supported philanthropic institution serving a defined geographic area and interest. It administers funds from an endowment built from contribu-

tions by individuals, corporations, other foundations and government. A community foundation distributes grants to nonprofit agencies in such areas as human services, education, health, community development, arts and other civic endeavors."

Doemel said Lilly Endowment is willing to help local com-
