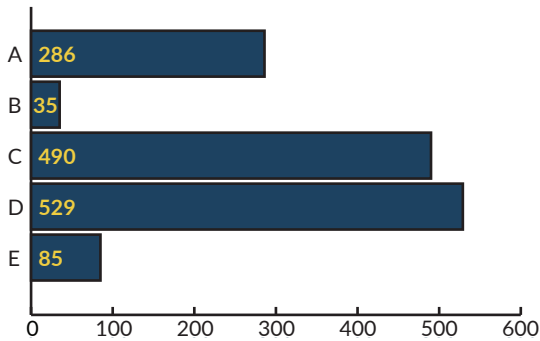

VACCINE MANDATES

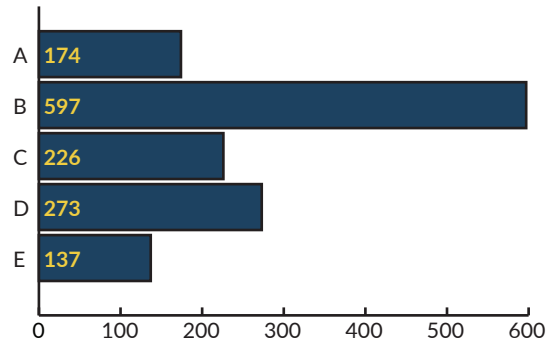
- A) The government should mandate institutions require vaccines for employees to improve public health.

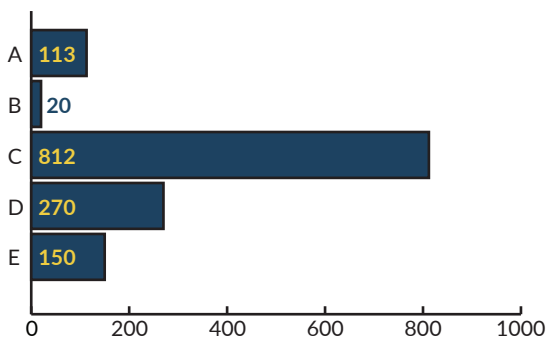

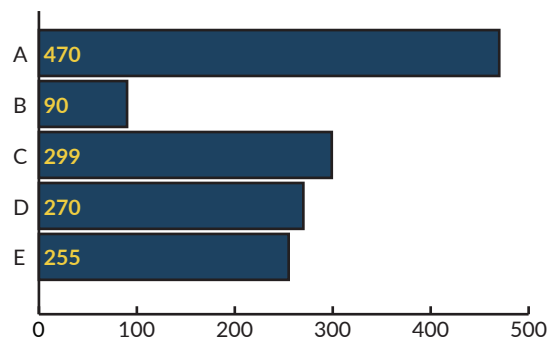

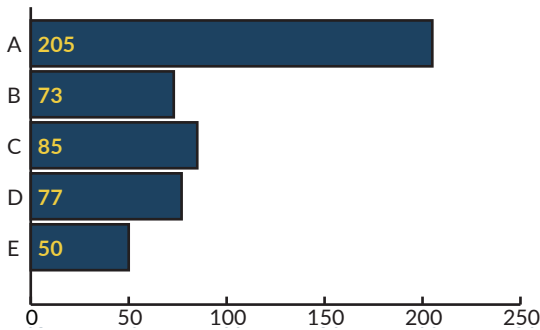

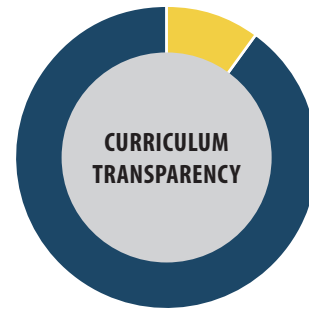
5. Solar farms are covering large areas of farmland in Indiana. Which of the following do you support?

6. Do you support or oppose requiring schools to make their educational materials available for parents to inspect?



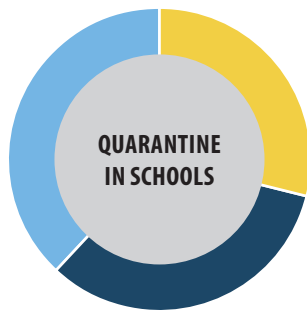

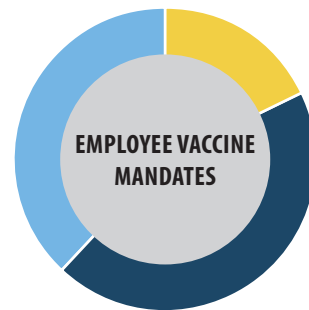

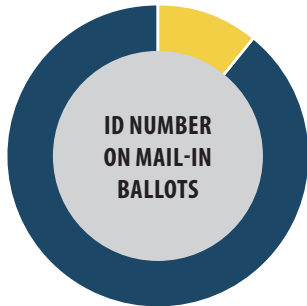

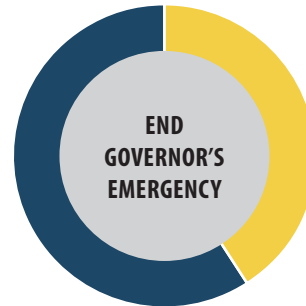

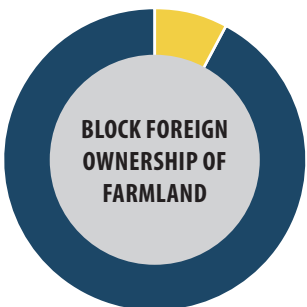
10. Should the General Assembly vote to end the governor's emergency declaration for COVID-19?

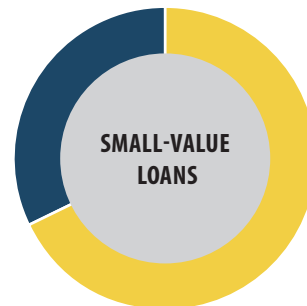

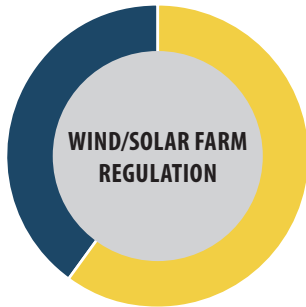

- B) Local communities should be allowed to create their own zoning and safety standards, including banning windmills and solar farms.

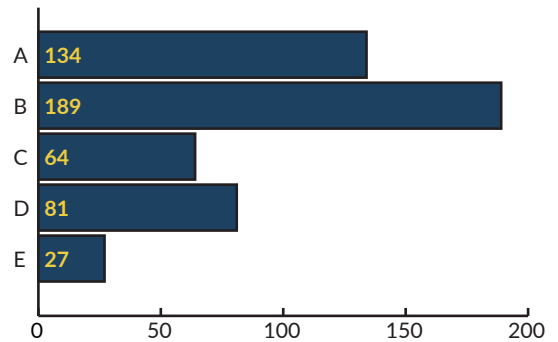

BROADBAND SATISFACTION

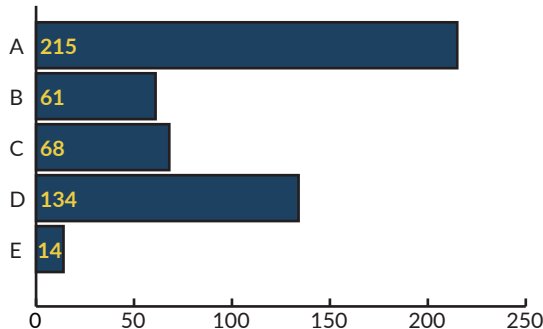
