Dr. Rozelle stated that after checking our records and confirming our information with Moisture Management we informed AAA that we had paid all of the pay applications we had received (including retainage). Upon checking further AAA Roofing discovered that they had not sent pay application #2 and so it was never paid. Brennen Baker, President of Moisture Management contacted AAA Roofing and after checking against their records confirmed this was the case. AAA Roofing sent pay application # 2 for the amount of \$29,862. The Board voted to approve pay application #2 in the amount of \$29,862.
