Questions & Answers

1. What are some characteristics of a strong grant proposal?

A strong proposal clearly defines the need using relevant data and real-life experience. The approach to addressing the need is well-thought out, explained concisely, and seems reasonable. Demonstrating efforts to work with others to ensure good use of resources, avoid duplicate efforts, and if logical, genuine collaboration will strengthen a request.

2. Our nonprofit organization has never written a grant. Can we do it ourselves or should we hire a grant writer?

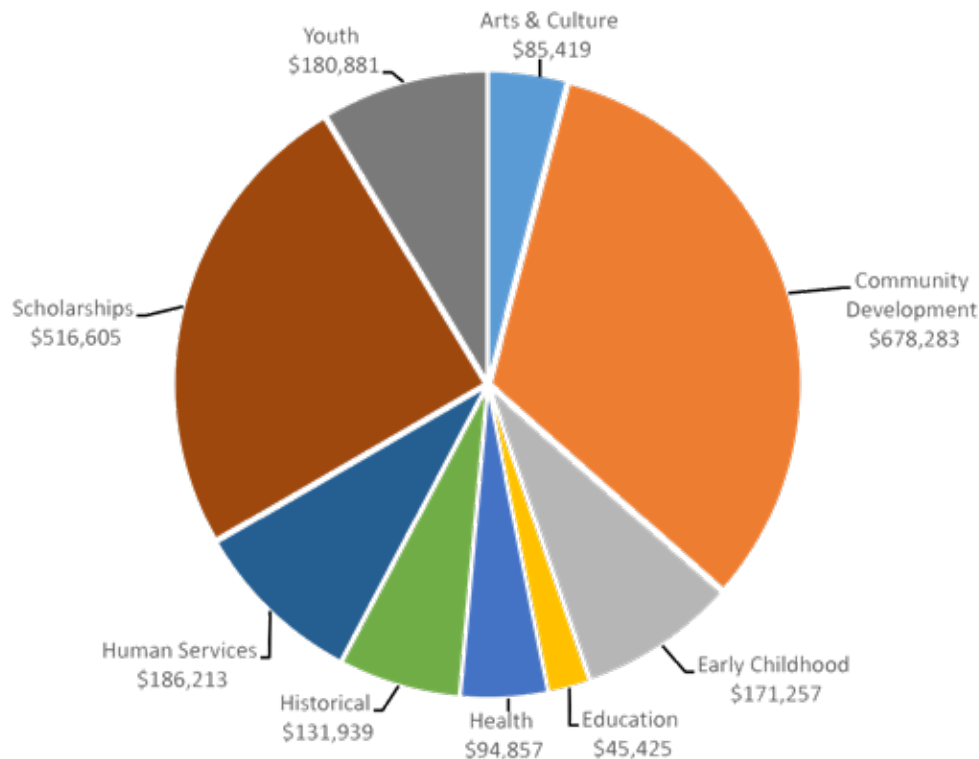
MCCF grants are straight forward. With good preparation, and collaboration with your board and/or staff, it should be quite manageable to do in-house.

3. How are unrestricted grant funds distributed?

Local nonprofits are invited to apply for grants each spring and fall. The Grants & Distributions committee reviews the grant requests. The committee is made up of both MCCF board members and community members. They carefully review each request and evaluate it on a number of factors such as the strength of the plan, the potential impact, and the organization’s capacity to do the work. Keeping the community’s greatest needs and challenges in mind, recommendations for funding are made. Those recommendations go to the full MCCF Board of Directors for approval.

ON a bright and sunny Saturday morning in September, MCCF hosted a dedication of the newly renovated Frances Wooden Park. A large crowd from the community gathered to celebrate the dedication, and there was an abundance of smiles and laughter as children explored and played in the park. The park is named in honor of Wooden, who was Director of the Northside Rec Center for over 35 years and was known as an advocate for neighborhood children. The park was built where the rec center once stood, and sits adjacent to the Bethel AME Church, which was a stop on the Underground Railroad. The renovation was made possible through funding from the MCCF and the City of Crawfordsville. Newly installed benches act as a historical timeline, with notable dates and facts etched into the bases. Play structures, a shelter, and interactive musical pieces are just a few of the many other improvements made during the renovation.



IN partnership with the City of Crawfordsville, MCCF celebrated the dedication of a newly-activated alley in downtown Crawfordsville. A popular gathering spot for the community, the alley boasts a 144 foot long mural featuring a variety of flowers and a gradient color scheme, created by New York muralist Jenna Morello. After the mural was finished, the City of Crawfordsville committed funding to “activate” the space and add lighting and seating.

A new bench was also unveiled honoring Dale Milligan, a long-time business owner and active community member. Friends and family donated

the bench, which encourages visitors to “Rest, reflect, and enjoy our beautiful community”- a perfect sentiment for this beautiful new addition to historic downtown Crawfordsville.

WHEN a need was made known within our community, our community joined resources to make it happen. A young man, Luke Rice, needed an adaptive bike to help exercise his legs and build muscle tone. Local Kiwanians learned of Luke's need and with donations made by their members and others, along with a successful grant request to MCCF from the Youth Service Bureau, the bike became a reality and was presented to Luke.

Luke is the son of Bruce and Melinda Rice and attends Crawfordsville Middle School. In the eighth grade, he attends a special education life skills class. Luke was diagnosed with cerebral palsy when he was just six months old. Further test results showed that Luke has a unique and rare chromosome deletion identified as 1q4 Chromosomal Deletion. As a growing teenager, his muscle tone is getting tighter due to the cerebral palsy spastic muscle tone he has. Botox injections into his hamstrings and physical therapy are helping with muscle tone; however, Luke is unable to walk long distances. The bike is a great way to exercise his legs and build muscle tone.

The MCCF grant was awarded through two Field of Interest funds: The Bradley and Suzanne Deur Mullendore Fund and the Ian Geoffrey Hudson Memorial Fund. The Mullendore fund was established to benefit those with neurological injuries, diseases, or impairments. The Hudson fund was similarly created to assist local children with disabilities. The Hudsons were thrilled for Luke to have this opportunity. Through the needs of their son, Ian, they were familiar with this type of adaptive equipment and how important it is to Luke and his family. The Mullendores were equally delighted about this grant and pleased to know their fund would be used to help improve the quality of life for Luke through this bike.



Luke has a sweet and happy spirit and loves wearing hats and watching people. He is a joy to all who know him, and his family is so grateful for the gift of this bike which will have a positive impact on his life. Montgomery County is truly a place where giving does more good.

"Luke really enjoyed going for rides last summer and we are looking forward to warmer weather when we can make full use of the bike this year. Last fall we already noticed that riding the bike increased Luke's muscle tone. By developing the muscles in his legs, Luke will be much more able to walk longer distances and be steadier on his feet. We can't thank MCCF and the community enough for enabling Luke to receive the bicycle – it has been, and will continue to be, such a blessing for Luke."

BUILDING affordable housing is the cornerstone of Habitat for Humanity's mission in a community. Habitat's vision is of a world where everyone has a decent place to live. Habitat works toward this vision by building and improving homes in partnership with individuals and families in need of a decent and affordable place to live. Their neighborhood revitalization efforts empower individuals, businesses, and organizations to gather, acquire resources, and create a thriving Montgomery County community. In 2023, during the building of two new homes, rising building costs hampered their efforts to complete both projects. A MCCF grant of \$35,000 enabled them to finish construction and move on to other projects.

Joe Tague, a Crawfordsville native, is now the proud homeowner of one of these recently completed homes. To him, this was much more than a project and it means the world to Joe to have a place he can call home. As the Habitat for Humanity volunteers worked diligently on his new home, he was inspired by their kindness and compassion. They showed Joe the skills they had developed over a lifetime, but more importantly, they showed him what can be accomplished by working together. They left a deep impression on Joe of the importance of giving back.

Joe's home was completed with the help of local Habitat for Humanity volunteers, and with the help of RV Care-A-Vanners. This volunteer program invites anyone who travels by recreational vehicle to participate in a Habitat for Humanity building project. Volunteers from Kansas, Texas, and Missouri traveled to be part of this construction.

Habitat for Humanity believes that God's love and grace is for everyone, and demonstrate that love and grace through their work. They put faith into action by helping to build, renovate or preserve homes, and by partnering with others to broaden access to affordable housing as a foundation for breaking the cycle of poverty. 1. *Why is high-quality child care vital to our community?*

A child's brain experiences 85% of development in the first five years of life, which is why it is incredibly important that each child have an opportunity to receive a high-quality early childhood education so that they are well-prepared to enter kindergarten and experience school success. A top priority of the Montgomery County Early Childhood Coalition is to help support high-quality early childhood education programs so that all of our children have an opportunity to grow and learn before starting school.

2. *What has been one of your major accomplishments as the MCCF Early Learning Director?*

In the last two years, 15 local teachers obtained their Child Development Associate credentials, and a few of those teachers are now in Associate and Bachelor degree programs. Our Coalition is also in our third full year of offering free professional learning series where attending teachers learn important information from experts in the field of early childhood education. Our workshops average 55-60 teachers at each session and it is remarkable to see the energy and engagement of our guests at each workshop.

3. *What's next for the Early Childhood Coalition?*

We will continue to support our local child care programs as we work towards promoting high-quality early education for all of our young children. We look forward to another amazing summer at Camp Milligan, our annual Early Learning Expo, and of course, the construction of the Montgomery County Early Learning Center!

MCCF was selected as a recipient of the Early Years Initiative from Early Learning Indiana. The Early Years Initiative is a \$50 million competitive grant program focused on enhancing the learning and development of infants and toddlers in Indiana communities. The generous support for this initiative comes from Lilly Endowment Inc.

Through this grant, MCCF received \$374,200 in funding to increase professional development opportunities for local childcare programs and partner with the City of Crawfordsville to expand the Project Swaddle and Project Bundle programs. The Early Years Initiative places special emphasis on serving families in low-income households. Project Swaddle and Project Bundle are home-visiting programs operated by the Mobile Integrated Health Department to improve maternal and infant health outcomes. Using community paramedics and registered nurses as physician extenders, the programs provide wrap-around care for perinatal mothers, infants, and their families who face health, social, and environmental challenges.

Another key component of the grant is professional development for local childcare programs. In 2022, MCCF launched professional development workshops for early childhood educators and with this grant, the workshops will provide focused training for educators serving children ages infant to three. This initiative aligns with the mission of the Montgomery County Early Childhood Coalition, a leadership initiative of the MCCF, which is to create a collaborative and high quality early childhood education system that supports development and early education.



CAMP MILLIGAN was back in action for its second summer of fun and learning! Camp counselors welcomed 40 full-time campers back to summer camp on May 31. All ten weeks of summer break at Camp Milligan offered new opportunities for learning and adventure. New at camp in 2023 was a fully-loaded STEAM lab. Each week held a different theme such as Animal Encounters, Art Investigations, and Time Travel. Campers and staff enjoyed many field trips that included local museums, the Indianapolis Zoo, Children's Museum, water parks, and so much more.

Camp Holly Jolly Days held its second winter session during the first week in January. Parents welcomed the opportunity for their children to participate in fun activities while school was out during Christmas break. Forty children attended and enjoyed field trips to the CHS Aquatic Center and Plaza Lanes Bowling. In addition, they joined in STEAM lab activities, arts and crafts, and burned some energy during open gym.

THE MONTGOMERY COUNTY EARLY CHILDHOOD COALITION (MCECC) welcomed nearly 60 early childhood educators to the third Annual Early Learning Expo. This free event was a time of celebration and appreciation for our local educators who work tirelessly teaching and caring for our youngest citizens. Held at the Masonic Cornerstone Grand Hall & Event Center, guests enjoyed visiting with several on-site vendors before entering the brightly decorated ballroom for the main session.



MCCF's Early Learning Director, Lisa Walter, opened the morning session and awarded five students who achieved their CDA and/or Associate Degrees. Mayor Barton attended and expressed support for the hard work and dedication of our educators. Keynote speaker was Desi Payne, a self-proclaimed "motivational humorist," and guests laughed along as she led them in a dance party. After the keynote address, Adriana Kincaid from Lakeshore Learning led a workshop designed to help teachers

develop further understanding of science in the early childhood classroom. Spark Learning Lab and Lakeshore sponsored 60 science kits valued at \$500 for every educator. In addition, the MCECC provided educational supplies and furniture for the grand prize giveaway. Teachers and staff from Crawfordsville Head Start won a set of Jumbo Magnetiles, Fuzzy Bear Preschool won a Toddler Treehouse, Happytown Daycare won a fully stocked Grocery Market, and Rainbows and Rhymes won a Mud Kitchen.



THE 2023 PROFESSIONAL LEARNING SERIES,

sponsored by the MCECC, provided four professional development workshops for local early childhood educators. Topics in these free workshops included social and emotional development for infants and toddlers, process art, self-care, and positive classroom guidance. The workshops were held at the Hoosier Heartland State Bank Success Center and included a complementary dinner and supplies. The purpose of this learning series is to strengthen and support our network of child care providers.



1. How and when do I apply for a MCCF scholarship?

Applications for the Lilly Endowment Community Scholarship typically open in early August, then all other MCCF scholarships open in mid-October. The best part? The entire process is online! Students can visit our website at www.mccf-in.org/scholarships to see what awards are available and the most current application information.

2. Do I have to be attending a four-year college to receive a MCCF scholarship?

Not at all. Our donors support students pursuing a variety of educational paths after high school. We offer scholarships for technical and vocational programs, as well as two-year degrees. In addition, a handful of non-traditional scholarships are also available for those who are not high school seniors.

3. Do I have to show financial need in order to apply for a MCCF scholarship?

If a student is eligible for a scholarship that takes financial need into consideration, they will need to submit their FAFSA Student Aid report. If they aren't, then no financial information is required to apply.

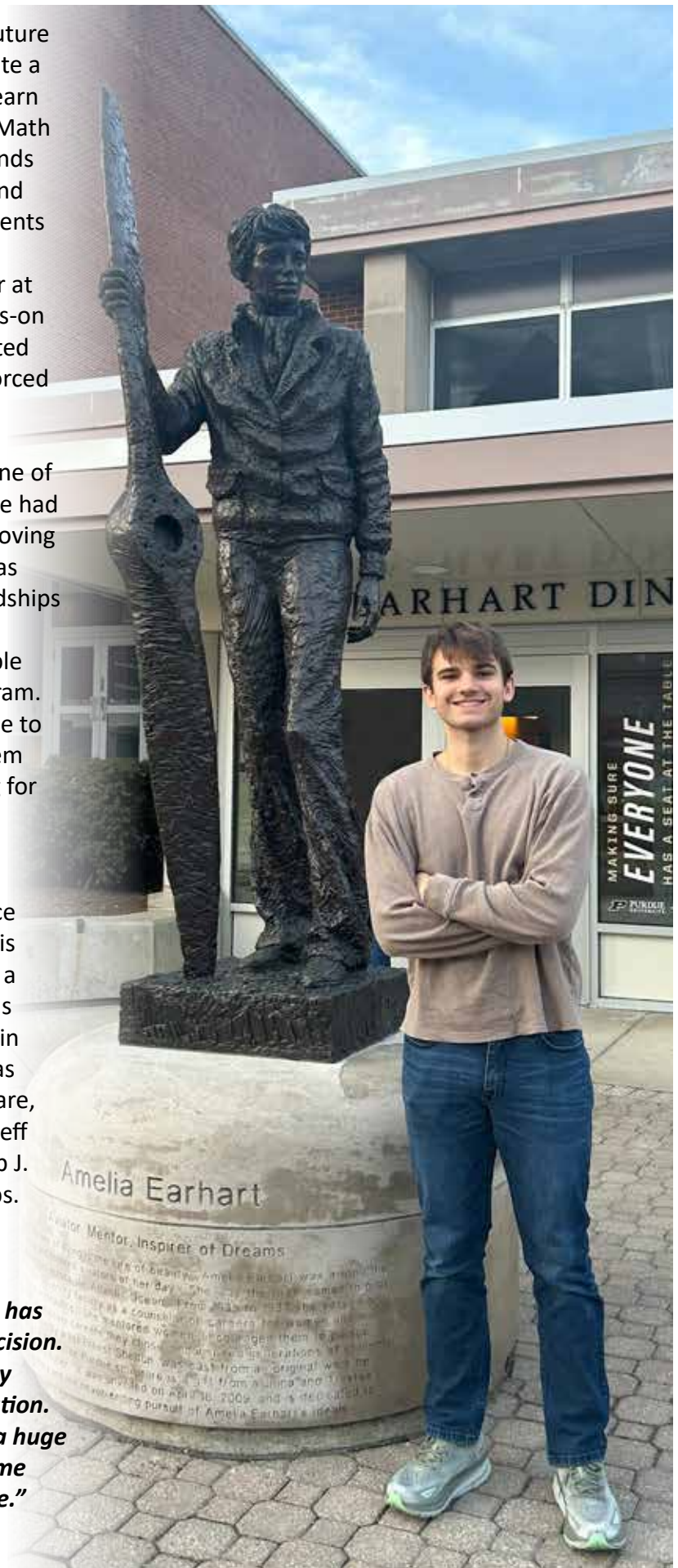

THE FUTURE looks bright for students enrolled in the Willson Preschool Academy. As these young minds are eager to learn and explore, new quality learning materials are already put to good use. New flooring and preschool furniture provide a safe and comfortable learning environment with cots, coat cubbies, and storage units suitable for small hands. New research-based curriculum, as well as support for professional development to implement the new curriculum, are now in place. These improvements are beginning steps in a long-term plan to make preschool programming more accessible, and were made possible through a recent MCCF grant award of \$52,503.

Both the furniture and curriculum were necessary in order to become Paths to Quality certified through the State of Indiana. This certification not only deems a program as high-quality, but also allows them to accept Child Care and Development Fund (CCDF) and On My Way Pre-K vouchers available to low-income families. The Willson preschool expansion project aims to build a foundation for the future in Montgomery County through access to free quality childcare and preschool to an estimated 100 economically disadvantaged students.

Students will reap the educational and social-emotional benefits of early childhood education and will be better equipped to enter kindergarten. Economically disadvantaged parents who were not able to work because they were not able to afford childcare, will now be able to obtain full-time employment empowering them to end the cycle of poverty. The growth of this program will not only benefit students and families, but will create job opportunities for Montgomery County citizens. The Willson Preschool Academy is dedicated to educating and nurturing preschool-aged children to prepare them for successful school experiences and life-long learning. The preschool also supports the involvement of parents and community as partners in education. Montgomery County is a place where giving does more good for the youngest of our citizens.

The Bokhart Family Fund

Brent and Jessica Bokhart moved to Crawfordsville in 2011 after seeing the sense of community through the school system. Upon moving here, they immediately felt at home and welcomed, and quickly became involved in the community. Brent taught math at Crawfordsville Middle School where he eventually became Principal, but now serves as Assistant Superintendent with the Crawfordsville Community School Corporation. Jessica's career is with Market Street Wealth Management Advisors where she is a Managing Partner. Jessica also volunteers on several nonprofit boards and committees, and is a former MCCF board member. Their two children, Carli and Carter, are very involved in sports and school activities, and are active members of 4-H. They all enjoy traveling, attending sporting events, and visiting local museums. The Bokhart family established this unrestricted fund because they understand the value in giving back to their community, as well as the value that MCCF brings to the community through grants and scholarships.



The Dr. Robert E. Brower Educational Scholarship Fund



The Brower family is deeply connected to and supportive of public education. Their entire family has been involved with educational programs, both professional and personal. Dr. Robert E. Brower served as Superintendent of North Montgomery Schools prior to his retirement. He truly loved his years at North Montgomery where he made many deep and lasting friendships. However, his passions and interests were not limited to education; he was a coach, an accomplished teacher, artist, and author. Dr. Brower was a first generation college student, and was particularly proud of achieving his PhD. Most importantly, he was a man who dearly loved his family. It will provide support to North Montgomery graduates who are pursuing a degree in education, or who are first generation college students. The Brower family is grateful to this community for their support and encouragement over the years, and this fund will continue to give back to others, while honoring the rich legacy of Dr. Brower.

The Marilyn J. Davidson Scholarship Fund

Marilyn Davidson was a local teacher and coach, and a groundbreaker in establishing girls' high school sports. Marilyn taught physical education, health, and drivers' education classes at Crawfordsville and Southmont high schools. She coached girls' volleyball, basketball and track teams, and sponsored cheerleading, pep block, and the Girls Athletic Association. She owned her own farm in the Whitesville area and loved working outside there in the summer. When Marilyn retired from teaching and coaching, she and her nephew, David Davidson, opened Davidson's Greenhouse, which continues in operation. In honor of her dedication to teaching and coaching, her beloved niece and nephew established this scholarship fund in her memory. The fund will provide scholarships for female graduates of Southmont or Crawfordsville High School who are pursuing a degree in Education.



The Durham Home Inc. Scholarship Fund



The Durham Home is an historic manor built in 1900 by George and Sarah Durham and located on West Main Street in Crawfordsville. Sarah was a kind and generous lady, and a prominent resident of this area. Upon her death in 1937, she bequeathed her beautiful home and established a trust for the purpose of maintaining the home as a ladies residence for independent women. Today, Durham Home Inc. operates as a nonprofit organization and oversees the home. The Durham Home Inc. Scholarship was established in 2020 to further impact Sarah Durham's mission to embolden women. In 2023, the Durham Home Inc. Board of Directors established this scholarship fund at MCCF. It

is their wish to support local women pursuing education to better themselves and their contributions to the community. Each year, the scholarship provides support to a female graduate of a Montgomery County school who is accepted to a college or university in the State of Indiana in a degree program.

The Scott and Wendy Feller Fund

Scott and Wendy Feller are third generation livestock farmers originally from Oregon. In 1998, they moved to Montgomery County where they settled and raised a family. Scott is the President of Wabash College, and together they operate Silver Valley Farm where they raise sheep. Wendy makes soap and wool products and sells their lamb cuts at Four Seasons Local Market, a store she helped found in 2016. When away from the farm, they enjoy hiking and traveling to national parks with their Border Collie. Their passion to provide for their community goes beyond their farm; Scott served on the MCCF Board of Directors, and Wendy is currently serving. Through these experiences, they have seen the benefits that others receive through MCCF grants and scholarships. They are so grateful for the support they receive in this community, and established this unrestricted fund as a way to give back and help others in need.



The Darlene Harmon Early Childhood Education Fund

Though Candi Harmon Kruse no longer lives in Montgomery County, this community will always be home, and she comes back often to visit family. Inspired by the plans to construct the Montgomery County Early Learning Center, and aware of the struggles to find high quality early childhood education, Candi wanted to make a difference. Friends that remained here remarked that they were cobbling together babysitters or exiting the workforce entirely due to lack of childcare options. Candi is passionate about education; she currently serves on a local school board, a public library board, and a literacy center. Her involvement with several nonprofit boards showed her the importance of having endowed funds to meet future needs. Those factors combined to inspire Candi to start something in the area of education here in her hometown. Her maternal grandmother, Darlene Harmon, always stressed the importance of education, and so it seemed a good fit to establish this fund in her honor. Candi is certain she would be pleased to know this field of interest fund will provide broad support in the area of early childhood education. Candi and her husband, John, and their two children currently reside in Pennsylvania.



The Richard (Beck) and Elsie M. Lane Fund



Elsie Bradley Lane grew up in the Wingate community and was one of five graduates in the 1947 graduating class from the Wingate High School. After high school, Elsie went to Indiana Business College and graduated from there as a private secretary. She married Richard "Beck" Lane in 1950 and together they owned and operated the New Richmond Hardware. Richard also drove a school bus, and Elsie worked as a secretary, retiring from Ingress Plastene after 23 years. Jeff passed away in April 2020, and even though it happened in the midst of the pandemic, his family felt the overwhelming love and support of this community. They desired to give back over time to a community that gave so much to them in their time of greatest need. In loving memory of Jeff, and in honor of his love of sports and generous spirit, his family established this athletic scholarship fund. The fund will provide support to a Montgomery County high school graduate who has participated in at least two sports during their high school career, and earned at least one varsity letter.



The Mike and Sheila McCormick Fund



Lifelong residents of Montgomery County, Mike and Sheila McCormick have faithfully served and supported this community. They were high school sweethearts, and as Sheila headed to college, Mike went on to serve in the Army for four years. After undergrad work and the Army, they married in the Wabash Chapel. They lived, worked, and raised their son, Christopher, in this community. Mike retired from his career at Pace Dairy, and Sheila retired after 40 years of teaching visual arts at Crawfordsville High School. Both continue to volunteer at various local nonprofit organizations, and Sheila currently serves on the MCCF Board of Directors. They chose to establish an unrestricted fund because they know that needs change over time, and this type of fund allows the MCCF Board the flexibility to meet the most pressing needs. Mike and Sheila's parents instilled in both of them to always be willing to help others, give back, and be grateful and kind.

The Greg and Nancy Morrison Fund

Greg Morrison has many great stories and memories from growing up in Montgomery County. His roots go deep, and his family still owns farm ground that dates back to the 1830s. Greg delivered newspapers to the downtown area in the early 1960s, participated in high school sports, and has owned multiple local businesses. His early career began at family-owned Morrison Automotive Supply in 1967, and eventually he became a real estate broker and currently owns Morrison Realty-Keller Williams. Greg has been involved in many local organizations and served on several boards, all in a desire to give back to this community that he loves. He and his wife, Nancy, established this unrestricted fund as one more way to continue giving back and support the community that has supported them throughout the years.



The Wade Nixon Fund

Wade Nixon, a lifelong resident of Montgomery County, had deep ties to this community where he was born and raised. 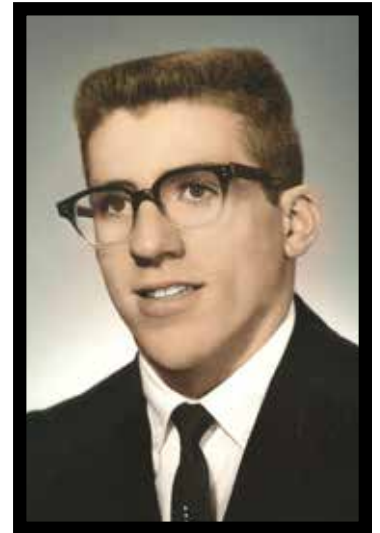
The Stewart-Sweek Family Fund

The Frances Wooden Park Fund



Through funding from the MCCF and the City of Crawfordsville, the Frances Wooden Park underwent a major overhaul during the summer of 2023. The park is located at the 200 block of West North Street, Crawfordsville and has historical significance. It sits adjacent to the Bethel AME Church, which was a stop on the Underground Railroad. The park is named in honor of Frances Wooden who was Director of the Northside Rec Center for over 35 years, and known as an advocate for neighborhood children. Newly installed benches act as a historical timeline, with notable dates and facts etched into the bases. Play structures, a shelter, and interactive musical pieces

are just a few of the many other improvements made during the renovation. An anonymous donor established this fund which will provide support to the City of Crawfordsville to maintain the park.

The Jarrod and Crystal Zachary Fund

Jarrold Zachary was initially introduced to the MCCF through the Montgomery County Leadership Academy. After further discussions and learning more about our overall work in the community, Jarrod and his wife, Crystal, decided they wanted to contribute. YEARS AGO, love was in the air at a Valentine's Day party where a blind date resulted in a lifelong marriage for Bill and Becky Degitz. Rebecca Jane Wray Degitz was born in 1921 and lived to be 102. She grew up in the town of Darlington, but her family also had a farm southeast of town. She graduated from Darlington High School in 1939 and later graduated from DePauw University where she studied sociology. Becky worked as an exit interviewer at RCA during the war, but proudly spent the majority of her married life as a wife and mother to their two children.



William Bates Degitz was born in 1920 in Chicago, and passed away in 2012 at the age of 92. He received his BA from Wabash College and later received his MBA from the Harvard Business School. Bill served in the Army during WWII, and about ten days after returning home from the war, Bill and Becky were married. Other than the 11 years that separated them in death, they were together for 66 years. Bill eventually returned to his alma mater in 1955 where he served as Business Office Manager for Wabash College, retiring after 27 years.

Bill and Becky firmly believed in doing what they could to make this community better. They never tired of attending concerts, plays and sporting events at Wabash. They delivered Meals on Wheels, and helped establish the Wesley Thrift Shop and the Christian Nursing Service. Bill served on the MCCF Board of Directors, which was a perfect fit for his desire to see the community prosper. Bill and Becky were active members of the First United Methodist Church, and quietly volunteered and were involved in a variety of nonprofit agencies and service clubs.

They established the Damon C. and Bernice Seaman Wray Unrestricted Fund in 2002 in memory of Becky's parents, whom they wanted to honor for their kindness and thoughtfulness. Since 2004, nearly \$34,000 in grant awards have provided support to a wide variety of areas in Montgomery County. Some examples include Darlington Forever, Habitat for Humanity, Art League, local preschools, Lew Wallace Study and Museum, and many more.

Their love for this community did not end with their deaths. Bill and Becky left a bequest to the MCCF adding to their endowed fund, which will continue to grow and increase in grant awards. Though they delighted in knowing how their fund benefitted the community during their lifetime, their bequest was a selfless way to continue sharing their lives and their generosity with people they will never meet. As Richard Strawn, Professor Emeritus, once said, "Bill saw money as a good with which to do good." Indeed, they both did, and we are grateful to the Degitz' and their legacy of love for this community.

OUR COUNTY is home to a beautiful water trail called Sugar Creek. Friends of Sugar Creek is an organization dedicated to protect, restore, and promote appreciation of Sugar Creek and its watershed. The creek is recognized as one of the best kayaking/canoeing rivers in Indiana. Friends of Sugar Creek is active in the community to educate and raise awareness and share any concerns related to the health of the creek. They organize two creek cleanups per year to clear debris, sponsor the Sugar Creek Canoe Race, and offer a free Family Float Trip. They also offer a free educational program called “Kids, Canoes, and Crinoids” for kids ages 9-14.

In order to continue offering free public programs to access the creek, to gain knowledge of the creek as a natural resource, and to teach basic skills, they needed to replace their aging canoes. A MCCF grant of \$13,500 provided the purchase of 10 new canoes to help support their mission to protect, restore, and promote appreciation of our beautiful natural resource.

TYPES OF FUNDS

THINK BROADLY Unrestricted Funds

Unrestricted funds offer the broadest giving option, including future needs that often cannot be anticipated at the time your gift is made. This fund allows the MCCF Board of Directors the flexibility to provide grants where community needs - and impact - are greatest. All aspects of community well-being are considered: arts and culture, community development, education, health and human services, historical and more. Fund minimum is \$5,000.

STAY INVOLVED Donor Advised Funds

A Donor Advised Fund allows you to make non-binding grant recommendations to the MCCF Board of Directors, thus allowing you more interaction with your fund. We manage the grant process and ensure accountability. Fund minimum is \$5,000.

ADDRESS ISSUES Field of Interest Funds

A Field of Interest Fund allows you to choose a particular area of charitable interest that you would like to support. The MCCF Board of Directors then identifies the most qualified local charities which work to support your area of interest. Fund minimum is \$5,000.

INVEST IGNITE IMPACT

EXPAND ACCESS Scholarship Funds

A Scholarship Fund provides assistance to Montgomery County students. Scholarship criteria may be broadly, or narrowly defined, as you choose. Please note that for administrative reasons, scholarship funds require a minimum of \$25,000.

TARGETED SUPPORT Designated Funds

A Designated Fund provides a wonderful way to give back to one or more specific organizations that have touched your life. A designated fund allows you to choose specifically the charity, or charities, that you wish to support. Your gift provides the organization you choose with a permanent source of reliable funding, creating long-term impact. Your organization will also benefit from the MCCF's investment stewardship and ability to manage endowment funds. Fund minimum is \$5,000.

BUILD YOUR FUND Pathway Plans

A Pathway Plan is a planned giving agreement that allows you to build a named fund over five years. You may establish the fund immediately with a minimum of \$1,000 and add to it over five years until it reaches \$5,000 and becomes an endowed fund.

It is not an easy task to choose just one as all nominees are worthy and deserving of the honor.

The 2023 MCCF Volunteer of the Year was awarded to Nancy Sennett, who was nominated for her service to the Montgomery County Free Clinic. After a long and successful career in healthcare, serving on the Free Clinic’s board seemed the natural way for Nancy to share her time and talents in the community. When an unexpected health emergency caused the then MCFC Executive Director to step down, Nancy resigned her board role and took on the director’s position in a volunteer capacity. During that time, the board restructured staffing, developed a resource development plan, and searched for and hired the clinic’s first dedicated chief executive. Nancy’s leadership during that pivotal time kept the clinic running smoothly while maintaining the highest standard of care for patients. MCCF Board President Jim McBee presented her with a plaque commemorating her service, and a \$1,000 grant was awarded to the Free Clinic in her honor.

Other nominees were Amy Cochran for the Youth Service Bureau, Sally Gooden for the Animal Welfare League, Mary Sue Measel, for Pam’s Promise, Mike Reidy for the Masonic Temple Foundation, Karen Thada for Crawfordsville Main Street, Ann Watson, for the Public Library, and Dick Young, for Grace and Mercy Food Pantry.

The 2023 Peggy Herzog Youth Volunteer of the Year was awarded to Melanie Dowd for her service to The Kid’s Closet. For two years this young teen has been doing laundry, tackling three to six 33 gallon bags of clothes at a time. She washes it, dries it, and neatly folds it, and then returns it to The Kids Closet to be distributed to children in need. A real leader, she has recruited her school friends to help too. They have made new labels for storage totes and are organizing a clothing drive. President McBee presented Melanie with a plaque commemorating her service, and a \$1,000 grant was awarded to the Kid’s Closet in her honor.

1. What are some of the basic responsibilities of a board member?

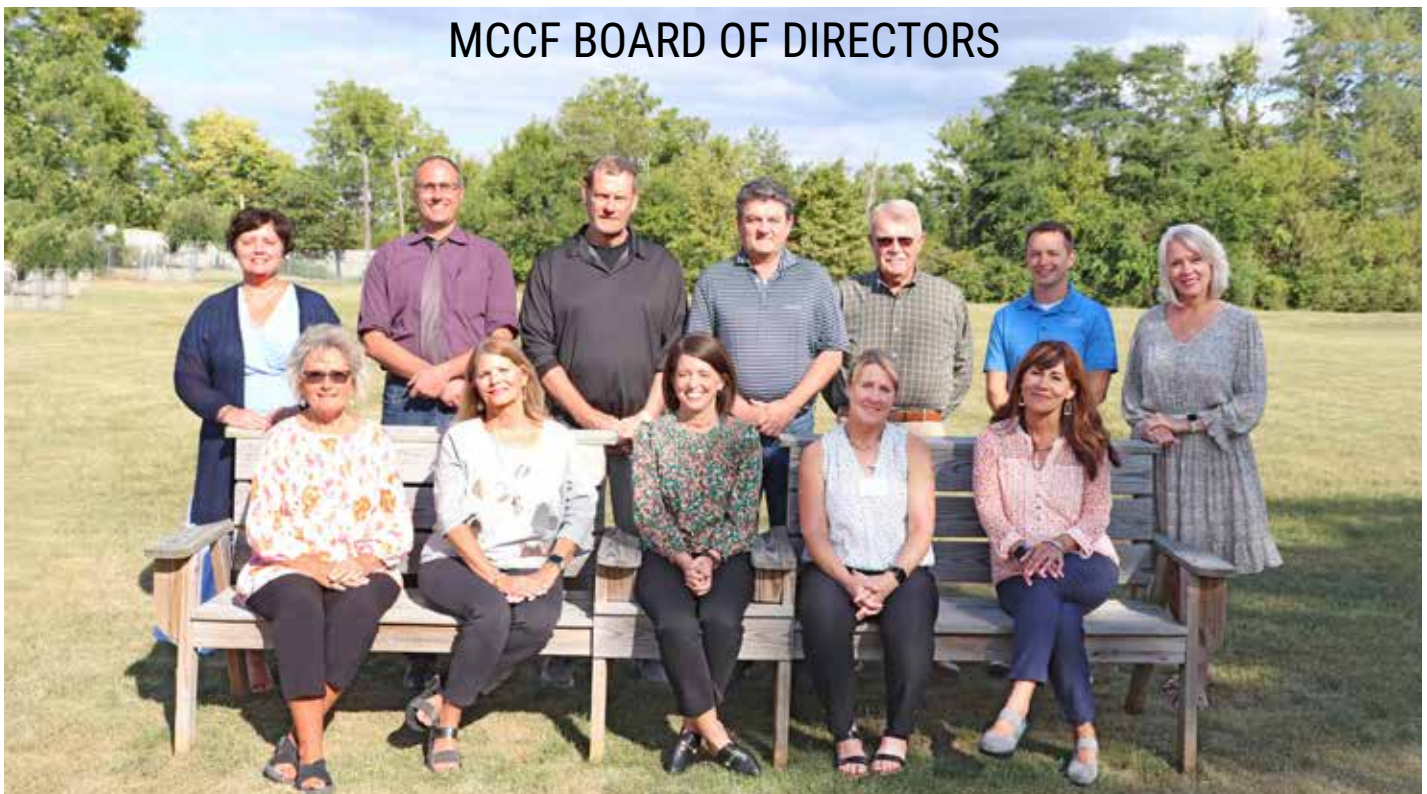
Attend board meetings, and committee meetings as assigned, and review the agenda and supporting materials prior to the meetings. Stay informed about MCCF's mission, vision, services and policies. Be an ambassador for MCCF in the community. Make a personal financial contribution. Carry out the Foundation's fiduciary responsibilities by ensuring proper financial controls are in place, and by providing prudent oversight of our resources.

2. How are board members chosen to serve?

The MCCF Board of Directors elects a nominating committee consisting of one current board member and four non-board members to make recommendations to fill expiring board positions. Those recommendations are presented at the Annual Meeting and voted upon. One of the most important characteristics of a board member is that they have an active interest in our community and a desire to make Montgomery County the very best it can be.

3. Why do we need a community foundation?

Since awarding its first community grant in 1992, MCCF has been Montgomery County's partner for positive change. The community foundation has truly made an impact in our community. Grants totaling more than \$29 million have made it possible for local students to go to college, for community history to be saved, and for the diverse needs of our neighbors to be served. We're proud of what we've been able to accomplish, and we're most proud of the founders and board members who have had the vision and wisdom to make it happen.

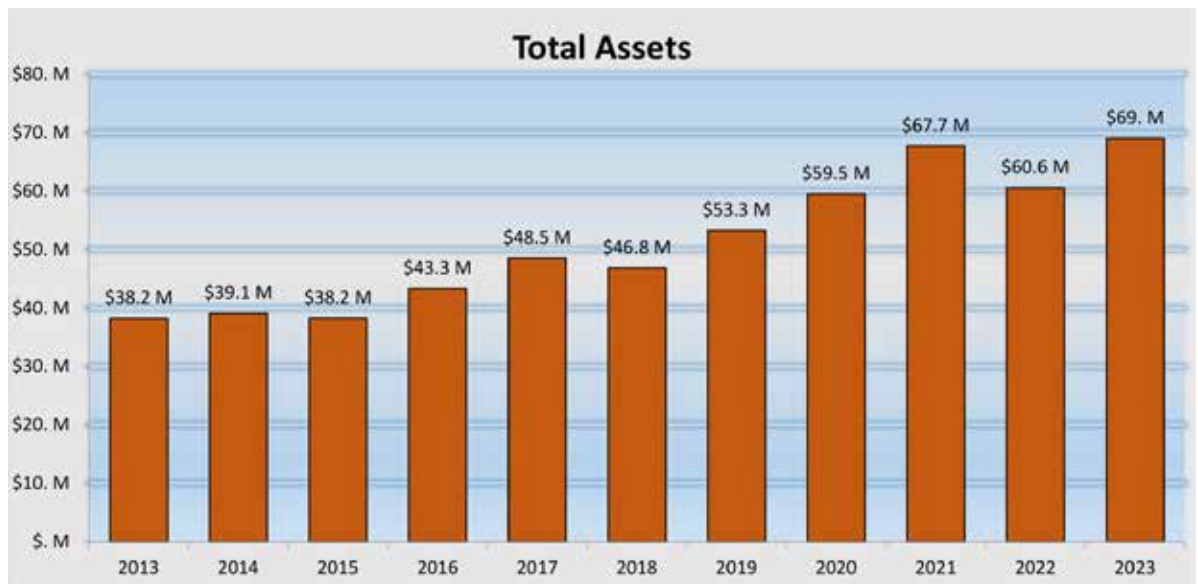
Questions & Answers

1. How is the amount available for grantmaking from a fund determined?

MCCF’s current distribution policy is 4.5% of a 20 quarter rolling average of a fund’s market value determined as of September 30th each year. That 4.5% is used for fees and grantmaking. For example, an unrestricted fund with a 20 quarter rolling average of \$25,000 will have \$825 (3.3%) available for grantmaking annually, and pay \$300 (1.2%) in fees.

2. How does MCCF invest the funds?

MCCF uses a professional investment manager who follows our investment policy and commitment to our donors that their funds stay endowed forever. The primary objective of our investments are to provide for long-term growth of principal and income without undo exposure to risk.

3. How does MCCF differ from a private foundation?

We receive funds from a large number of donors, whereas a private foundation generally has one single major source of funding. Community Foundations also offer more favorable tax deductions compared to private foundations. Our non-compensated board is made up of community members that know the needs of our community and strive to maximize the impact of our grant making dollars. The trustees of a private foundation must make decisions on their grant making from afar based on their own research and evaluation.

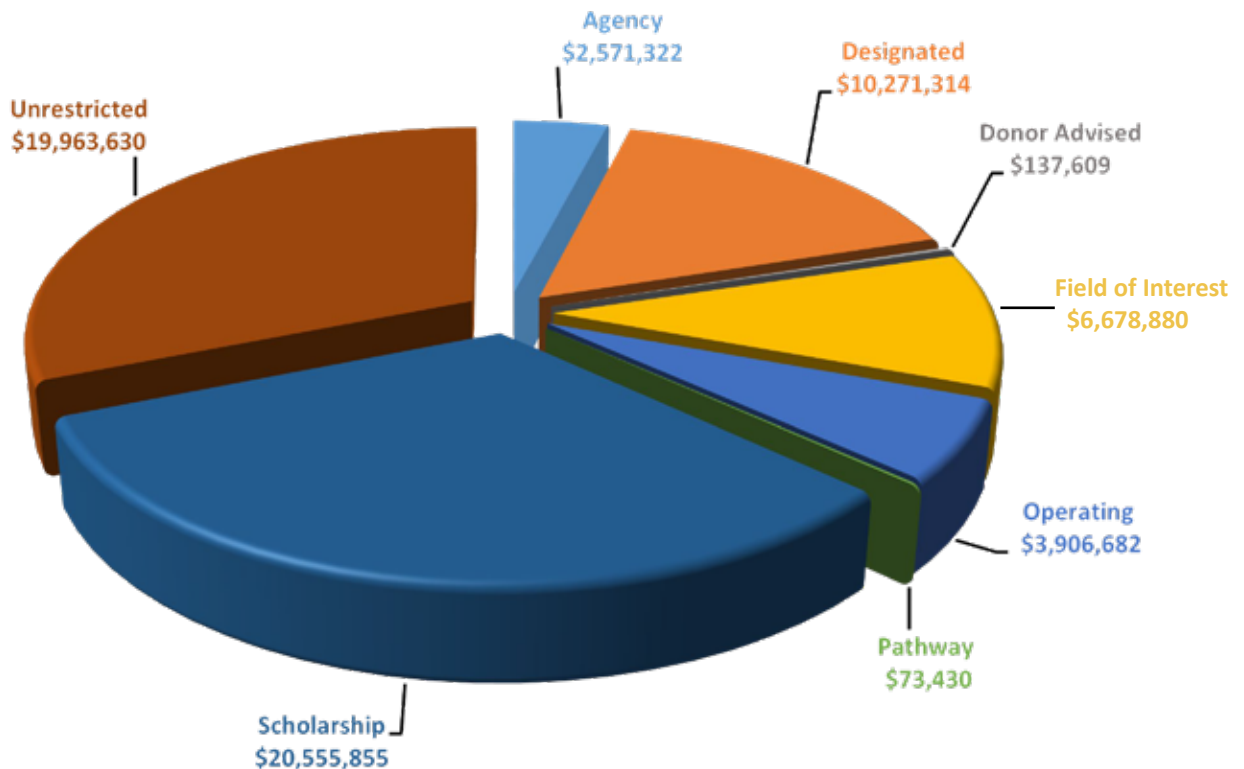

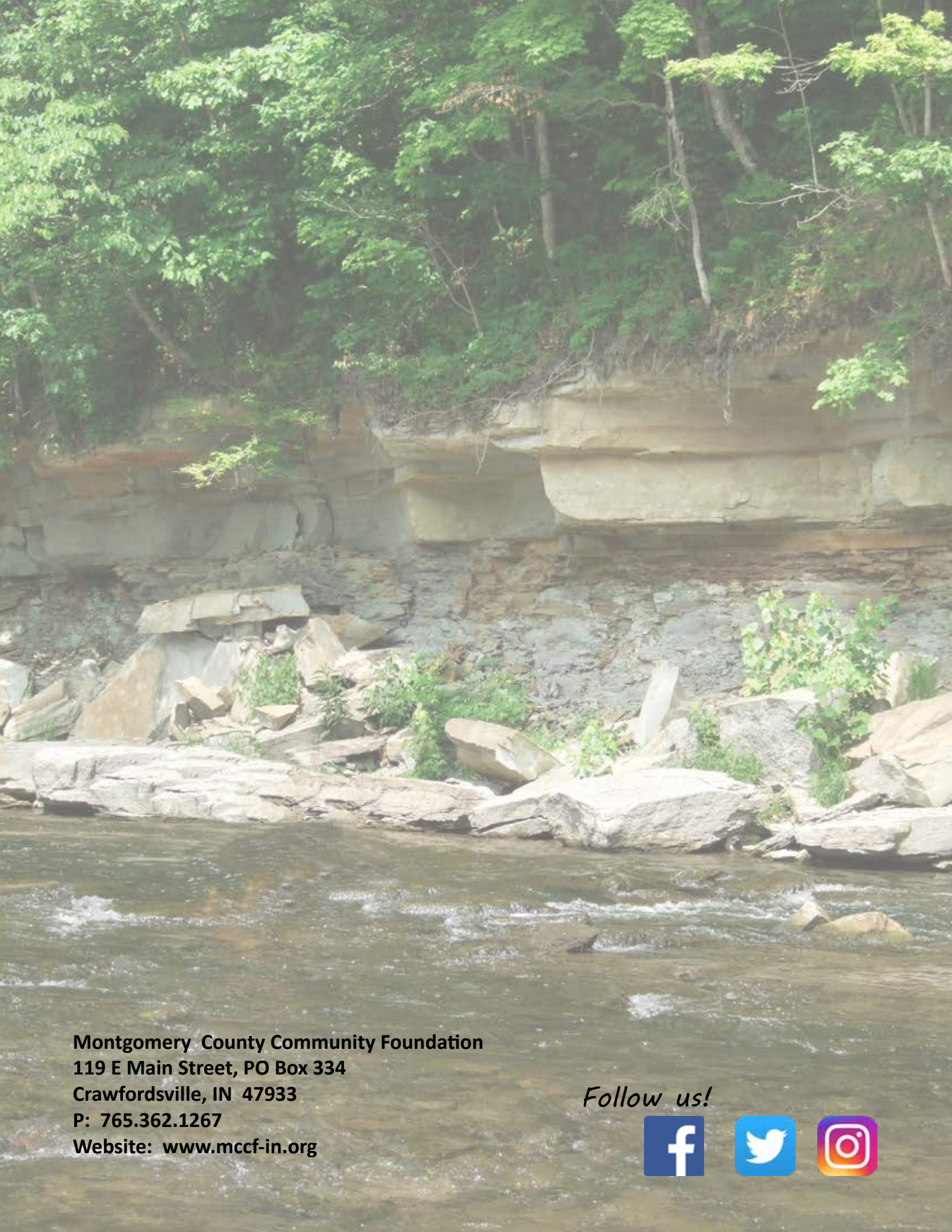
