VISITORS CAMPING AT THE JOHNSON COUNTY PARK ARE REQUIRED TO OBSERVE THE FOLLOWING RULES. THE JOHNSON COUNTY PARK DEPARTMENT, ACTING THROUGH ITS DESIGNATED REPRESENTATIVES, HAS THE AUTHORITY TO REFUSE ADMITTANCE TO THE CAMPGROUNDS TO ANY INDIVIDUAL DETERMINED IN THE DEPARTMENT'S SOLE DISCRETION TO POSE A THREAT TO THE HEALTH, SAFETY, WELFARE OR ENJOYMENT OF ANY PERSON UTILIZING THE CAMPGROUNDS OR THE PROPERTY OF THE JOHNSON COUNTY PARK DEPARTMENT. VIOLATION OF THESE RULES WILL RESULT IN THE IMMEDIATE REVOCATION OF A PREVIOUSLY ISSUED CAMPING PERMIT. IN THE EVENT A PERMIT IS REVOKED, ALL DEPOSITS AND FEES PAID BY THE VIOLATOR SHALL BE FORFEITED AND SHALL BECOME THE SOLE PROPERTY OF THE JOHNSON COUNTY PARK AND RECREATION DEPARTMENT AND YOU WILL BE ASKED TO LEAVE IMMEDIATELY. ALL CAMPERS SHALL COMPLY WITH ALL FEDERAL, STATE & LOCAL LAWS AND ORDINANCES.

REGISTRATION ● All campers must register and pay for a site before setting up. Payments for multiple nights must be kept up to date. Payments for additional nights must be received before check-out at 2pm. Make reservations at the Park Office or call 812-526-6809. If the Park Office is closed, you can pay using the office drop box or through an on-duty Camp Host, if available. Payments made through the drop box are your responsibility. **Absolutely no arrivals are allowed after 10PM.** All campers under the age of 18 must be accompanied by an adult. Check out/in time is 2PM Monday through Saturday, and 5PM on Sundays and holidays. **Any individuals that are currently on the sex offender registry are prohibited from camping in Johnson County Park, any violators of this policy will be asked to leave.**

RESERVATIONS ● The name and information on the reservation **MUST** match the person staying on the site. All reservations require payment within 7 days. Call: 812-526-6809 for more information. Reserved sites will be turned on and tagged prior to your arrival. ***2 night minimum stay on select Holiday and event weekends***

FEES ● The fee for in-season (April-October) standard camping, per night is \$30 plus tax and fee for full hook-up camping, per night is \$45 plus tax. The fee for off-season (November-March) camping, per night is \$25 plus tax. Only ONE unit is allowed per site. **No refunds will be given. We do allow for credits, but cancellations must be received 24 hours ahead of each night you are staying.**

LENGTH OF STAY ● Campers may stay for 14 nights, and then must break camp completely for 7 days before returning. Switching names within the same party, or leaving early to lengthen stay is not allowed.

SITE RULES ● All campsites are to be maintained and kept clean and tidy. Hanging items in trees, leaving out trash and items scattered amongst the site is not allowed. **Trash must be disposed of in the dumpsters. Gray water must be disposed of at the campground Dump Station. Fire rings are not to be moved.** Return picnic tables to their original location if you move them during your visit. Any park property that has been damaged or is missing will be the responsibility of the registered camper. Vehicles and ANY items (bags, coolers, etc) left on sites that fall into arrears or left after the camper has checked out are considered abandoned and will be removed and disposed of at our discretion. **Water use cannot exceed camper use.** Washing vehicles and washing laundry at water sources is not allowed. Use of kiddie pools must be approved by Superintendent. Sites are reserved for camping in vehicles designed for camping. Camping in vehicles not designed for camping, such as, passenger cars, cargo trailers, horse trailers etc., is prohibited. Any converted/conversion campers are at the discretion of the Parks Superintendent, any vehicle can be denied. **All fireworks, with the exception of sparklers, are prohibited in Johnson County Park. Working on vehicles and/or RV's is STRICTLY PROHIBITED, unless discussed with the Superintendent.**

VEHICLES ● RVs and vehicles are to be located on gravel campsite pads and assigned parking only. No non-operating or unlicensed vehicles are allowed. **A limit of two vehicles is allowed per campsite area.** Please use designated areas for overflow parking. ALL vehicles must obey posted speed limits. Driving cars and campers off road is prohibited. **Working on vehicles and/or RV's is STRICTLY PROHIBITED, unless discussed with the Superintendent.**

GOLF CARTS ● JCP Golf Cart Permits **MUST** be clearly visible on your cart before operating them on park property and users must follow all associated rules. Permits can be purchased in the Park Office for \$10 and are valid for the entire season. ALL vehicles must obey posted speed limits. Driving carts on the cross country course and east/west fields is strictly prohibited.

PETS ● Animals cannot be left unattended and must be kept on a leash. If your pet becomes a nuisance or a danger to other pets or campers, Johnson County Park staff will require you to remove your pet from the campgrounds. Pet waste must be removed immediately. Any animal left in unsafe conditions will be addressed by Johnson County Animal Control.

QUIET HOURS ● Campers must observe quiet hours in the campground from 11PM-6AM.

SHOWERHOUSE ● Please contact the Park Office or camp host to get the showerhouse code. A Port-O-Let is available 24 hrs. a day.

FIREWOOD ● **No wood can be gathered from the park grounds.** The burning of treated wood, trash, building materials, furniture, pallets, etc. is prohibited. Wood can be purchased from the park office or campground host for \$7.00/bundle plus tax. All fires must be contained in designated sites. If a fire ring is not at your site, please use the existing burn scar.

EMERGENCY ● In case of a maintenance emergency, please call: 812-414-6200. Non-emergency situations can be brought to the attention of the Camp Host or Park Office if available. You may also decide to call the Sheriff's Non-Emergency Dispatch at 317-346-6336. If there is a life-threatening emergency, call 911. Camp Hosts may be located on site 35 or 36. On duty host will have a sign posted at their site.

AS OF 2017- NO TENTS ARE ALLOWED IN THE CAMPGROUND. THIS INCLUDES TENTS PLACED ON RV SITES. SCOUT GROUPS IN TENTS ARE ALLOWED WITH PRIOR RESERVATION.
