It'sMe247 Online Banking lets you check your account balances, transfer funds from one internal credit union account to another, make loan payments, download cleared checks for free, and much more. This FREE service allows you to access your account anytime and anywhere you have internet access. To set up It'sMe247 Online Banking contact Viriva for your temporary login information then visit VIRIVA.COM and click on the Online Banking login button.

Electronic Bill Pay (EBP) lets you pay all of your bills in minutes. Funds are automatically deducted from your Checking Account. Download and print canceled checks for free. Best of all, if your payee cannot be paid by electronic check we will print and mail the checks at no cost to you. The service is FREE* when you use it to pay at least one bill per month.

eStatements are free and allow quicker access with increased security. One of the most common ways thieves steal your personal information is by going through your mailbox! Reduce paper and clutter, and protect your personal information! Enroll online and choose the eStatements option.

Direct Deposit/Payroll Deduction

Overdraft Coverage Options

Before you perform a transaction on your account, always try to make sure you have sufficient funds available so as to avoid overdraft fees or declined transactions.

Viriva understands that life happens and unexpected overdrafts may occur from time to time. The best way to avoid overdrafts is to practice good account management, but overdraft protection services can help.

Overdraft protection services apply to all types of transactions and may help protect your account from being overdrawn by automatically transferring funds to your Checking Account from another account, or line of credit you may have at the Credit Union, for a fee or finance charge. We offer:

1. Overdraft Protection linked to another Deposit Account you have at the Credit Union for a \$1.00 fee per transfer. To learn more about these plans, please call or email us at info@viriva.com.
2. You can also apply for an Overdraft Protection Line of Credit. This service is subject to credit approval and carries a \$1.00 per transfer charge + interest.
3. When Overdraft Protection resources are exhausted, Overdraft Privilege is available on eligible accounts to cover overdrafts for a \$30 Overdraft Fee per item paid.¹

Overdraft Privilege allows you to overdraw your account up to the disclosed limit for an Overdraft Fee in order to pay a transaction. Standard Coverage includes checks, ACH, recurring debit card transactions, teller transactions and telephone and internet banking.

For added coverage members can choose Extended Overdraft Privilege coverage. With your consent, ATM and everyday debit card

transactions will be authorized and paid with your Overdraft Privilege limit, in addition to the transaction types listed under Standard Coverage. If you want us to authorize and pay overdrafts caused by ATM and everyday debit card transactions (Extended Coverage), log in to It'sMe247 Online Banking, then under the 'My Accounts' tab select 'Overdraft Services to update your preference, or contact us directly.²

Make purchases at many retail locations using credit or debit and the funds will be drawn directly from your account. You can also access your account surcharge-free at any CU\$ Network ATMs.

- Get "Cash Back" through PIN based transactions at select retailers to avoid ATM surcharge fees.
- Receive up to 12 free PIN based transactions per month⁴

¹The fee amount is subject to change. Provided to members with a consumer checking account in good standing 30 days after account opening, or 60 days after account opening for business checking accounts. We pay overdrafts at our discretion, which means we do not guarantee that we will always authorize and pay any type of transaction. There is no limit on the total fees we can charge you for overdrawing your account. Overdraft Privilege may be discontinued if you default on any loan or other obligation to us, your account becomes the subject of any legal or administrative order or levy, or if you fail to maintain your account in good standing by not bringing your account to a positive balance within thirty (30) days for a minimum of one business day.

²You can revoke your authorization for Viriva to pay ATM and everyday debit card transaction overdrafts at any time by contacting us directly. Your revocation must include both your name and your account number so that we can properly identify your account.

³Card must be used at least once every 6 months to avoid an inactivity fee.

⁴The ATM must be a part of the Jeanie or CU\$ network to avoid surcharge fees (Please note: Not all ATMs in the Mastercard Jeanie network are surcharge free). The first 12 transactions per month are free for members who have full-pay direct deposit or who were previously designated as a Pioneer Club member, otherwise the first 8 transactions per month are free for all other Mastercard Debit Card holders. PIN based transactions made in excess of the 12 and 8 free transactions allowed per month will be charged a \$1.00 fee per transaction.
