2024-2025 ASSOCIATE CHAPTER FEE SUMMARY

Delta Upsilon's fee structure is one of the most competitive amongst men's college fraternities. For fees assessed to an associate chapter and its members, please review the chart below.

Initial Associate Chapter Member Fee	Associate Member Pin, Copy of <i>The Cornerstone</i> , and administrative processing.	\$150 per member. One-time fee.	At the time of recognition or within 24 hours after becoming an associate chapter member. Provides for the Membership Fees and the Liability Insurance Assessments for the term until the Associate Chapter Ceremony.
Member Fees	Expansion staff and Leadership Consultant visits, IHQ resources, educational programs, website resources, recruitment assistance, alumni lists, printed materials, and support programs.	Fall - \$110 per member based on member roster as of Aug. 19. Spring - \$110 per member based on member roster as of Jan. 7.	The members will remit the same Membership Fees as undergraduate chapter members in the term after the Associate Chapter Ceremony. Fall due date– Sept. 30 Spring due date – Feb. 1
Liability Insurance Assessment	General liability insurance coverage of \$1 million and Loss Prevention resources, staff support, and publications.	The associate chapter is billed \$100 (\$50/semester) for each member of the associate chapter.	After the term in which the organization is recognized and an additional 1 term has expired, the associate chapter will remit the Liability Insurance Assessments at a rate of \$100 per year (\$50/semester). Fall due date– Sept. 30 Spring due date – Feb. 1
Directors & Officers Insurance	Insurance for individuals serving in director and officer roles of the undergraduate chapter, alumni association, and house corporation.	The associate chapter is billed \$700 annually for D&O coverage. Chapters may opt out via form sent to IHQ by Sept. 1.	All associate chapters should consider carrying D&O insurance. It is strongly encouraged when operating a facility.
Chapter Fee	Registration, including meals and lodging for 1 delegate to the summer Leadership Institute, 1 delegate to the Presidents Academy, and 1 delegate to the Recruitment Symposium.	\$2,250 per associate chapter (\$1,125 per semester) after the first two terms, with half of the fee billed in the fall and half in the spring.	During the term in which the associate chapter is recognized, the Chapter Fee is waived. After the term of the Associate Chapter Ceremony, the members of the associate chapter will remit the Chapter Fee at half the rate. Beyond this time period, the associate chapter will remit the Chapter Fee consistent with what is required of an undergraduate chapter. Fall due date– Sept. 30 Spring due date – Feb. 1

Chapter Member Initiation Fee	Membership in Delta Upsilon; membership card, certificate, and badge; and subscription to the <i>Delta Upsilon Quarterly</i> .	\$285 per undergraduate or alumnus initiate, one-time fee.	Upon Initiation.
Chartering Fee*	Chapter charter, administrative processing, and offsets the cost of Fraternity staff to conduct Installation.	\$750 per associate chapter. One-time fee.	Upon Installation. *Newly Installed/Reinstalled chapters must remit to the Fraternity a Chartering Fee at the time of Installation/Reinstallation.

SO, HOW MUCH WILL IT REALLY COST TO BE A MEMBER OF A NEW DELTA UPSILON ASSOCIATE CHAPTER?

Individual associate chapter members are responsible for the following fees detailed above:

- Initial Associate Chapter Member Fee - \$150 (one-time fee due at the time one becomes an associate chapter member).
- Member Fee - \$110 per term (beginning one [1] academic term after recognition, recurring each semester).
- Initiation Fee - \$285 (one-time fee due at time of Initiation).

The associate chapter, as a group, is responsible for the following fees detailed above:

- Insurance Assessment of \$100 per man (beginning two [2] academic terms after recognition, recurring annually).
- Directors & Officers Insurance of \$700 per chapter per year (billed in August and due Sept. 30).
- Chapter Fee (beginning one [1] academic term after recognition: half the fee, then full fee each term thereafter).
- Chartering Fee of \$750 (due at the Installation Ceremony).

In addition to these fees, Delta Upsilon associate chapter members set their own local dues structure to cover costs such as Interfraternity or Greek Council dues, intramural sports fees, social function costs, educational costs, and office supplies needs.

Dues assessed to each member of a Delta Upsilon associate chapter vary from group to group depending on what other money the associate chapter wishes to collect for its own operations. Typically, dues range from \$450-\$600 per member for one semester. Generally, this money is more than enough to cover the fees detailed above and any monetary needs the associate chapter may have locally.
