A. BEREAVEMENT LEAVE

Upon the death of a member of the teacher's immediate family, a teacher requesting a leave will be granted up to five (5) school days to commence on the day after death unless the teacher does not report for work that day. In that case, the day of death shall be counted as the first day. **The window to use the five days can be extended due to extenuating circumstances, at the discretion/approval of the superintendent.** Immediate family is defined as grandparent, grandchild, father, mother, brother, sister, spouse or child and a similar relationship established by marriage, or any other person who is living in the teacher's household, **or a miscarriage.**

Upon the death of a member of the teacher's extended family, a teacher requesting a leave will be granted up to one (1) bereavement day for extended family. Extended family defined as aunt, uncle, niece, nephew, cousin, and a similar relationship established by marriage. A teacher may be granted additional bereavement days at the Superintendent's discretion.

A. COURT LEAVE

Court leave with pay shall be granted to teachers for the time necessary to make an appearance as a subpoenaed witness. Absences due to being subpoenaed for a legal action not against the school corporation, ~~or a school-related matter approved by the Superintendent, will not be factored into the Teacher Effectiveness Rubric.~~ **must be verified with the subpoena. Absences due to subpoena will not be factored into the teacher effectiveness rubric.**

Article VI- Donation of Sick Days outside of the Sick Bank

A teacher may donate up to ten (10) sick days per year to another employee who has used all of their sick days, and/or all of their Sick Bank days. The employee who has received the donation must use the days or the days will be returned to the donor at the end of the school year in which they are donated. The employee receiving the sick days may only get one donation per year unless the superintendent approves more donations. The teacher must complete the donation of sick days form.
