A MESSAGE FROM THE JCPL FOUNDATION PRESIDENT

For the first time in the history of the Library, the JCPL Foundation launched a campaign to fund innovation for the new Clark Pleasant Branch called Enhancing the Story. Concentrating on six special project areas, the JCPL Foundation raised nearly \$200,000 in 2021 to support the services offered in the special project areas of the new construction. JCPL Foundation will help JCPL launch these six special areas: a Robotics Learning Lab, an Early Childhood Learning Area, a Teen Gaming Center, an Adult Learning Center, Public Art projects, and a Nature Trail and Community Garden.

We found unique ways to fundraise - from a bake sale at our Friends of JCPL's book sale, Giving Tuesday, a Read-a-Thon for students, and naming opportunities at the new branch, to partnering with local businesses. In addition to our Enhancing the Story special projects campaign for the new Clark Pleasant Branch, the Foundation and Friends continued to support unique learning experiences that patrons at JCPL appreciate and love. 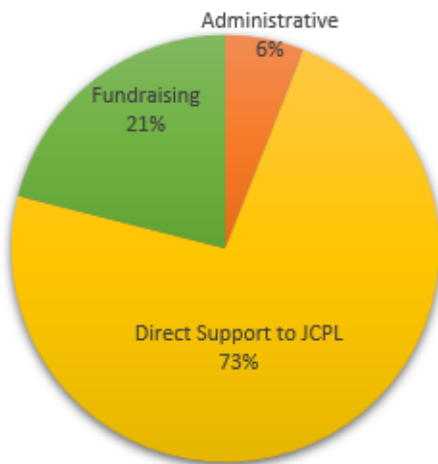
