II. General Duties and Responsibilities

- 1. Lead development of initiative designed to achieve mission of the BY5 Early Childhood Initiative, Inc. and monitor effectiveness of results.
- 2. Provide leadership in developing partnerships with various agencies necessary for BY5 to be successful.
- 3. Provide supervision of staff and volunteers engaged in the BY5.
- 4. Develop and monitor budgetary requirements associated with BY5.
- 5. Participate in the process for fund raising and grant writing that will advance BY5.
- 6. Provide leadership in the development of professional development goals for the staff, volunteers and program leaders.
- 7. Participate in program meetings and individual professional development opportunities that will broaden skills, knowledge, and coordination of services. Attend state, regional, and national opportunities.
- 8. Provide records and reports to meet the requirements of funding sources and to monitor the achievements of that component.
- 9. Develop a close working relationship with BY5 evaluators in order to provide leadership in the evaluation process of the BY5.
- 10. Take leadership in developing reports, presentations and data interpretation for the Board and for the greater public.
- 11. Coordinate and facilitate Board/Committee/Advisory Committee meetings when appropriate and as needed.
- 12. Responsible for overseeing purchasing, distribution, and allocation of resources pertaining to the services provided to children by the various program components.
