Physician Health First

Clif Knight, MD

The subject of burnout is a critical concern to the AAFP because family physicians suffer from significantly higher rates of burnout than physicians in most other specialties. With [AAFP Physician Health First](#), the first-ever comprehensive initiative devoted to improving the well-being and professional satisfaction of family physicians, the AAFP is working at every level to help put physician well-being first, so physicians can stay passionate about their purpose: providing quality patient care.

As part of ongoing efforts to improve family physician well-being, we are pleased to have the AAFP join us in Indianapolis for a Physician Health First presentation. In this presentation, **Clif Knight, MD**, AAFP Senior Vice President for Education and a past president of the IAFP, will explain what the AAFP is doing to battle physician burnout and, in a workshop setting, provide solutions for improved professional satisfaction and better patient care within a broken system.

Speaker Biography:

H. Clifton “Clif” Knight, MD, FAAFP, is senior vice president, education at the AAFP. He oversees all organizational activities related to medical education and continuing medical education. These areas include education and training of medical students and residents; student interest in the specialty of family medicine, including federal policies that affect it; and CME curriculum development, production, and accreditation and regulations.

Knight was a family physician in Indiana for nearly 25 years. He served as chief medical and academic officer for Community Health Network in Indianapolis, where he was responsible for patient safety, medical education, research and medical staff support. Knight was previously in private practice in rural Flora, Indiana. In 2011, he was named to the board of trustees for Marian University in Indianapolis. He served on the Admissions Committee for the Marian University College of Osteopathic Medicine, which admitted its inaugural class in August 2013. Knight served in an appointed position on the Indiana Medical Education Board, which oversees state grant funding for family medicine residency programs in Indiana.

A member of the AAFP since 1984, Knight was elected to the board of directors in 2012, a position he resigned to take on his current role. He has served on numerous commissions and committees. He is a past chair of the Congress of Delegates Reference Committee on Practice Enhancement and the Awards Subcommittee. Knight also served as a delegate or alternate delegate to the AAFP Congress of Delegates for 12 years.

At the state level, Knight has been an active member of the Indiana Academy of Family Physicians since his first year of medical school in 1984. Since that time, he has served in one or more leadership positions each year, including chapter president and board chair. Knight also has chaired the Indiana AAFP’s Commissions on Legislation and Education. In 2004, the Indiana AAFP awarded Knight the A. Alan Fischer Award for his outstanding contributions to family medicine education. He was Indiana AAFP Student of the Year in 1987.

Knight earned his undergraduate degree from Ball State University, Muncie, Ind., and his medical degree from the Indiana University School of Medicine, Indianapolis. He completed his family medicine residency at Community Health Network in Indianapolis, where he also served one year as chief resident. In addition, Knight completed a Faculty Development Fellowship at the University of North Carolina at Chapel Hill School of Medicine. From 1992 to 2007, Knight was a full-time faculty member in the Community Health Network Family Medicine Residency where he most recently served as interim program director.

He is board certified by the American Board of Family Medicine and has the AAFP Degree of Fellow, an earned degree awarded to family physicians for distinguished service and continuing medical education.

Project ECHO
(Extension for Community Healthcare Outcomes)

Joan Duwve, MD

Learn about Project ECHO - a movement to connect local primary care teams with inter-disciplinary specialist teams to spread knowledge and amplify local capacity to provide best practice care for complex chronic health conditions.

Speaker Biography:

Joan M. Duwve, MD, MPH is Associate Dean for Practice and Clinical Associate Professor of Health Policy and Administration at the Indiana University Richard M. Fairbanks School of Public Health, Indianapolis.

Dr. Duwve created the Center for Public Health Practice to support public health practice around the state and provide opportunities to link students to public health practice. In 2018, she was awarded an IU Addictions Grand Challenge grant to develop an ECHO Center at IUPUI. The ECHO Center currently supports training to diagnose and manage hepatitis C and HIV, and on culturally informed care of LGBTQ+ patients. Dr. Duwve is a member of the Addictions Grand Challenge Scientific Advisory Committee and the principal investigator on a Mixed Methods research project in Scott County. She loves working with students and staff on campus community projects, like Drug Take Back events and HPV vaccination initiatives, poverty simulations and campus movie nights.

Dr. Duwve served as a Medical Director, and then the Chief Medical Officer at the Indiana State Department of Health for 10 years. In those roles, she worked to improve adolescent immunization rates, served on the State Child Fatality Review Committee, and co-developed a State Suicide Prevention Committee and a Suicide Prevention Plan. With former Indiana Attorney General, Greg Zoeller, she created and co-chaired a statewide Prescription Drug Abuse Prevention Task Force, which successfully championed legislation for evidence-based opioid prescribing, improved access to treatment for opioid addiction, and expanded access to and use of life-saving naloxone for first responders and lay savers. Dr. Duwve was subsequently appointed to Governor Pence's Task Force on Drug Enforcement, Treatment and Prevention.

Dr. Duwve has held numerous state, regional, and national committees, including an appointment to the CDC National Center for Injury Prevention and Control Board of Scientific Counselors by former HHS Secretary, Sylvia Burwell, in 2015.

She currently serves on a National Academies of Science, Engineering, and Medicine Evaluation Committee, the Infectious Diseases Policy Committee for the Association of State and Territorial Health Officials, and the boards of Covering Kids and Families and the Indiana Public Health Association.

Dr. Duwve received her MPH from the University of Michigan and worked in international public health prior to receiving her MD from the Johns Hopkins School of Medicine. She is Board Certified in Family Medicine and practiced clinical medicine for 14 years before returning to public health. Recently, she began working with CleanSlate treating patients with opioid use disorder.

Emerging Concepts in the Recognition and Management of Systemic Lupus Erythematosus (SLE)

Michelle Petri, MD

Speaker Biography:

Michelle Petri, MD, MPH, is a professor of medicine in the Division of Rheumatology and director of the Lupus Center at the Johns Hopkins University School of Medicine and Johns Hopkins Hospital in Baltimore, Maryland. She earned her medical degree

from Harvard Medical School in Boston, Massachusetts, and completed her internship and residency in internal medicine at Massachusetts General Hospital. Dr. Petri completed a fellowship in allergy, immunology/rheumatology at the University of California, San Francisco. She subsequently earned her master's degree in public health and epidemiology from Johns Hopkins University Bloomberg School of Public Health.

Dr. Petri's research focuses on several aspects of systemic lupus erythematosus (SLE), including atherosclerosis, antiphospholipid syndrome (APS), lupus nephritis, and pregnancy. The Hopkins Lupus Cohort, initiated by Dr. Petri in 1987, is a longitudinal study of the incidence and pathogenesis of thrombotic events and coronary artery disease in SLE. Its serum and plasma bank is a valuable resource for other SLE-related research. The Hopkins Lupus Pregnancy Center, of which Dr. Petri is a co-director, has a database of over 400 pregnant patients, providing information on lupus activity, antiphospholipid tests, and pregnancy outcomes. As part of the Systemic Lupus International Collaborating Clinics, Hopkins participates in studies of atherosclerosis, malignancy, and neuropsychiatric lupus. Dr. Petri has served as study chair or principal investigator for several of these studies on the SLE patient population.

Dr. Petri has authored more than 400 papers and chapters on SLE and APS. She is on the editorial boards of *Arthritis and Rheumatism*, *The Journal of Rheumatology*, and *Journal of Clinical Rheumatology*. She serves as an ad hoc reviewer for *Annals of Internal Medicine*, *The American Journal of Medicine*, *Medicine*, *Lancet*, *JAMA*, *Southern Medical Journal*, and *Fertility and Sterility*. Dr. Petri served on the Medical Advisory Board of the Lupus Foundation of America, is a member of the American College of Rheumatology, and was chair of the Lupus Now Education Program.

John Hammond, JD | Partner, Ice Miller, Indianapolis

John R. Hammond III is co-chair of Ice Miller's Public Affairs Group. As a veteran of Indiana state government, he has helped shape a wide variety of public policy, from tax policy to environmental management, education to tort reform, transportation to insurance and economic development.

John served as a key aide to former Indiana Governor Robert D. Orr during his time as lieutenant governor, as well as serving as a deputy campaign manager for Orr's

gubernatorial run in 1979 and heading up his transition team in 1980. He was senior executive assistant for Legislative Affairs and Education Policy in the Orr administration, serving as chief legislative liaison for six general sessions and three special sessions of the Indiana Legislature during the 1980s. Since leaving state government in 1988, he has led the governmental and public affairs programs for several major Indiana firms.

He is a frequent public affairs panelist and lecturer, and is the co-author of the article "Campaigns and Candidates: Lawyers and Their Obligations," prepared for the Legislative Services Agency for Continuing Legal Education's seminar titled, "The Lawyer-Lobbyist." He also serves as a Republican commentator and analyst on Indiana Week in Review, a state wide public affairs news program of WFYI focusing on Indiana government and politics.

He has served as an advisor to several statewide campaigns. John was awarded his Bachelor of Arts from DePauw University in 1976, and a juris doctorate from the Indiana University School of Law in 1991. He is admitted to practice law in the state of Indiana. John joined Ice Miller in February 2001.

Anne Doran | Director of Public Affairs, Ice Miller, Indianapolis

Anne Doran is a seasoned legislative advocate with a wealth of experience representing corporate, municipal and trade association clients before the Indiana General Assembly and state and local regulatory agencies.

Anne has previously held government positions at the federal, state and local levels. She began her public service career in Washington, D. C., working for the general counsel of the Federal Election Commission and the administrator of the Small Business Administration. Anne joined the staff of the mayor of Fort Wayne, Ind. as deputy staff director responsible for oversight of external affairs for the city, including public information, citizens action service center and the management of local and state legislative matters. She was active with the U. S. Conference.

At the end of the mayor's term in office, Anne joined the Lincoln National Corporation as director of Indiana government relations, representing both the corporation and the domestic life and health trade association, the Association of Indiana Life Insurance Companies, before the Indiana General Assembly and state regulatory agencies. She served as corporate representative to numerous associations, including the Health Insurance Association of America, the American Council of Life Insurance, Indiana Chamber of Commerce, the Indiana Manufacturers' Association and the National Association of Insurance Commissioners. Prior to joining Ice Miller in January 2001, Anne was director of public affairs for the law firm of Johnson Smith, LLP.

A member of a politically active Indiana family, Anne has been extensively involved in state and local politics. She has served as campaign manager or volunteer on dozens of mayoral or city council races throughout the state, and has worked on the campaigns of several current and former congressional members as well as state office holders. She has been a delegate to both state and national conventions and has been a local precinct committeewoman.

She holds a Bachelor of Science in public affairs from Indiana University.

Mary R. Ciccarelli, MD, is the Director of the 3 Wishes: Early Action for Autism project.

Dr. Ciccarelli is a primary care provider at one of the Eskenazi Health Community Health Centers and a Professor of Clinical Medicine and Clinical Pediatrics at Indiana University School of Medicine. She has a long-standing dossier within medical education including training of medical students, residents, fellows and both community and university physician continuing education. She is the founding director of the statewide transition support program, the Center for Youth and Adults with Conditions of Childhood, where a transdisciplinary team provides consults and care coordination to improve the transition of youth with special health care needs from pediatric to adult systems of care.

ABFM Update on Board Certification: What's New, What's True and What's Ahead

Speaker Biography:

Elizabeth G. (Libby) Baxley, MD, is the American Board of Family Medicine (ABFM)'s Senior Vice President, a role she assumed in July 2018. As Senior Vice President, Dr.

Baxley leads all aspects of ABFM activity that relate to the experience of board certified family physicians with ABFM, including residency, the early clinical years, credentials, and communications.

A graduate of Clemson University, Dr. Baxley received a Doctor of Medicine from the University of South Carolina School of Medicine. She completed a family medicine residency at Anderson Family Practice Residency in South Carolina followed by the Faculty Development Fellowship at the University of North Carolina at Chapel Hill. From 2012 - 2018, she was Senior Associate Dean for Academic Affairs and Professor of Family Medicine at the Brody School of Medicine at East Carolina University. In that role, she led a pioneering curriculum redesign with an emphasis on integration of training in health system science competencies: patient safety, quality improvement, population health, and interprofessional education. Brody was one of only 11 medical schools nationally to be selected by the AMA in their Accelerating Change in Medical Education initiative.

Prior to that she spent 18 years at the University of South Carolina School of Medicine, serving as Family Medicine Residency Director, school-wide Director of Faculty Development, and Chair of the Department of Family and Preventive Medicine. Her work has focused heavily on health care delivery system redesign and teaching about patient safety and quality improvement. A faculty advisor for IHI Open School chapters at both USC and Brody SOM, she is also one of the co-founders of the I³Collaborative, which has led residency practice redesign in primary care teaching practices across South Carolina, North Carolina, and Virginia.

Dr. Baxley has an outstanding track record of leadership in Family Medicine, having taught and provided full-scope family medicine throughout the greater part of her 31-year career. In addition to her roles as a prior board member and board chair of the American Academy of Family Physician's (AAFP) Advanced Life Support in Obstetrics (ALSO[®]) and the AAFP's Residency Assistance Program Panel of Consultants, she served on the ABFM Board of Directors from 2013-2018. During her tenure on the board, she served on the certification, credentials, examination, and research and development committees, the latter of which she chaired. She became a member of the executive committee in 2016 after her election as Chair Elect and finished her final year on the board of directors as the Board Chair.

Dr. Baxley has been honored with many distinctions including the American Academy of Family Physicians Exemplary Teaching Award and the James Halford Award for Leadership in Humane Education. In 2017 she was recognized by East Carolina University with a Woman of Distinction Award, and in 2016 and 2018 received the American Medical Women's Association Gender Equity Award from medical students at Brody SOM.
