NOTE: As per Superintendent Rozelle and Board approval the JV position is essentially 60 days of work. Total amount for the JV position is \$1693.80, or \$28.23 per day. Tom Schulte worked 42 of those 60 days, and I feel he should be paid as such. He was already paid \$846.90, which is 30 days of work.
