## ILEARN Online Test Forms and Scripts for Students with Accommodations

Schools are strongly encouraged to review the [ILEARN Spring 2021 Online Test Form Assignments for Students with Accommodations](#) and [ILEARN Scripts to Support Test Administration](#) before the ILEARN test administration window opens on Monday, April 19. These resources are designed to help ensure all Test Administrators (TAs) are aware of the appropriate test forms and/or scripts to be used with students. ## ILEARN Scheduling Option: Test Sessions for Multiple Grade Levels

OSA formalized [guidance](#) to remind schools that the design of the ILEARN 3-8 Test Administrator's Manual (TAM) and the configuration of the Test Delivery System (TDS) allow TAs to administer multiple grade-level tests during a single test session. This approach can be especially helpful when finalizing online test schedules for small groups of students (e.g., virtual learners coming onsite, makeup testing).
