## TAX RELIEF

### Property Tax Deduction for Partially Disabled Veterans

An honorably discharged veteran with a service-connected disability of at least 10% (or the veteran's surviving spouse) is entitled to a \$24,960 property tax deduction each year.

Any veteran or surviving spouse who does not use the entire above amount is entitled to a vehicle excise tax credit.

### Property Tax Deduction for Totally Disabled Veterans or Partially Disabled Veterans Age 62+

An honorably discharged veteran with a total disability or who is at least 62 years old with a disability of at least 10% (or the veteran's surviving spouse) is entitled to a \$14,000 property tax deduction if the assessed value of the property is less than \$240,000.

### Military Service Income Tax Deductions: Active, Reserve, National Guard and Retirement Pay

All income earned from active or reserve military service is exempt from Indiana income tax. If the person and his/her spouse both earned military income, they each may claim the deduction.

Members of the reserve components of the Army, Navy, Air Force, Coast Guard, Marine Corps, the Merchant Marine, or members of the Indiana National Guard may receive an income tax deduction for all military income received. If the person and his/her spouse both earned military income, they each may claim the deduction.

Military retirement benefits are exempt from Indiana income tax.

## HIGHER EDUCATION

### In-State Tuition for Veterans, Spouses and Dependents

All honorably discharged veterans who enroll in an Indiana public college within one year of discharge are eligible for in-state tuition. If they reside in a state that borders Indiana, all honorably discharged veterans who enroll in an Indiana public college within three years of discharge are eligible for in-state tuition. If enrolled within one year of the veteran's honorable discharge, spouses and dependents of veterans are eligible for in-state tuition.

### Free College for Indiana National Guard Members

The National Guard Supplemental Grant ensures all Indiana Air and Army National Guard members receive 100% tuition and fee support while attending higher education.

### Free College for Children and Spouses of Deceased Indiana National Guard members

Children and spouses of a deceased Indiana National Guard member who suffered a service-connected death may receive 100% tuition and fee support.

### Free College for Purple Heart Recipients and their Children

The state pays for 8 semesters (124 credits) of college for honorably discharged Purple Heart recipients from Indiana.

The state pays for 8 semesters (124 credits) of public college for children of honorably discharged Purple Heart recipients from Indiana.

### College Credit for Military Work

State universities are required to award credit to veterans for courses they completed at other higher education institutions during their military service and competency tests they passed during their military service.

## Free Re-enrollment or Refund for Military Deployment

If a college student is called for active duty after having paid their tuition for the semester, they may re-enroll free of charge when they return or receive a full refund for the tuition.

## EMPLOYMENT

### Exemption from Professional Licensing Requirements

Veterans are exempt from professional licensing requirements if they received relevant training as part of their military service.

### Vendor's Licenses

Any wartime veteran who has been honorably discharged is exempt from the city and county fees for licenses to sell goods door-to-door, provide a business service or sell merchandise from various locations.

### Local Government License Fees

Local governments waive business and professional license fees for veterans and their spouses.

### Disabled Veterans' Outreach Program (DVOP)

Department of Workforce Development (DWD) program that specializes in tailored training and job placement opportunities for veterans with service-connected disabilities

### Local Veterans' Employment Representative (LVER) Program

DWD program that coordinates services provided to veterans, including counseling, testing and identifying training and employment opportunities

### Veterans' Employment and Training Program Preference

Veterans and their spouses receive priority placement in any federal or state employment or training program administered by DWD.

## Private Employment Preference Policies

Allows private employers to establish an employment preference policy for hiring, promoting or retaining veterans

### State Employee Hiring

Provides for the addition of points for veterans applying for merit positions or promotions within state government

### State Contracting Goal

The state has established a goal of making 3% of its contracts with Indiana veteran-owned businesses.

## OTHER BENEFITS

### Golden Hoosier Passport

This provides unlimited admission to all Indiana state-owned parks, recreation areas, reservoirs and forests. Disabled veterans can receive the passport at a discount, and former prisoners of war can receive the passport for free.

### Resident Veteran Hunting & Fishing License

Indiana residents with a service-connected disability can purchase an Indiana license to hunt and fish for a very reduced fee.

### Disabled Hoosier Veteran License Plates and Parking Placards

Disabled Hoosier veterans are eligible for special license plates and parking placards that exempt them from being charged or fined in metered parking spots.

### Hyperbaric Treatment Pilot Program

Running through 2025, Indiana offers a hyperbaric oxygen treatment pilot program for qualifying veterans suffering from a traumatic brain injury or Post-Traumatic Stress Disorder.

### Veteran's Service Organization Charity Gaming License

The Indiana Gaming Commission may issue special three-year charity gaming licenses to veterans' service organizations. These permits can be used for charity games such as raffles and bingo that raise money for veterans' organizations.
