



Privacy Policy

Alpha Xi Delta Fraternity understands that security and privacy are important issues for users of our web site ("Site") and for our members in connection with their membership records. Alpha Xi Delta recognizes our obligations to keep your information secure and confidential. That is why we maintain the following standards to help protect information that personally identifies you, excluding any publicly available information. We may modify this Privacy Policy ("Policy") at any time, and, accordingly, we urge you to frequently review the Policy. By using the Site and providing us with your personally identifiable information, you consent to our use of such information as described in this Policy.

What information do we collect?

You may be asked to provide your name, address, phone number, email address, member number or other personally identifiable information ("Personal Information") to allow you to make use of portions of the Site. You may always refuse to provide your Personal Information, and this may lead to your inability to use some or all of the Site. We may also collect your domain type, browser version, service provider, operating system, IP address and areas of the Site visited for the purpose of improving this Site. We may distribute cookies and a method of capturing identifiable information.

We will also collect information from membership profiles and communications with the Chapter or National Fraternity.

How is your information used?

Alpha Xi Delta uses Personal Information only for the limited purposes of: administering your account; improving the Site and related services provided to you; administering the Site; allowing you to make a posting on the Site; notifying you of our or our business affiliate's products, promotional events or special offers, newsletters or announcements that may be of interest to you; providing Internet security; and meeting legal requirements. We may work with business partners who may perform functions on our behalf, such as fulfilling orders, providing promotional materials, sending email, managing data, processing credit card payments or providing customer service. They have access to your Personal Information only to the extent necessary to perform their functions and shall not be authorized by Alpha Xi Delta to use it for any other purpose.

Alpha Xi Delta may share your information between Alpha Xi Delta related entities, such as the chapter, National Fraternity, National Housing Corporation, local Alpha Xi Delta house corporations, and the Alpha Xi Delta Foundation. Additionally, at times, Alpha Xi Delta members request contact information of other Alpha Xi Delta Sisters for various reasons. This information will be provided only if used for Alpha Xi Delta





purposes such as college chapter events, reunions, alumnae association membership or event invitations. Such lists will only include members in good standing with the Fraternity.

Links

The Site may contain links to other sites on the Internet that are owned and operated by third parties. Alpha Xi Delta is not responsible for the collection, use, security or privacy protection of your information at any third party site. As such, members are encouraged to read the privacy policies of those third party websites.

Security

We have policies and procedures in place to protect the privacy and confidentiality of your Personal Information that we collect and maintain. All Personal Information is stored on our secured servers, behind a firewall at a data center with access to data strictly controlled. Any unauthorized use of the Site may result in criminal and/or civil prosecution. Alpha Xi Delta will regularly assess its security standards and procedures.

A note to parents: Alpha Xi Delta values the involvement of the friends and family of Alpha Xi Delta members. However, on matters of membership status, discipline, financial issues and housing contract information, we may only provide details to the collegiate member in order to maintain the member's right to privacy. Our discipline processes are confidential and require direct contact with the Alpha Xi Delta member. Sometimes our members choose not to share all information with their parents and we respect their choice and their privacy.
