The Union County College Corner Joint School District Board of Trustees met in special session on Thursday, September 12, 2019 at Union County High School, Room A-400, 410 Patriot Blvd., Liberty, IN. Those in attendance were Mary Eversole, Susan Kirkpatrick, Grace Atkins, Jessica Ewing-Jones, Josh Garwood, Ben Caskey, and Mike Sims.

1. Call Meeting to Order

Mrs. Eversole called the special session to order at 7:00 P.M.

Mr. Borowiak explained that according to PSI the roofing project should be completed by the end of October or early November.

Mr. Garwood and Mr. Caskey shared information from a safety conference they attended where the Superintendent from Jay County Schools spoke about

keeping their schools safe. He stated that they have armed staff members who have completed extensive training.

Mr. Garwood asked about the sign on 27 to help slow passengers down. Mr. Borowiak explained that the town council has been in contact with the State Department and they would look further into the matter. Nothing has been done as of yet.
