Message From the Executive Director

Healwell's 10th year began on a high note with plans for an anniversary celebration and a strategic vision that had us on track to log our most financially successful year in the organization's history. Then, March and the news of COVID came and our momentum was interrupted in ways we never could have imagined.

Nevertheless, we persisted.

The immediate impact of halting all of Healwell's service programs forced us to lay off our team of 12 massage therapists in early spring. We shunted our resources to a small core of leaders who would support our shift from direct, hands-on care to the ability to sustain our work through education offerings, non-service collaborations and virtual community building.

It was a bumpy year and we learned invaluable lessons that brought us closer together. Well-timed PPP funding allowed us to redirect our efforts, focus on education, build new partnerships, and end the year in a healthy financial position. We are deeply grateful for our therapist family, the unwavering support of our donors and our Board of Directors for their calm and pragmatic guidance.

As 2020 came to a close, we had hired back a majority of our therapists and resumed hands-on work with most of our clinical partners. We had also built a robust online, collaborative and interdisciplinary education platform, a new podcast, an email list that tripled in size and earned the love and support of thousands of massage therapists and other clinicians from around the world who had never heard of Healwell before COVID.

Healwell emerged from 2020 smaller on paper, but so much larger in impact. It was easily our most challenging year, but we strengthened and galvanized our mission to transform healthcare in new and truly visionary ways.

I look forward to the adventures that lie ahead in 2021. I know that, with your continued support, we will meet whatever challenges arise with grace, humility and confidence.








Program Revenue and Operating Expenses






Total Operating Expenses = \$315,001
