### 15. Superintendent's Comments

\*Dr. Rozelle noted in response to a question from a board member at the August 11, 2014 board meeting that the total spent on substitute teachers last school year (2013-2014) was \$57,340.

\*Dr. Rozelle reminded the School Board Policy Committee of the meeting on Wednesday, September 10 at 1:30 pm.

\*Dr. Rozelle stated that he would be scheduling a meeting of the School Board Building and Grounds Committee.

\*Dr. Rozelle noted there would be a collective bargaining negotiations meeting with teacher representatives on Wednesday, September 10 @ 4:00 pm.

\*Dr. Rozelle reported that in 2013 we spent \$\$11,271.75 on for lawn care services provided by Johnson's Lawn Care and that to date in 2014 we have spent \$13,184.50. Dr. Rozelle noted as well that in 2014 we hired a temporary mower and to date have paid that individual \$4,480. Dr. Rozelle went on to say that because they were not primarily responsible for mowing and trimming that the district's maintenance staff had time to attend to a large number of maintenance issues that needed attention and thus he feels that bidding out the mowing had proven to be a cost effective strategy.

\*Dr. Rozelle stated that he was waiting for attorney Mr. Walt Chidester to complete an agreement between the school district and property owners before proceeding with the Patriot Avenue drainage issue fix.

\*Dr. Rozelle reported that the project is continuing and is expected to be finished by the end of October.

\*Dr. Rozelle reported that the ADM count on Friday, September 5 was 1,400 students district –wide and that number was down 12.5 students from the previous February, 2014 count.

\*Dr. Rozelle reminded the board of the ISBA Fall Region Meeting on October 1, 2014.

\*Mike Murray commented on the fall election and introduced incoming school board member Mrs. Nancy Redd.

\*Gena Waltz asked if certified personnel were in instances calling for long-term substitute teachers. Dr. Rozelle and Mr. Sustarsic responded by saying that they are when they are available.

\*Gary Arn commented on the pension fund.

\*Susan Kirkpatrick expressed that she appreciated the reception and the opportunity to meet new hires.
