

Diane Black Servant Leader Award 2019

The Diane Black Servant Leader Award was created because Diane Black exemplifies servant leadership. Diane was a member of the first graduating class of Leadership Johnson County in 1995. She went on to serve the organization as program coordinator for five years. In addition Diane Black has served Johnson County through her involvement in various organizations including: Community Congregational Church, Franklin Community School Board, Johnson County Extension Board, Franklin City Technical Committee, Franklin Chamber Task Force, Johnson County Public Library, Johnson County Community Foundation Scholarship Committee, and the Leadership Johnson County Alumni Association.

Leadership Johnson County and the Johnson County community are much richer because of the legacy that Diane Black has brought and continues to bring to our community. This award is given in honor of Diane Black and her servant leadership.

A Servant Leader—

- ✦ Is willing to work on self first: values, intentions, and purpose
- ✦ Understands that power is granted to one by those one serves
- ✦ Chooses service over self-interest
- ✦ Believes that all people have knowledge and answers from which one can learn
- ✦ Shares power, wealth, knowledge, information, and responsibility
- ✦ Promotes partnerships, ownership, empowerment, and responsibility

The Award—

A monetary award of up to \$500 to be utilized by the recipient toward fulfilling or assisting with the ongoing program or project described in the application.

The selection committee may name multiple recipients, in which case the monetary award would be divided among the award winners.

Individual plaque(s) for the winner(s).

Criteria for Eligibility—

Recipients must be graduates of the Leadership Johnson County Signature Program.
Candidates must display ample evidence of servant leadership.

They must be actively participating in a relevant project or program that benefits Johnson County.

Recipients shall not be eligible to apply again for three years after receiving the award.
